HOUSE BILL NO. 552

- AN ACT TO AMEND SECTION 23-15-227, MISSISSIPPI CODE OF 1972, 2 TO INCREASE THE POLL MANAGERS COMPENSATION TO ONE HUNDRED FIFTY
- DOLLARS; TO INCREASE THE COMPENSATION OF THE POLL MANAGERS WHO
- CARRY AND RETURN THE BALLOTS TO THIRTY DOLLARS; TO MAKE A MINOR, NONSUBSTANTIVE CHANGE; TO AMEND SECTION 23-15-229, MISSISSIPPI

- CODE OF 1972, TO MAKE A MINOR, NONSUBSTANTIVE CHANGE; AND FOR 6 7 RELATED PURPOSES.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 SECTION 1. Section 23-15-227, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 23-15-227. (1) The poll managers shall be each entitled
- to * * * One Hundred Fifty Dollars (\$150.00) for each election; 12
- 13 however, the board of supervisors may, in its discretion, pay the
- 14 poll managers an additional amount not to exceed Fifty Dollars
- (\$50.00) per election. 15
- 16 * * *
- 17 (* * *2) The poll manager who shall carry to the place of
- 18 voting, away from the courthouse, the official ballots, ballot
- boxes, pollbooks and other necessities, shall be allowed * * * 19
- 20 Thirty Dollars (\$30.00) for each voting precinct for so doing.

- 21 The poll manager who acts as returning officer shall be allowed
- 22 * * * Thirty Dollars (\$30.00) for each voting precinct for that
- 23 service. If a person who performs the duties described in this
- 24 subsection uses a privately owned motor vehicle to perform them,
- 25 he or she shall receive for each mile actually and necessarily
- 26 traveled in excess of ten (10) miles, the mileage reimbursement
- 27 rate allowable to federal employees for the use of a privately
- 28 owned vehicle while on official travel.
- 29 (4) The compensation authorized in this section shall be
- 30 allowed by the board of supervisors, and shall be payable out of
- 31 the county treasury; provided, however, that any compensation for
- 32 additional pandemic pay due to a public health emergency may be
- 33 payable from federal funds available for such purpose, or a
- 34 combination of both county and federal funding sources.
- 35 (5) The compensation provided in this section shall
- 36 constitute payment in full for the services rendered by the
- 37 persons named for any election, whether there be one (1) election
- 38 or issue voted upon, or more than one (1) election or issue voted
- 39 upon at the same time.
- 40 (6) The Secretary of State shall promulgate rules and
- 41 regulations as are necessary to ensure the safety of poll
- 42 managers, election commissioners, electors and their families at
- 43 the voting precincts during a COVID-19 public health risk or other
- 44 public health risk declared by the Governor where the appearance

- 45 of such persons may result in exposure to such risk or the
- 46 exposure of other persons to such risk.
- 47 **SECTION 2.** Section 23-15-229, Mississippi Code of 1972, is
- 48 amended as follows:
- 49 23-15-229. The compensation for poll managers and other
- 50 workers in the polling places of a municipality shall be the same
- 51 as the compensation paid by the county for those services;
- 52 provided, however, that the governing authorities of a
- 53 municipality shall not be required to pay any additional
- 54 compensation authorized by the board of supervisors. The
- 55 governing authorities of a municipality may, in their discretion,
- 56 pay clerks and poll managers in the polling places of the
- 57 municipality an additional amount of compensation not to exceed
- 58 Fifty Dollars (\$50.00) per election * * *. Such compensation
- 59 shall be payable out of the county general fund, and may be
- 60 payable from federal funds available for such purpose, or a
- 61 combination of both funding sources.
- 62 **SECTION 3.** This act shall take effect and be in force from
- 63 and after July 1, 2023.
