HOUSE BILL NO. 689

1 AN ACT TO CREATE THE MISSISSIPPI CENTER FOR LEGAL SERVICES 2 CORPORATION FUND; TO AMEND SECTION 99-19-72, MISSISSIPPI CODE OF 3 1972, TO REVISE THE FILING FEE FOR A PETITION TO EXPUNGE AN 4 OFFENSE AND PROVIDE THAT A CERTAIN AMOUNT OF THE FEE SHALL BE 5 DEPOSITED INTO THE FUND; AND FOR RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. There is created in the State Treasury a special
- 8 fund designated as the Mississippi Center for Legal Services
- Corporation Fund. The fund shall be administered by the
- 10 Mississippi Center for Legal Services Corporation and monies in
- the fund shall be distributed to the various legal service centers 11
- 12 throughout the state. The fund shall consist of monies deposited
- into the fund as provided in Section 99-19-72 and monies from any 13
- 14 other source designated for deposit into the fund.
- 15 Mississippi Center for Legal Services Corporation Fund may also
- 16 accept monies from any public or private source for deposit into
- 17 the fund. Money remaining in the fund at the end of the fiscal
- year shall not lapse into the State General Fund, and any interest 18

- 19 earned from the investment of monies in the fund shall be
- 20 deposited to the credit of the fund.
- 21 **SECTION 2.** Section 99-19-72, Mississippi Code of 1972, is
- 22 amended as follows:
- 99-19-72. (1) A filing fee of \star \star One Hundred Fifty-two
- 24 Dollars (\$152.00) is * * * levied on each petition to expunge an
- 25 offense under Section 99-19-71 to be collected by the circuit
- 26 clerk and distributed as follows:
- 27 (a) One Hundred Dollars (\$100.00) to be deposited into
- 28 the Judicial System Operation Fund;
- 29 (b) Forty Dollars (\$40.00) to be deposited into the
- 30 District Attorneys Operation Fund; and
- 31 (c) Ten Dollars (\$10.00) to be retained by the circuit
- 32 clerk collecting the fee for administration purposes * * *; and
- 33 (d) Two Dollars (\$2.00) to be deposited into the
- 34 Mississippi Center for Legal Services Corporation Fund.
- 35 (2) From and after July 1, 2016, the expenses of district
- 36 attorneys shall be defrayed by appropriation from the State
- 37 General Fund and all user charges and fees authorized by
- 38 paragraphs (a) and (b) of subsection (1) of this section shall be
- 39 deposited into the State General Fund as authorized by law and as
- 40 determined by the State Fiscal Officer, and charges and fees
- 41 authorized by paragraph (c) of subsection (1) of this section
- 42 shall be retained by the circuit clerks for expenditures
- 43 authorized by law.

- SECTION 3. This act shall take effect and be in force from
- 45 and after July 1, 2023.
