HOUSE BILL NO. 691 (As Sent to Governor)

1 AN ACT TO DESIGNATE A SEGMENT OF U.S. HIGHWAY 45 LOCATED IN 2 WAYNE COUNTY, MISSISSIPPI, AS THE "ARMY SERGEANT ERIC C. NEWMAN 3 MEMORIAL HIGHWAY"; TO DESIGNATE A SEGMENT OF U.S. HIGHWAY 72, LOCATED IN SLAYDEN, MARSHALL COUNTY, MISSISSIPPI, AS THE "EDDIE 5 DIXON MEMORIAL HIGHWAY"; TO DESIGNATE THE INTERSECTION OF U.S. 6 HIGHWAY 80 AND HIGHWAY 481 LOCATED IN MORTON, SCOTT COUNTY, MISSISSIPPI, AS THE "REVEREND SCOTT MANGUM LIFE SPRINGS MINISTRIES 7 MEMORIAL INTERSECTION"; TO AUTHORIZE A SIGN OR SIGNS TO BE ERECTED 8 9 ON INTERSTATE 20 IN LAKE, SCOTT COUNTY, MISSISSIPPI, TO HONOR COUNTRY MUSIC SINGER RANDY HOUSER; AND FOR RELATED PURPOSES. 10 11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

- 12 **SECTION 1.** (1) The segment of U.S. Highway 45 located in
- 13 Wayne County, Mississippi, beginning at a point one-tenth (1/10)
- of a mile North of the Highway 84 West exit on U.S. Highway 45 and 14
- 15 extending northerly for a distance of approximately three (3)
- miles to a point one-tenth (1/10) of a mile South of the 16
- 17 intersection of U.S. Highway 45 and Pleasant Grove Chapparal Road
- is designated and shall be known as the "Army Sergeant Eric C. 18
- Newman Memorial Highway." 19
- 20 The Mississippi Department of Transportation shall erect
- and maintain appropriate signs along and approaching the segment 21
- 22 of highway described in subsection (1) of this section.

- 23 **SECTION 2.** (1) The segment of U.S. Highway 72, located in
- 24 Slayden, Marshall County, Mississippi, beginning one (1) mile to
- 25 the south of the H.W. Byers High School and extending northerly to
- 26 an ending point approximately one (1) mile north of the H.W. Byers
- 27 High School, for a total distance of approximately two (2) miles,
- 28 is designated and shall be known as the "Eddie Dixon Memorial
- 29 Highway."
- 30 (2) The Mississippi Department of Transportation shall erect
- 31 and maintain appropriate signs along and approaching the segment
- 32 of highway described in subsection (1) of this section.
- 33 **SECTION 3.** (1) The intersection of U.S. Highway 80 and
- 34 Highway 481 in the City of Morton, Scott County, Mississippi, is
- 35 designated and shall be known as the "Reverend Scott Mangum Life
- 36 Springs Ministries Memorial Intersection."
- 37 (2) The Mississippi Department of Transportation shall erect
- 38 and maintain appropriate signs along and approaching the
- 39 intersection described in subsection (1) of this section.
- 40 **SECTION 4.** (1) Within the incorporated city limits of the
- 41 Town of Lake, in Scott County, Mississippi, along the Interstate
- 42 20 East and Interstate 20 West corridor near the Lake exit, Exit
- 43 96, may be erected a sign or signs that reads as follows: "Home
- 44 of Randy Houser, Country Music Singer."
- 45 (2) The sign or signs described in subsection (1) of this
- 46 section are to be erected in accordance with the Mississippi

- 47 Department of Transportation's permitting process and must be paid
- 48 for by the Town of Lake.
- 49 **SECTION 5.** This act shall take effect and be in force from
- 50 and after July 1, 2023.
