 12 SUPREME COURT, COURT OF APPEALS, CHANCERY COURTS AND CIRCUIT  
 13 COURTS, FOR THE PURPOSE OF POSSIBLE AMENDMENT; AND FOR RELATED  
 14 PURPOSES.

15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

16 **SECTION 1.** Section 9-3-1, Mississippi Code of 1972, is  
 17 brought forward as follows:

18 9-3-1. The state shall be divided into three (3) Supreme  
 19 Court districts, as follows, to wit:

20 The counties of Bolivar, Claiborne, Copiah, Hinds, Holmes,  
 21 Humphreys, Issaquena, Jefferson, Kemper, Lauderdale, Leake,  
 22 Madison, Neshoba, Newton, Noxubee, Rankin, Scott, Sharkey,  
 23 Sunflower, Warren, Washington and Yazoo shall constitute the First  
 24 District.



25           The counties of Adams, Amite, Clarke, Covington, Forrest,  
26 Franklin, George, Greene, Hancock, Harrison, Jackson, Jasper,  
27 Jefferson Davis, Jones, Lamar, Lawrence, Lincoln, Marion, Pearl  
28 River, Perry, Pike, Simpson, Smith, Stone, Walthall, Wayne, and  
29 Wilkinson shall constitute the Second District.

30           The counties of Alcorn, Attala, Benton, Calhoun, Carroll,  
31 Chickasaw, Choctaw, Clay, Coahoma, DeSoto, Grenada, Itawamba,  
32 Lafayette, Lee, Leflore, Lowndes, Marshall, Monroe, Montgomery,  
33 Oktibbeha, Panola, Pontotoc, Prentiss, Quitman, Tallahatchie,  
34 Tate, Tippah, Tishomingo, Tunica, Union, Webster, Winston and  
35 Yalobusha, shall constitute the Third District.

36           **SECTION 2.** Section 9-4-5, Mississippi Code of 1972, is  
37 brought forward as follows:

38           9-4-5. (1) The term of office of judges of the Court of  
39 Appeals shall be eight (8) years. An election shall be held on  
40 the first Tuesday after the first Monday in November 1994, to  
41 elect the ten (10) judges of the Court of Appeals, two (2) from  
42 each congressional district; provided, however, judges of the  
43 Court of Appeals who are elected to take office after the first  
44 Monday of January 2002, shall be elected from the Court of Appeals  
45 Districts described in subsection (5) of this section. The judges  
46 of the Court of Appeals shall begin service on the first Monday of  
47 January 1995.

48           (2) (a) In order to provide that the offices of not more  
49 than a majority of the judges of said court shall become vacant at



50 any one (1) time, the terms of office of six (6) of the judges  
51 first to be elected shall expire in less than eight (8) years.  
52 For the purpose of all elections of members of the court, each of  
53 the ten (10) judges of the Court of Appeals shall be considered a  
54 separate office. The two (2) offices in each of the five (5)  
55 districts shall be designated Position Number 1 and Position  
56 Number 2, and in qualifying for office as a candidate for any  
57 office of judge of the Court of Appeals each candidate shall state  
58 the position number of the office to which he aspires and the  
59 election ballots shall so indicate.

60 (i) In Congressional District Number 1, the judge  
61 of the Court of Appeals for Position Number 1 shall be that office  
62 for which the term ends January 1, 1999, and the judge of the  
63 Court of Appeals for Position Number 2 shall be that office for  
64 which the term ends January 1, 2003.

65 (ii) In Congressional District Number 2, the judge  
66 of the Court of Appeals for Position Number 1 shall be that office  
67 for which the term ends on January 1, 2003, and the judge of the  
68 Court of Appeals for Position Number 2 shall be that office for  
69 which the term ends January 1, 2001.

70 (iii) In Congressional District Number 3, the  
71 judge of the Court of Appeals for Position Number 1 shall be that  
72 office for which the term ends on January 1, 2001, and the judge  
73 of the Court of Appeals for Position Number 2 shall be that office  
74 for which the term ends January 1, 1999.



75                   (iv) In Congressional District Number 4, the judge  
76 of the Court of Appeals for Position Number 1 shall be that office  
77 for which the term ends on January 1, 1999, and the judge of the  
78 Court of Appeals for Position Number 2 shall be that office for  
79 which the term ends January 1, 2003.

80                   (v) In Congressional District Number 5, the judge  
81 of the Court of Appeals for Position Number 1 shall be that office  
82 for which the term ends on January 1, 2003, and the judge of the  
83 Court of Appeals for Position Number 2 shall be that office for  
84 which the term ends January 1, 2001.

85                   (b) The laws regulating the general elections shall  
86 apply to and govern the elections of judges of the Court of  
87 Appeals except as otherwise provided in Sections 23-15-974 through  
88 23-15-985.

89                   (c) In the year prior to the expiration of the term of  
90 an incumbent, and likewise each eighth year thereafter, an  
91 election shall be held in the manner provided in this section in  
92 the district from which the incumbent Court of Appeals judge was  
93 elected at which there shall be elected a successor to the  
94 incumbent, whose term of office shall thereafter begin on the  
95 first Monday of January of the year in which the term of the  
96 incumbent he succeeds expires.

97                   (3) No person shall be eligible for the office of judge of  
98 the Court of Appeals who has not attained the age of thirty (30)  
99 years at the time of his election and who has not been a



100 practicing attorney and citizen of the state for five (5) years  
101 immediately preceding such election.

102 (4) Any vacancy on the Court of Appeals shall be filled by  
103 appointment of the Governor for that portion of the unexpired term  
104 prior to the election to fill the remainder of said term according  
105 to provisions of Section 23-15-849, Mississippi Code of 1972.

106 (5) (a) The State of Mississippi is hereby divided into  
107 five (5) Court of Appeals Districts as follows:

108 **FIRST DISTRICT.** The First Court of Appeals District shall be  
109 composed of the following counties and portions of counties:  
110 Alcorn, Benton, Calhoun, Chickasaw, Choctaw, DeSoto, Itawamba,  
111 Lafayette, Lee, Marshall, Monroe, Pontotoc, Prentiss, Tate,  
112 Tippah, Tishomingo, Union, Webster and Yalobusha; in Grenada  
113 County the precincts of Providence, Mt. Nebo, Hardy and Pea Ridge;  
114 in Montgomery County the precincts of North Winona, Lodi, Stewart,  
115 Nations and Poplar Creek; in Panola County the precincts of East  
116 Sardis, South Curtis, Tocowa, Pope, Courtland, Cole's Point, North  
117 Springport, South Springport, Eureka, Williamson, East Batesville  
118 4, West Batesville 4, Fern Hill, North Batesville A, East  
119 Batesville 5 and West Batesville 5; and in Tallahatchie County the  
120 precincts of Teasdale, Enid, Springhill, Charleston Beat 1,  
121 Charleston Beat 2, Charleston Beat 3, Paynes, Leverette, Cascilla,  
122 Murphreesboro and Rosebloom.

123 **SECOND DISTRICT.** The Second Court of Appeals District shall  
124 be composed of the following counties and portions of counties:



125 Bolivar, Carroll, Claiborne, Coahoma, Holmes, Humphreys,  
126 Issaquena, Jefferson, Leflore, Quitman, Sharkey, Sunflower,  
127 Tunica, Warren, Washington and Yazoo; in Attala County the  
128 precincts of Northeast, Hesterville, Possomneck, North Central,  
129 McAdams, Newport, Sallis and Southwest; that portion of Grenada  
130 County not included in the First Court of Appeals District; in  
131 Hinds County Precincts 11, 12, 13, 22, 23, 27, 28, 29, 30, 40, 41,  
132 83, 84 and 85, and the precincts of Bolton, Brownsville, Cayuga,  
133 Chapel Hill, Cynthia, Edwards, Learned, Pine Haven, Pocahontas,  
134 St. Thomas, Tinnin, Utica 1 and Utica 2; in Leake County the  
135 precincts of Conway, West Carthage, Wiggins, Thomastown and  
136 Ofahoma; in Madison County the precincts of Farmhaven, Canton  
137 Precinct 2, Canton Precinct 3, Cameron Street, Canton Precinct 6,  
138 Bear Creek, Gluckstadt, Smith School, Magnolia Heights, Flora,  
139 Virililia, Canton Precinct 5, Cameron, Couparle, Camden, Sharon,  
140 Canton Precinct 1 and Canton Precinct 4; that portion of  
141 Montgomery County not included in the First Court of Appeals  
142 District; that portion of Panola County not included in the First  
143 Court of Appeals District; and that portion of Tallahatchie County  
144 not included in the First Court of Appeals District.

145       **THIRD DISTRICT.** The Third Court of Appeals District shall be  
146 composed of the following counties and portions of counties:  
147 Clarke, Clay, Jasper, Kemper, Lauderdale, Lowndes, Neshoba,  
148 Newton, Noxubee, Oktibbeha, Rankin, Scott, Smith and Winston; that  
149 portion of Attala County not included in the Second Court of



150 Appeals District; in Jones County the precincts of Northwest High  
151 School, Shady Grove, Sharon, Erata, Glade, Myrick School,  
152 Northeast High School, Rustin, Sandersville Civic Center, Tuckers,  
153 Antioch and Landrum; that portion of Leake County not included in  
154 the Second Court of Appeals District; that portion of Madison  
155 County not included in the Second Court of Appeals District; and  
156 in Wayne County the precincts of Big Rock, Yellow Creek, Hiwannee,  
157 Diamond, Chaparral, Matherville, Coit and Eucutta.

158       **FOURTH DISTRICT.** The Fourth Court of Appeals District shall  
159 be composed of the following counties and portions of counties:  
160 Adams, Amite, Copiah, Covington, Franklin, Jefferson Davis,  
161 Lawrence, Lincoln, Marion, Pike, Simpson, Walthall and Wilkinson;  
162 that portion of Hinds County not included in the Second Court of  
163 Appeals District; and that portion of Jones county not included in  
164 the Third Court of Appeals District.

165       **FIFTH DISTRICT.** The Fifth Court of Appeals District shall be  
166 composed of the following counties and portions of counties:  
167 Forrest, George, Greene, Hancock, Harrison, Jackson, Lamar, Pearl  
168 River, Perry and Stone; and that portion of Wayne County not  
169 included in the Third Court of Appeals District.

170               (b) The boundaries of the Court of Appeals Districts  
171 described in paragraph (a) of this subsection shall be the  
172 boundaries of the counties and precincts listed in paragraph (a)  
173 of this subsection as such boundaries existed on October 1, 1990.



174           **SECTION 3.** Section 9-5-5, Mississippi Code of 1972, is  
175 brought forward as follows:

176           9-5-5. The First Chancery Court District is composed of the  
177 following counties:

- 178           (a) Alcorn County;
- 179           (b) Itawamba County;
- 180           (c) Lee County;
- 181           (d) Monroe County;
- 182           (e) Pontotoc County;
- 183           (f) Prentiss County;
- 184           (g) Tishomingo County; and
- 185           (h) Union County.

186           **SECTION 4.** Section 9-5-7, Mississippi Code of 1972, is  
187 brought forward as follows:

188           9-5-7. (1) There shall be four (4) chancellors for the  
189 First Chancery Court District.

190           (2) The four (4) chancellorships shall be separate and  
191 distinct and denominated for purposes of appointment and election  
192 only as "Place One," "Place Two," "Place Three" and "Place Four."  
193 The chancellor to fill Place One must be a resident of Alcorn,  
194 Prentiss or Tishomingo County. The chancellors to fill Place Two  
195 and Place Three must reside in Itawamba, Lee, Monroe, Pontotoc or  
196 Union County. The chancellor to fill Place Four may be a resident  
197 of any county in the district. Election of the four (4) offices





198 of chancellor shall be by election to be held in every county  
199 within the First Chancery Court District.

200 **SECTION 5.** Section 9-5-9, Mississippi Code of 1972, is  
201 brought forward as follows:

202 9-5-9. The Second Chancery Court District is composed of the  
203 following counties:

- 204 (a) Jasper County;
- 205 (b) Newton County; and
- 206 (c) Scott County.

207 **SECTION 6.** Section 9-5-11, Mississippi Code of 1972, is  
208 brought forward as follows:

209 9-5-11. (1) The Third Chancery Court District is composed  
210 of the following counties:

- 211 (a) DeSoto County;
- 212 (b) Grenada County;
- 213 (c) Montgomery County;
- 214 (d) Panola County;
- 215 (e) Tate County; and
- 216 (f) Yalobusha County.

217 (2) The Third Chancery Court District shall be divided into  
218 two (2) subdistricts as follows:

- 219 (a) Subdistrict 3-1 shall consist of DeSoto County.
- 220 (b) Subdistrict 3-2 shall consist of Grenada County,  
221 Montgomery County, Panola County, Tate County and Yalobusha  
222 County.



223           **SECTION 7.** Section 9-5-13, Mississippi Code of 1972, is  
224 brought forward as follows:

225           **[Until January 1, 2027, this section shall read as follows:]**

226           9-5-13. (1) There shall be three (3) chancellors for the  
227 Third Chancery Court District.

228           (2) (a) The chancellor of Subdistrict 3-1 shall be elected  
229 from DeSoto County. The two (2) chancellors of Subdistrict 3-2  
230 shall be elected from Grenada County, Montgomery County, Panola  
231 County, Tate County and Yalobusha County.

232           (b) For purposes of appointment and election, the three  
233 (3) chancellorships shall be separate and distinct. The  
234 chancellorship in Subdistrict 3-1 shall be denominated only as  
235 "Place One," and the chancellorships in Subdistrict 3-2 shall be  
236 denominated only as "Place Two" and "Place Three."

237           **[From and after January 1, 2027, this section shall read as**  
238 **follows:]**

239           9-5-13. (1) There shall be four (4) chancellors for the  
240 Third Chancery Court District.

241           (2) (a) The two (2) chancellors of Subdistrict 3-1 shall be  
242 elected from DeSoto County. The two (2) chancellors of  
243 Subdistrict 3-2 shall be elected from Grenada County, Montgomery  
244 County, Panola County, Tate County and Yalobusha County.

245           (b) For purposes of appointment and election, the four  
246 (4) chancellorships shall be separate and distinct and denominated  
247 as "Place One," "Place Two," "Place Three" and "Place Four". The



248 chancellorships in Subdistrict 3-1 shall be denominated only as  
249 "Place One" and "Place Four" and the chancellorships in  
250 Subdistrict 3-2 shall be denominated only as "Place Two" and  
251 "Place Three."

252       **SECTION 8.** Section 9-5-15, Mississippi Code of 1972, is  
253 brought forward as follows:

254       9-5-15. (1) The Fourth Chancery Court District is composed  
255 of the following counties:

- 256           (a) Amite County;
- 257           (b) Franklin County;
- 258           (c) Pike County; and
- 259           (d) Walthall County.

260       (2) There shall be two (2) chancellors for the Fourth  
261 Chancery Court District. The two (2) chancellorships shall be  
262 separate and distinct and denominated for purposes of appointment  
263 and election only as "Place One" and "Place Two."

264       **SECTION 9.** Section 9-5-17, Mississippi Code of 1972, is  
265 brought forward as follows:

266       9-5-17. (1) The Fifth Chancery Court District is composed  
267 of Hinds County.

268       (2) The Fifth Chancery Court District shall be divided into  
269 the following four (4) subdistricts:

- 270           (a) Subdistrict 5-1 shall consist of the following  
271 precincts in Hinds County: 1, 2, 4, 5, 6, 8, 9, 10, 32, 33, 34,



272 35, 36, 44, 45, 46, 47, 72, 73, 74, 75, 76, 77, 78, 79, 92, 93, 96  
273 and 97.

274 (b) Subdistrict 5-2 shall consist of the following  
275 precincts in Hinds County: 11, 12, 13, 14, 15, 16, 17, 23, 27,  
276 28, 29, 30, 37, 38, 39, 40, 41, 42, 43, 80, 81, 82, 83, 84, 85,  
277 Brownsville, Cynthia, Pocahontas and Tinnin.

278 (c) Subdistrict 5-3 shall consist of the following  
279 precincts in Hinds County: 18, 19, 20, 21, 22, 24, 25, 26, 31,  
280 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 66,  
281 67, 68, 69, 70, 71, 86, 89 and Jackson State.

282 (d) Subdistrict 5-4 shall consist of the following  
283 precincts in Hinds County: 87, 88, 90, 91, 94, 95, Bolton, Byram  
284 1, Byram 2, Cayuga, Chapel Hill, Clinton 1, Clinton 2, Clinton 3,  
285 Clinton 4, Clinton 5, Clinton 6, Dry Grove, Edwards, Learned, Old  
286 Byram, Pinehaven, Raymond 1, Raymond 2, Spring Ridge, St. Thomas,  
287 Terry, Utica 1 and Utica 2.

288 **SECTION 10.** Section 9-5-19, Mississippi Code of 1972, is  
289 brought forward as follows:

290 9-5-19. (1) There shall be four (4) chancellors for the  
291 Fifth Chancery Court District. One (1) chancellor shall be  
292 elected from each subdistrict.

293 (2) While there shall be no limitation whatsoever upon the  
294 powers and duties of the said chancellors other than as cast upon  
295 them by the Constitution and laws of this state, the court in the  
296 First Judicial District of Hinds County, in the discretion of the



297 senior chancellor, may be divided into four (4) divisions as a  
298 matter of convenience by the entry of an order upon the minutes of  
299 the court.

300 **SECTION 11.** Section 9-5-21, Mississippi Code of 1972, is  
301 brought forward as follows:

302 9-5-21. The Sixth Chancery Court District is composed of the  
303 following counties:

- 304 (a) Attala County;
- 305 (b) Carroll County;
- 306 (c) Choctaw County;
- 307 (d) Kemper County;
- 308 (e) Neshoba County; and
- 309 (f) Winston County.

310 **SECTION 12.** Section 9-5-22, Mississippi Code of 1972, is  
311 brought forward as follows:

312 9-5-22. (1) There shall be two (2) chancellors for the  
313 Sixth Chancery Court District.

314 (2) The two (2) chancellorships shall be separate and  
315 distinct and denominated for purposes of appointment and election  
316 only as "Place One" and "Place Two."

317 **SECTION 13.** Section 9-5-23, Mississippi Code of 1972, is  
318 brought forward as follows:

319 9-5-23. (1) The Seventh Chancery Court District is composed  
320 of the following counties:

- 321 (a) Bolivar County;



- 322 (b) Coahoma County;
- 323 (c) Leflore County;
- 324 (d) Quitman County;
- 325 (e) Tallahatchie County; and
- 326 (f) Tunica County.

327 (2) The Seventh Chancery Court District shall be divided  
328 into two (2) subdistricts as follows:

329 (a) Subdistrict 7-1 shall consist of Bolivar County and  
330 Coahoma County;

331 (b) Subdistrict 7-2 shall consist of Leflore County,  
332 Quitman County, Tallahatchie County and Tunica County.

333 **SECTION 14.** Section 9-5-25, Mississippi Code of 1972, is  
334 brought forward as follows:

335 9-5-25. There shall be three (3) chancellors for the Seventh  
336 Chancery Court District. The three (3) chancellorships shall be  
337 separate and distinct. One (1) chancellor shall be elected from  
338 Subdistrict 7-1 and shall be denominated for purposes of  
339 appointment and election only as "Place One," and two (2)  
340 chancellors shall be elected from Subdistrict 7-2 and shall be  
341 denominated for purposes of appointment and election only as  
342 "Place Two" and "Place Three."

343 **SECTION 15.** Section 9-5-27, Mississippi Code of 1972, is  
344 brought forward as follows:

345 9-5-27. The Eighth Chancery Court District is composed of  
346 the following counties:



- 347 (a) Hancock County;  
348 (b) Harrison County; and  
349 (c) Stone County.

350 **SECTION 16.** Section 9-5-29, Mississippi Code of 1972, is  
351 brought forward as follows:

352 9-5-29. (1) There shall be four (4) chancellors for the  
353 Eighth Chancery Court District.

354 (2) The four (4) chancellorships shall be separate and  
355 distinct and denominated for purposes of appointment and election  
356 only as "Place One," "Place Two," "Place Three" and "Place Four."

357 (3) While there shall be no limitation whatsoever upon the  
358 powers and duties of the chancellors other than as cast upon them  
359 by the Constitution and laws of this state, the court in the  
360 Eighth Chancery Court District, in the discretion of the senior  
361 chancellor, may be divided into four (4) divisions as a matter of  
362 convenience by the entry of an order upon the minutes of the  
363 court.

364 **SECTION 17.** Section 9-5-31, Mississippi Code of 1972, is  
365 brought forward as follows:

366 9-5-31. (1) The Ninth Chancery Court District is composed  
367 of the following counties:

- 368 (a) Humphreys County;  
369 (b) Issaquena County;  
370 (c) Sharkey County;  
371 (d) Sunflower County;



372 (e) Warren County; and

373 (f) Washington County.

374 (2) The Ninth Chancery Court District shall be divided into  
375 three (3) subdistricts as follows:

376 (a) Subdistrict 9-1 shall consist of the following  
377 precincts in the following counties:

378 (i) Sunflower County: Boyer-Linn, Drew,  
379 Fairview-Hale, Indianola 2 East\*, Indianola 3 North\*, Indianola 3  
380 Northeast\*, Indianola 3 South\*, Rome, Ruleville, Ruleville North  
381 and Sunflower Plantation; and

382 (ii) Washington County: American Legion, Brent  
383 Center, Buster Brown Community Center, Darlove Baptist Church\*,  
384 Elks Club, Extension Building, Grace Methodist Church\*, Greenville  
385 Industrial College, Leland Health Department Clinic, Leland Rotary  
386 Club, Metcalf City Hall and Potter House Church.

387 (b) Subdistrict 9-2 shall consist of Humphreys County  
388 and the following precincts in the following counties:

389 (i) Sunflower County: Doddsville, Indianola 2  
390 East\*, Indianola 2 West, Indianola 3 North\*, Indianola 3  
391 Northeast\*, Indianola 3 South\*, Indianola Southeast, Inverness,  
392 Moorhead, Sunflower 3 and Sunflower 4; and

393 (ii) Washington County: Arcola City Hall, Christ  
394 Wesleyan Methodist Church, Darlove Baptist Church\*, Glen Allan  
395 Health Clinic, Grace Methodist Church\*, Hollandale City Hall, St.





396 James Episcopal Church, Swiftwater Baptist Church, Tampa Drive and  
397 Ward's Recreation Center.

398 (c) Subdistrict 9-3 shall consist of Issaquena County,  
399 Sharkey County and Warren County.

400 **SECTION 18.** Section 9-5-33, Mississippi Code of 1972, is  
401 brought forward as follows:

402 9-5-33. There shall be three (3) chancellors for the Ninth  
403 Chancery Court District. One (1) chancellor shall be elected from  
404 each subdistrict.

405 **SECTION 19.** Section 9-5-35, Mississippi Code of 1972, is  
406 brought forward as follows:

407 9-5-35. The Tenth Chancery Court District is composed of the  
408 following counties:

- 409 (a) Forrest County;

1094 district with the consent of the chancellor thereof when in their  
1095 opinion the public interest may be thereby promoted. The terms of  
1096 all chancellors elected at the regular election for the year 1930  
1097 shall begin on the first day of January, 1931, and their terms of  
1098 office shall continue for four (4) years. A chancellor shall be a  
1099 resident of the district in which he serves but shall not be  
1100 required to be a resident of a subdistrict if the district is  
1101 divided into subdistricts.

1102 **SECTION 76.** Section 9-7-1, Mississippi Code of 1972, is  
1103 brought forward as follows:

1104 9-7-1. A circuit judge shall be elected for and from each  
1105 circuit court district and the listing of individual precincts  
1106 shall be those precincts as they existed on October 1, 1990. He  
1107 may hold court in any other district with the consent of the judge  
1108 thereof, when in their opinion the public interest may require.  
1109 The terms of all circuit judges hereafter elected shall begin on



1110 the first day of January, 1931, and their terms of office shall  
1111 continue for four (4) years. A circuit judge shall be a resident  
1112 of the district in which he or she serves but shall not be  
1113 required to be a resident of a subdistrict if the district is  
1114 divided into subdistricts.

1115           **SECTION 77.** This act shall take effect and be in force from  
1116 and after July 1, 2023, and shall stand repealed on June 30, 2023.
