## HOUSE BILL NO. 771

- AN ACT TO AMEND SECTION 37-106-75, MISSISSIPPI CODE OF 1972, TO REVISE PROVISIONS OF THE HIGHER EDUCATION LEGISLATIVE PLAN (HELP) GRANT TO PRESCRIBE AWARD MINIMUMS BASED ON CLASSIFICATION AND ENROLLMENT STATUS; TO AMEND SECTION 37-106-29, MISSISSIPPI 5 CODE OF 1972, TO REVISE PROVISIONS OF THE MISSISSIPPI RESIDENT 6 TUITION ASSISTANCE GRANT PROGRAM FOR THE PURPOSE OF STRENGTHENING 7 MISSISSIPPI'S WORKFORCE PIPELINE; TO PROVIDE MORE MISSISSIPPIANS ACCESS TO AFFORDABLE EDUCATION PATHWAYS FOR IN-DEMAND CAREERS; TO 8 9 RENAME THE PROGRAM AS THE "MTAG WORKS GRANT PROGRAM"; TO ESTABLISH 10 ELIGIBILITY CRITERIA FOR RECIPIENTS TO QUALIFY FOR GRANT AWARDS; 11 TO PROVIDE FOR BONUSES FOR STUDENTS ENROLLED IN EDUCATION PROGRAMS 12 THAT LEAD TO EMPLOYMENT IN HIGH-NEED OR HIGH-DEMAND FIELD; AND FOR 13 RELATED PURPOSES.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 15 **SECTION 1.** Section 37-106-75, Mississippi Code of 1972, is
- 16 amended as follows:
- 17 37-106-75. (1) The Legislature hereby establishes the
- 18 Higher Education Legislative Plan Grant Program.
- 19 (2) For purposes of this section:
- 20 (a) "Institution of higher education" shall mean any
- 21 state institution of higher learning or public community or junior
- 22 college, or any regionally accredited, state-approved, nonprofit

- 23 two-year or four-year college or university located in the State
- 24 of Mississippi approved by the board.
- 25 (b) "Tuition" shall mean the semester or trimester or
- 26 term charges and all required fees imposed by an institution of
- 27 higher education as a condition of enrollment by all
- 28 students. \* \* \*
- 29 (3) \* \* \* The state \* \* \* shall make awards to students who
- 30 enroll at any approved state institution of higher education to
- 31 pursue an academic undergraduate degree who apply for the
- 32 assistance under the program and who meet all of the following
- 33 qualifications:
- 34 (a) Resident of the State of Mississippi. Resident
- 35 status for the purpose of receiving assistance under this chapter
- 36 shall be determined in the same manner as resident status for
- 37 tuition purposes in Sections 37-103-1 through 37-103-29, with the
- 38 exception of Section 37-103-17;
- 39 (b) Graduate from high school within the two (2) years
- 40 preceding the application with a minimum cumulative grade point
- 41 average of 2.5 calculated on a 4.0 scale;
- 42 \* \* \*
- 43 (\* \* \*c) Have a composite score on the American
- 44 College Test of at least twenty (20) on the 1989 version or an
- 45 equivalent concordant value on an enhanced version of such test;
- 46 ( \* \* \*d) Have no criminal record, except for
- 47 misdemeanor traffic violations; and

49	(4) * * * The state * * * shall make awards to students who
50	enroll at any approved state institution of higher education to
51	pursue an academic undergraduate degree or associate degree who
52	apply for assistance under the program and who meet the
53	qualifications <u>established</u> in * * * subsection (3) * * *. <u>The</u>
54	award may be applied to tuition, rooms, meals, books, materials
55	and fees, and any other education-related expenses as long as the
56	student's total award package does not exceed the student's cost
57	of attendance as determined by the institution.
58	(5) Award amounts for junior and senior students attending
59	public four-year universities in the State of Mississippi shall be
60	equal to tuition and required fees. Award amounts for junior and
61	senior students attending four-year regionally accredited,
62	state-approved, nonprofit colleges and universities in the State
63	of Mississippi shall be equal to the average tuition and required
64	fees charged by the state's public four-year universities. Award
65	amounts for freshmen and sophomore students attending public

- 102 ( \* \* \*8) An applicant shall be found to be in financial
- 103 need if:
- 104 (a) The family has one (1) child under the age of
- 105 twenty-one (21), and the annual adjusted gross income of the
- 106 family is less than Forty-two Thousand Five Hundred Dollars
- 107 (\$42,500.00); or
- 108 (b) The family has an annual adjusted gross income of
- 109 less than Forty-two Thousand Five Hundred Dollars (\$42,500.00)
- 110 plus Five Thousand Dollars (\$5,000.00) for each additional child
- 111 under the age of twenty-one (21).
- The annual adjusted gross income of the family shall be
- 113 verified by completion of the Free Application for Federal Student
- 114 Aid (FAFSA) and the completion of the verification process if the
- 115 applicant is selected for it.
- 116 As used in this subsection, the term "family" for an
- 117 unemancipated applicant means the applicant, the applicant's
- 118 parents and other children under age twenty-one (21) of the
- 119 applicant's parents. The term "family" for an emancipated
- 120 applicant means the applicant, an applicant's spouse, and any
- 121 children under age twenty-one (21) of the applicant and spouse.

123	section in an amount greater than the tuition charged by the
124	school. The student must apply for a federal grant prior to
125	receiving state funds.

- SECTION 2. Section 37-106-29, Mississippi Code of 1972, is amended as follows:
- 37-106-29. (1) 128 There is established the Mississippi 129 Resident Tuition Assistance Grant Program, which shall be called 130 "MTAG Works" to signify the state's commitment to strengthening 131 Mississippi's workforce pipeline by providing expanded access to 132 postsecondary education for working adults and part-time students 133 in addition to students matriculating from high school. The grant shall be for college or university freshmen, sophomores, juniors 134 135 and seniors to be administered by the Mississippi Postsecondary 136 Education Financial Assistance Board established under Section 137 37-106-9, Mississippi Code of 1972, which shall set the dates and 138 deadlines for applying for an award under this section. The board shall establish such rules and regulations as it deems necessary 139 140 and proper to carry out the purposes and intent of this section.
- 141 (2) The board shall approve grants to full-time freshmen, 142 sophomore, junior and senior Mississippi residents who meet the 143 general requirements for student eligibility as provided in 144 subsection (4) of this section.
- 145 (3) \* \* \* MTAG Works grants shall be for Mississippi 146 resident students from any Mississippi family whose prior year

- 161 colleges in Mississippi, or regionally accredited, state-approved,

- 163 Award amounts for part-time students will be reduced as determined
- 164 by the board.
- 165 (4) The general requirements for initial eligibility of
- 166 students for \* \* \* MTAG Works Grants consist of the following:
- 167 (a) Member of a Mississippi family whose prior year
- 168 adjusted gross income (AGI) exceeds \* \* \* one hundred percent
- 169 (100%) of the state's median family income as determined by the
- 170 Free Application for Federal Student Aid.

- 171 (b) Acceptance for enrollment at any state institution
- 172 of higher learning or public community or junior college located
- in Mississippi, or any regionally accredited, state-approved,
- 174 nonprofit two-year or four-year college or university located in
- 175 Mississippi and approved by the board.

- 177 ( \* \* \*c) Any student currently enrolled in any
- 178 qualified institution shall have to only meet the same
- 179 requirements as students who are applying for a renewal award.
- 180 \* \* \*
- 181 ( \* \* \*5) Eligibility for renewal of \* \* \* MTAG Works grants
- 182 shall be evaluated at the end of \* \* \* each academic year. As a
- 183 condition for renewal, a student shall:
- 184 (a) Make steady academic progress toward a certificate
- 185 or degree, as outlined in the school Satisfactory Academic
- 186 Progress Standards and certified by the institution's registrar.
- 187 \* \* \*
- 188 (\* \* \*b) Have a cumulative grade point average of at
- 189 least 2.50 calculated on a 4.0 scale at the end of each \* \*  $\star$
- 190 academic year.
- 191 ( \* \* \*6) Each student, each year, must complete \* \* \* the
- 192 Free Application for Federal Student Aid \* \* \* to determine his or
- 193 her eligibility for a \* \* \* MTAG Works grant.
- 194 (  $\star$   $\star$   $\star$ 7) (a) The amount of the  $\star$   $\star$  MTAG Works grant

195 awarded to any one (1) full-time student shall be determined by

196	the board, but shall not be less than the * * * amount provided in
L97	subsection (3) of this section * * *. The amount of the MTAG
L98	Works grant awarded to any one (1) student enrolled less than
L99	full-time shall be a reduced amount determined by the board.
200	(b) A bonus shall be paid to any MTAG Works recipient
201	who is enrolled as a full-time student in an education program
202	that leads to employment in a high-need or high-demand field as
203	determined by the Mississippi Office of Workforce Development
204	(Accelerate Mississippi). A reduced bonus amount determined by
205	the board shall be paid to any MTAG Works recipient who is
206	enrolled less than full-time in an approved education program that
207	led to employment in a high-need or high-demand field.
208	( * * * $\underline{c}$ ) Payment of the * * * MTAG Works grant shall
209	be made payable to the recipient and the educational institution
210	and * * * delivered directly to the institution * * *.
211	(8) (a) By accepting a MTAG Works grant, the student is
212	attesting that the information provided demonstrates that the
213	student's eligibility is accurate, complete and correct.
214	Falsification of such information shall result in the denial of
215	any pending grant and revocation of any award currently held to
216	the extent that no further payments shall be made by the board on
217	the student's behalf. Any student knowingly making false
218	statements in order to receive a grant shall be guilty of a
219	misdemeanor and, upon conviction thereof, shall be punishable by a
220	fine not to exceed Ten Thousand Dollars (\$10,000.00), or

221	imprisonment	up	to	one	(1)	year	in	the	county	jail,	or	by	both

- 222 such fine and imprisonment.
- 223 (b) In addition to any such fine or imprisonment which
- 224 may be imposed, the court shall order that restitution be made to
- 225 the board. The measure for restitution in money shall be the
- 226 current replacement value of the actual monetary benefit received
- 227 under the MTAG Works Grant Program plus any interest accrued
- thereon.
- 229 (9) In order for an institution to remain eligible for its
- 230 students to participate in the \* \* \*  $\underline{\text{MTAG Works}}$  Grant Program, the
- 231 institution shall comply with the following requirements:
- 232 (a) A complete and accurate roster of the eligibility
- 233 status of each awarded student shall be made to the board for each
- 234 term, semester or quarter of the academic year the student
- 235 receives a \* \* \* MTAG Works grant.
- 236 (b) The institution is required to make refunds to
- 237 the \* \* \* MTAG Works Grant Fund for any funds for which the
- 238 student is ineligible according to the rules established by the
- 239 board \* \* \*.
- 240 (c) \* \* \* The award for an eligible student \* \* \*
- 241 enrolled for less than full-time status, as defined by the board,
- 242 will be prorated based on the student's level of enrollment \* \* \*.
- 243 (d) The board may conduct its own annual audits of any
- 244 institution participating in the \* \* \* MTAG Works Grant Program.
- 245 The board may suspend or revoke an institution's eligibility to

246	receive future monies under the program if it finds that the
247	institution has not complied with the provisions of this section.
248	In determining a student's initial eligibility, the number of
249	prior semesters enrolled will not be counted against the student.
250	(10) No student may receive a * * * MTAG Works grant for
251	more than the equivalent semesters or quarters required to
252	complete one (1) baccalaureate degree or one (1) certificate or
253	associate degree program per institution.
254	(11) No student receiving * * * $\frac{1}{2}$ another state grant for
255	undergraduate education shall be eligible to receive the * * *
256	MTAG Works Grant pursuant to this section * * *.
257	For purposes of this section, certificated shall mean, but
258	not be limited to, all postsecondary vocational programs in

SECTION 3. The board shall determine the annual award and 260 261 bonus amounts. It is the intention of the Legislature that award 262 amounts for full-time junior and senior students equal 263 approximately twenty percent (20%) to twenty-five percent (25%) of 264 the average tuition of the state's public four-year universities 265 and bonus amounts equal approximately twenty-five percent (25%) of 266 the full-time award. Award amounts for full-time freshmen and 267 sophomore students shall be half of the amount determined by the 268 board to be awarded for juniors and seniors. If funds are 269 insufficient to make full awards to all eligible students, the

270	board shall first withhold or restrict bonuses. The board shall
271	then prorate awards among all eligible students.
272	<b>SECTION 4.</b> Initial awards under the MTAG Works Grant Program
273	shall be made first available during the 2024-2025 academic year.
274	<b>SECTION 5.</b> Any student who previously received a Mississippi
275	Resident Tuition Assistance Grant, but does not qualify for a MTAG
276	Works Grant, shall continue to receive the Mississippi Resident
277	Tuition Assistance Grant through the 2026-2027 academic year
278	according to the rules and regulations established by the board.
279	SECTION 6. This act shall take effect and be in force from
