HOUSE BILL NO. 917

1 AN ACT TO AMEND SECTION 29-5-2, MISSISSIPPI CODE OF 1972, TO 2 PLACE THE MISSISSIPPI WORKERS' COMPENSATION COMMISSION OFFICE BUILDING UNDER THE SUPERVISION AND CARE OF THE DEPARTMENT OF 3 4 FINANCE AND ADMINISTRATION; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. Section 29-5-2, Mississippi Code of 1972, is 6 7 amended as follows: 8 29-5-2. The duties of the Department of Finance and Administration shall be as follows: 9 10 (a) (i) To exercise general supervision and care over and keep in good condition the following state property located in 11 12 the City of Jackson: the New State Capitol Building, the Woolfolk 13 State Office Building and Parking Garage, the Carroll Gartin 14 Justice Building, the Walter Sillers Office Building and Parking Garage, the War Veterans' Memorial Building, the Charlotte Capers 15 Building, the William F. Winter Archives and History Building, the 16 17 Mississippi Museum Complex, the Gulf, Mobile and Ohio Train Depot (GM&O Depot), the Old State Capitol Building, the Governor's 18 Mansion, the Heber Ladner Building, the Robert E. 20 Building, the Robert E. Lee Parking Garage, the former Naval 21 Reserve Center, 515 East Amite Street, 620 North Street, 660 North 22 Street, 700 North State Street, 350 High Street, 401 North Lamar Street, 455 North Lamar Street, the State Records Center, the 23 24 Robert G. Clark, Jr. Building, the Mississippi State Fairgrounds 25 Complex, the former Central High Building, the Mississippi Workers' Compensation Commission Office Building, as well as all 26 27 state-owned or leased buildings situated on seat of government 28 property.

(ii) To exercise general supervision and care over
and keep in good condition the Dr. Eldon Langston Bolton Building
located in Biloxi, Mississippi.

32 (iii) To exercise general supervision and care
33 over and keep in good condition the State Service Center, located
34 at the intersection of U.S. Highway 49 and John Merl Tatum
35 Industrial Drive in Hattiesburg, Mississippi.

36 (iv) To exercise general supervision and care over 37 and keep in good condition any property purchased, constructed or 38 otherwise acquired by the State of Mississippi for conducting 39 state business and not specifically under the supervision and care 40 by any other state entity, but which is reasonably assumed the 41 department would be responsible for such, as approved by the 42 Public Procurement Review Board, including, but not limited to:

51 To assign suitable office space for the various (b) 52 state departments, officers and employees who are provided with an 53 office in any of the buildings under the jurisdiction or control 54 of the Department of Finance and Administration. However, the 55 assignment of space in the New Capitol Building shall be 56 designated by duly passed resolution of the combined Senate Rules 57 Committee and the House Management Committee, meeting as a joint 58 committee, approved by the Lieutenant Governor and Speaker of the 59 House of Representatives. A majority vote of the members of the Senate Rules Committee and a majority vote of the members of the 60 61 House Management Committee shall be required on all actions taken, 62 resolutions or reports adopted, and all other matters considered 63 by the full combined committee on occasions when the Senate Rules 64 Committee and the House Management Committee shall meet as a full combined committee. 65

66 (c) To approve or disapprove with the concurrence of67 the Public Procurement Review Board, any lease or rental

68 agreements by any state agency or department, including any state 69 agency financed entirely by federal and special funds, for space 70 outside the buildings under the jurisdiction of the Department of 71 Finance and Administration, including space necessary for parking 72 to be used by state employees who work in the Woolfolk Building, 73 the Carroll Gartin Justice Building or the Walter Sillers Office 74 Building. In no event shall any employee, officer, department, 75 federally funded agency or bureau of the state be authorized to 76 enter into a lease or rental agreement without prior approval of 77 the Department of Finance and Administration and the Public 78 Procurement Review Board.

The Department of Finance and Administration is authorized to use architects, engineers, building inspectors and other personnel for the purpose of making inspections as may be deemed necessary in carrying out its duties and maintaining the facilities.

This section is not intended to apply to locations for which the Department of Finance and Administration has decided to solicit proposals in accordance with subsection (e) of this section.

(d) To acquire by lease, lease-purchase agreement, or
otherwise, as provided in Section 27-104-107, and to assign
through the Office of General Services, by lease or sublease
agreement from the office, and with the concurrence of the Public
Procurement Review Board, to any state agency or department,

94 To solicit and approve or disapprove, (e) notwithstanding any rule of law to the contrary, and with the 95 96 concurrence of the Public Procurement Review Board, any lease, use 97 or rental agreement for a charge or other consideration for space not exceeding three thousand (3,000) square feet in any individual 98 building listed in subsection (a) of this section, with a private 99 100 entry who will provide food and/or catering services for state 101 employees, visitors and the general public.

102 The department shall select the entity using a competitive 103 process which shall be publicly advertised. In addition to 104 satisfying any other requirements for the Public Procurement 105 Review Board's approval, the department must demonstrate that any 106 agreement entered into under this section will neither result in a 107 net cost to the state, nor impair or impede the function of state 108 agencies at such location.

109 SECTION 2. This act shall take effect and be in force from 110 and after July 1, 2023.
