1 2 3 4 5 6	AN ACT TO AMEND SECTIONS 37-101-1, 37-101-91, 37-101-141, 37-101-147, 37-101-181, 37-121-3 AND 37-121-5, MISSISSIPPI CODE OF 1972, TO UPDATE REFERENCES TO ALCORN STATE UNIVERSITY AND CERTAIN OTHER STATE INSTITUTIONS OF HIGHER LEARNING IN THE MISSISSIPPI CODE TO REFLECT CURRENT NAME DESIGNATION; AND FOR RELATED PURPOSES.
7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
8	SECTION 1. Section 37-101-1, Mississippi Code of 1972, is
9	amended as follows:
10	37-101-1. The following state institutions of higher
11	learning shall be under the management and control of a board of
12	trustees to be known as the Board of Trustees of State
13	Institutions of Higher Learning, namely:
14	(a) The University of Mississippi;
15	(b) * * * Mississippi State University of Agriculture
16	and Applied Science;
17	(c) * * * Mississippi * * * University for Women;
18	(d) The University of Southern Mississippi;
19	(e) * * * Delta State * * * <u>University</u> ;

                     Section 37-101-91, Mississippi Code of 1972, is

    amended as follows:
         37-101-91. The Board of Trustees of State Institutions of

    Higher Learning is hereby authorized and empowered to contract

    with and borrow money from the United States of America, or any

    department, instrumentality, or agency thereof, as may be

    designated or created to make loans and grants, or from private

    lenders, at an overall rate of interest to maturity not to exceed
    that allowed in Section 75-17-103, for the purpose of acquiring

- 47 In agreements or commitments by or between the aforesaid
- 48 board of trustees and private lenders and/or the U.S. Department
- 49 of Housing and Urban Development to make loans or grants for the
- 50 construction of dormitories in which bonds are to be issued under
- 51 the provisions of Sections 37-101-91 through 37-101-103, and in
- 52 which part or all of the principal and/or interest on said bonds
- is to be paid or guaranteed by the U.S. Department of Housing and
- 54 Urban Development, said bonds shall bear a net interest rate not
- in excess of that allowed in Section 75-17-103.
- Notwithstanding the foregoing provisions of this section,
- 57 bonds referred to hereinabove may be issued pursuant to the
- 58 supplemental powers and authorizations conferred by the provisions
- of the Registered Bond Act, being Sections 31-21-1 through
- 60 31-21-7.
- 61 **SECTION 3.** Section 37-101-141, Mississippi Code of 1972, is
- 62 amended as follows:

- 63 37-101-141. The Board of Trustees of State Institutions of
- 64 Higher Learning is hereby authorized and empowered, in its
- 65 discretion, to sell and dispose of the timber, trees, dead wood
- 66 and stumps standing, growing and being upon the lands granted to
- 67 the State of Mississippi for the use and benefit of the University
- 68 of Mississippi by an act of Congress of the United States approved
- 69 June 20, 1894, and upon the lands granted to the State of

- 70 Mississippi for the use and benefit of Mississippi * * *
- 71 University for Women by an act of Congress of the United States
- 72 approved March 2, 1895, and upon the lands granted to the State of
- 73 Mississippi for the use and benefit of Mississippi State
- 74 University of Agriculture and Applied Science, and Alcorn * * *
- 75 State University by an act of Congress of the United States
- 76 approved February 20, 1895, whenever the sale or disposition of
- 77 such timber shall be to the best advantage of the institutions
- 78 named herein. Such timber shall be sold and disposed of under the
- 79 direction and specifications of the State Forestry Commission in
- 80 accordance with sound and efficient principles of forestry
- 81 management and conservation.
- 82 **SECTION 4.** Section 37-101-147, Mississippi Code of 1972, is
- 83 amended as follows:
- 37-101-147. All leases and conveyances of timber, trees,
- 85 dead wood and stumps, and all oil, gas and mineral leases, or
- 86 leases for other purposes, provided for in Sections 37-101-141 and
- 87 37-101-143, shall be executed by the President of the Board of
- 88 Trustees of State Institutions of Higher Learning, and attested by
- 89 the Commissioner of Higher Education, respectively, for and on
- 90 behalf of the University of Mississippi, Mississippi * * *
- 91 University for Women, Mississippi State University of Agriculture
- 92 and Applied Science and Alcorn * * * State University, as the case
- 93 may be. The corporate seal of the proper institution shall be
- 94 affixed to all conveyances and leases of the lands held for the

- 95 use and benefit of such institutions. In all such cases such
- 96 conveyances and leases shall be executed only upon the order or
- 97 resolution of the Board of Trustees of State Institutions of
- 98 Higher Learning in the manner and method hereinbefore set forth.
- 99 **SECTION 5.** Section 37-101-181, Mississippi Code of 1972, is
- 100 amended as follows:
- 101 37-101-181. Any member of the faculties of Alcorn \star \star
- 102 State University, Jackson State * * * University, and Mississippi
- 103 Valley State * * * University shall be eligible for leave of
- 104 absence to pursue advanced academic training so as to elevate the
- 105 scholastic qualifications of the faculties of these
- 106 above-mentioned colleges, in line with the requirements of the
- 107 several accrediting agencies.
- In order to provide for the above leaves, the Board of
- 109 Trustees of State Institutions of Higher Learning shall have power
- 110 to adopt rules and regulations regarding such leave. In no
- 111 instance shall leave be granted unless there is a contract
- 112 providing for continued service, after expiration of the leave, in
- 113 the college where the faculty member is employed.
- 114 The Board of Trustees of State Institutions of Higher
- 115 Learning is hereby authorized to make payment of salary, or such
- 116 part of salary as may be decided, of such faculty members who are
- 117 under contract for academic leaves.
- SECTION 6. Section 37-121-3, Mississippi Code of 1972, is
- 119 amended as follows:

120	37-121-3. All the provisions in Chapter 113 of this title,
121	being sections applicable to the Mississippi State University of
122	Agriculture and Applied Science, that can reasonably apply to
123	Alcorn * * * State University, shall apply to the college, except
124	those sections on the subject of apportioning students among the
125	several counties of the state and dormitory privileges for them
126	and those sections on the subject of agricultural experimental
127	stations.
128	SECTION 7. Section 37-121-5, Mississippi Code of 1972, is
129	amended as follows:

- 37-121-5. The Mississippi agricultural and forestry
 experimental station is * * * authorized to establish a branch at
 Alcorn * * * State University, Lorman, Mississippi, for the
 purpose of providing an organization for cooperative effort
 between the two land grant institutions in furthering a unified
 agricultural research program for the State of Mississippi.
- 136 **SECTION 8.** This act shall take effect and be in force from and after its passage.
