- 14 (a) The name of the reciprocal, which name shall not be
- 15 so similar to any name adopted by any insurance organization
- authorized to write the same class of insurance in this state as 16
- 17 to confuse or deceive.
- 18 (b) The address of the reciprocal's principal office.

- 21 (d) The kind or kinds of insurance to be effected or

- (e) A copy of the form of policy contract or agreement

- 36 **SECTION 2.** Section 83-33-23, Mississippi Code of 1972, is

- 38 83-33-23. The board of directors for the reciprocal shall
- 39 have and exercise the ultimate power over the control and
- 40 management of the affairs of the reciprocal, subject to the
- 41 subscriber's agreement. The board of directors shall be selected
- 42 under rules adopted by the subscribers. \star \star The board of
- 43 directors may also be referred to as a subscribers advisory

- 44 committee, board of trustees or by such other name as the board
- 45 chooses.
- 46 **SECTION 3.** This act shall take effect and be in force from
- 47 and after July 1, 2023.
