HOUSE BILL NO. 1266

1 AN ACT TO ESTABLISH A MISSISSIPPI USA SEMIQUINCENTENNIAL
 2 COMMISSION TO DEVELOP PROGRAMS FOR OBSERVING THE 250TH ANNIVERSARY
 3 OF THE UNITED STATES OF AMERICA; TO AUTHORIZE COOPERATION WITH THE
 4 UNITED STATES SEMIQUINCENTENNIAL COMMISSION AND THE AMERICA250
 5 FOUNDATION AND OTHER PUBLIC AND PRIVATE ORGANIZATIONS; TO
 6 DESIGNATE SPECIFIC OBJECTIVES OF THE COMMISSION; TO PROVIDE FOR
 7 THE MEMBERSHIP AND ORGANIZATION OF THE COMMISSION; TO PROVIDE FOR
 8 REIMBURSEMENT OF EXPENSES; TO PROHIBIT SOLICITATION OF FUNDS BY
 9 MEMBERS WHO ARE ELECTED OFFICIALS OR PUBLIC EMPLOYEES; TO PROVIDE
 10 FOR THE APPOINTMENT OF AN EXECUTIVE OFFICER AND SECRETARY TO THE
 11 COMMISSION; TO PROVIDE FOR ADVISORY COMMITTEES; TO ENCOURAGE THE
 12 COOPERATION OF STATE AGENCIES AND POLITICAL SUBDIVISIONS; TO
 13 EMPOWER THE COMMISSION TO ACCEPT AND EXPEND FUNDS FROM PRIVATE AND
 14 PUBLIC SOURCES FOR THIS CELEBRATION; TO CREATE THE MISSISSIPPI
 15 SEMIQUINCENTENNIAL CELEBRATION FUND IN THE STATE TREASURY; TO
 16 REQUIRE AN ANNUAL REPORT OF THE COMMISSION TO THE GOVERNOR AND
 17 LEGISLATURE; AND FOR RELATED PURPOSES.

18 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

19 **SECTION 1.** (1) The Legislature finds that:

20 (a) Public Law 114-196 established the United States
 21 Semiquincentennial Commission and its nonprofit partner, the
 22 America250 Foundation, to collaborate with affiliates at the
 23 local, territorial, state, tribal, regional, national and
 24 international levels to educate, engage and unite Americans
 25 throughout a commemorative period beginning in 2020 to officially



26 conclude in 2027, culminating in the celebration of the 250th
27 Anniversary of the signing of the Declaration of Independence on
28 July 4, 2026, and of the 250th Anniversary of the founding of the
29 United States of America;

30 (b) As of December 1, 2021, eighteen (18) states have
31 established organizations to support the America250 initiative by
32 planning and implementing programs that honor the history and
33 culture of the United States, including special events, public art
34 displays, museum exhibitions and educational curriculums, and the
35 United States Semiquincentennial Commission expects the widest
36 participation to occur through state and local projects and
37 events; and

38 (c) It is altogether appropriate during this
39 commemorative period to participate in a celebration of this
40 magnitude and salute our state heroes, groups, artists,
41 industries, agriculture, historic sites and other contributions to
42 the fabric and history of our nation.

43 (2) There is hereby created a Mississippi USA
44 Semiquincentennial Commission, hereinafter referred to as the
45 "commission," to plan, promote and implement appropriate public
46 celebrations and official events, programs and commemorations.

47 (3) The commission is authorized to cooperate with the
48 United States Semiquincentennial Commission and the America250
49 Foundation and other national and state organizations engaged in
50 commemoration and celebration of the semiquincentennial, and other



51 national, regional, state and local public and private
52 organizations with compatible purposes.

53 (4) The commission shall designate and coordinate events and
54 programs with respect to the formal semiquincentennial celebration
55 and commemoration and promote and encourage through those events,
56 programs, digital and printed media, symposia, and educational
57 outreach all of the following:

58 (a) Awareness and understanding of the principles of
59 the Declaration of Independence, of the winning of American
60 independence in the American Revolutionary War, and of the
61 establishment of America's system of constitutional
62 self-government;

63 (b) Teaching students and increasing public knowledge
64 and appreciation of the breadth of American history and the
65 centuries-long quest for "liberty and justice for all," to include
66 sharing the stories and contributions of the various people who
67 have populated the land, from indigenous peoples, explorers,
68 British colonists, seekers of religious freedom, enslaved African
69 Americans and many others who are part of America's stories;

70 (c) Advancing the cause of liberty and American
71 self-government and of the meaning of "E Pluribus Unum" ("from
72 many, one") through promoting civic knowledge and practice,
73 including America's "Charters of Freedom" (the Declaration of
74 Independence, the Constitution and the Bill of Rights) and the



75 constitutional features of self-government emphasizing the roles
76 of active and engaged good citizens;

77 (d) Emphasizing the service and sacrifices of veterans
78 of all generations who have secured and preserved American
79 independence and freedom and encouraging Mississippians to honor
80 them; and

81 (e) Celebratory and commemorative events and activities
82 throughout the State of Mississippi and its eighty-two (82)
83 counties and its two hundred ninety-nine (299) incorporated
84 municipalities celebrating our state's arts, culture, sports,
85 entertainment, innovation, science, entrepreneurship, parks,
86 preservation and youth.

87 (5) The commission shall be composed of the following
88 members:

89 (a) The Governor's First Lady, or her designee;

90 (b) The Lieutenant Governor, or his designee;

91 (c) The Speaker of the House of Representatives, or his
92 designee;

93 (d) Three (3) members appointed by the Governor to
94 serve terms concurrent with that of the Governor;

95 (e) Two (2) members appointed by the Lieutenant
96 Governor to serve terms concurrent with that of the Lieutenant
97 Governor;



98 (f) One (1) member appointed by the Speaker of the
99 House of Representatives to serve a term concurrent with that of
100 the Speaker;

101 (g) The Director of the Division of Tourism of the
102 Mississippi Development Authority, or his designee;

103 (h) The Executive Director of the Mississippi Tourism
104 Association, or her designee;

105 (i) The Director of the Mississippi Department of
106 Archives and History, or her designee; and

107 (j) The Executive Director of the Mississippi Arts
108 Commission, or his designee.

109 (6) Appointments shall be made within thirty (30) days after
110 the passage of this act by the Legislature, and the First Lady
111 shall serve as chairwoman for a term concurrent with the
112 gubernatorial term. Within fifteen (15) days thereafter, on a day
113 to be designated by the First Lady, the commission shall meet and
114 organize for business by adopting internal organizational
115 procedures necessary for the commission's efficient operation,
116 including officers, committees and subcommittees, quorum
117 requirements, and policies for any commission staff. Each member
118 of the commission shall designate necessary staff of his or her
119 respective agency, department or business entity, as the case may
120 be, to provide administrative support to assist the commission in
121 performing its duties and responsibilities. In the selection of
122 its officers and the adoption of rules, resolutions and reports,



123 an affirmative vote of a majority of the commission shall be
124 required. All members shall be notified in writing of all
125 meetings, such notices to be transmitted as appropriate at least
126 five (5) days before the date on which a meeting is to be held.
127 The commission shall meet and conduct business at least quarterly
128 each year. Commission meetings shall be open to the public, and
129 opportunity for public comment shall be made available.

130 (7) Commission members shall receive no compensation for
131 their services. No commission member may incur per diem, travel
132 or other expenses unless previously authorized by vote at a
133 meeting of the commission, which action shall be recorded in the
134 official minutes of the meeting. Legislative members of the
135 commission shall be paid from the contingent expense funds of
136 their respective houses in the same manner as provided for
137 committee meetings when the Legislature is not in session;
138 however, no per diem or expense for attending meetings of the
139 commission will be paid while the Legislature is in session.
140 Nonlegislative members shall be paid from any funds made available
141 for that purpose to the commission or their respective agencies,
142 departments or business entities.

143 (8) No elected public official or public employee serving on
144 the commission shall be involved in soliciting any private funds
145 or gifts for the commission.

146 (9) The First Lady, with concurrence of the commission, may
147 designate the chief executive officer of an agency or nonprofit



148 organization created or chartered by legislative act, or another
149 qualified individual, to serve as the executive officer and
150 secretary of the commission. The executive officer shall serve
151 without additional compensation but may be reimbursed for expenses
152 as provided for state employees. He or she shall exercise such
153 powers delegated by the commission, including the right to apply
154 for, receive, accept, deposit and administer pursuant to
155 commission authorization any federal, state or local public or
156 private funds given for express use by the commission for
157 semiquincentennial purposes.

158 (10) The First Lady, with the concurrence of the commission,
159 shall constitute one or more advisory committees to advise the
160 commission. The committees may include such representatives as
161 the respective executive officer, or his or her designee, of the
162 Mississippi Department of Education, the Mississippi Institutions
163 of Higher Learning, the Mississippi Community College Board, the
164 Mississippi Military Department or the Mississippi Veterans
165 Affairs Board, or representatives of presidents of Mississippi's
166 public colleges and universities, historically black colleges and
167 universities, community colleges, associations and organizations
168 of city or county officials, or state historical, educational,
169 patriotic, civic, religious, military, veterans, community
170 improvement and other organizations.

171 (11) To effectuate the purposes of this section, any
172 department, division, board, bureau, commission or agency of the



173 state or of any political subdivision thereof shall, at the
174 request of the chair of the commission or her designee, provide to
175 the commission such facilities, assistance and data as will enable
176 the committee properly to carry out its task. All departments,
177 boards, agencies, officers and institutions of the state and of
178 all subdivisions thereof shall cooperate with the commission in
179 carrying out its purposes under this section. The commission
180 shall encourage various state agencies and organizations to work
181 cooperatively to promote the semiquincentennial.

182 (12) The commission is authorized and empowered to accept
183 and expend grants and private donations from any source, including
184 federal, state, public and private entities, and may create a
185 supporting nonprofit organization, supervised and controlled by
186 the commission through majority board control and representation,
187 to accept and expend on behalf of the commission such grants and
188 private donations, to encourage the broadest volunteer
189 participation of public and private partners and organizations,
190 and to assist the commission to carry out its functions. Any
191 expenditures by the commission shall be authorized by a majority
192 vote of the nonlegislative members of the commission.

193 (13) There is hereby created in the State Treasury the
194 Mississippi Semiquincentennial Celebration Fund. Any
195 appropriations, funds or donations received by the commission
196 shall be deposited into this special fund. The fund shall be
197 maintained by the State Treasurer as a special fund, separate and



198 apart from the State General Fund. Unexpended amounts remaining
199 in this special fund at the end of a fiscal year shall not lapse
200 into the State General Fund, and any interest earned or investment
201 earnings on amounts in the fund shall be deposited to the credit
202 of the special fund. Monies in the fund shall be expended by the
203 Department of Finance and Administration after receipt of
204 requisitions submitted by the appropriate person designated by the
205 commission. Monies in the special fund may be used by the
206 commission in carrying out its responsibilities under this
207 section.

208 (14) The commission shall make an annual written report and
209 make any recommendations to the Governor and Legislature at least
210 thirty (30) days prior to the convening of each Regular Session of
211 the Legislature, beginning in 2024 and continuing through its
212 final report in 2027. The commission shall consider and recommend
213 ways for the state to commemorate the semiquincentennial through
214 state and local legacy projects for the state at large and for
215 counties and municipalities, as well as ways to enhance
216 educational programs and extended learning offered by local boards
217 of education, the Department of Education, relevant state agencies
218 and departments, and two-year and four-year institutions of higher
219 education, including historically black colleges and universities.

220 (15) This section shall stand repealed on June 30, 2027.

221 **SECTION 2.** This act shall take effect and be in force from
222 and after July 1, 2023.
