HOUSE BILL NO. 1322

1 AN ACT TO AMEND SECTION 37-13-134, MISSISSIPPI CODE OF 1972, 2 TO REQUIRE PUBLIC SCHOOL STUDENTS TO RECEIVE TWENTY HOURS PER 3 SCHOOL YEAR OF HEALTHY LIVING INSTRUCTION AND TO REQUIRE THE HEALTH EDUCATION CURRICULUM IN THE PUBLIC SCHOOLS TO PROMOTE THE 5 MAKING OF HEALTHY CHOICES IN NUTRITION, EXERCISE AND BEHAVIOR; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 8 SECTION 1. Section 37-13-134, Mississippi Code of 1972, is amended as follows: 9 10 37-13-134. (1) The Legislature recognizes that there is a problem with Mississippi student inactivity and obesity, and 11 therefore, requires school districts to adhere to the following 12 13 guidelines for school district physical education, health education and physical activity and fitness classes: 14 (a) Kindergarten through Grade 8: One hundred fifty 15 (150) minutes per week of physical activity-based instruction and 16 forty-five (45) minutes per week of health education and healthy 17

living instruction, as defined by the State Board of Education.

- 22 instruction. Beginning with the 2015-2016 Ninth Grade class, an
- 23 instructional component on the proper administration of
- 24 cardiopulmonary resuscitation (CPR) and the use of an automated
- 25 external defibrillator (AED) shall be included as part of the
- 26 physical education or health education curriculum. The curricula
- 27 shall incorporate into the instruction the psychomotor skills
- 28 necessary to perform cardiopulmonary resuscitation and use of an
- 29 automated external defibrillator as follows:
- 30 (i) An instructional program developed by the
- 31 American Heart Association or the American Red Cross;
- 32 (ii) An instructional program which is nationally
- 33 recognized and is based on the most current national
- 34 evidence-based Emergency Cardiovascular Care guidelines for
- 35 cardiopulmonary resuscitation and the use of an automated external
- 36 defibrillator:
- 37 (iii) A licensed teacher shall not be required to
- 38 be a certified trainer of cardiopulmonary resuscitation * * * to
- 39 facilitate, provide or oversee such instruction for
- 40 noncertification; and
- 41 (iv) Courses which result in a certification being
- 42 earned must be taught by an authorized CPR/AED instructor.
- For purposes of this paragraph (b), the term "psychomotor
- 44 skills" means the use of hands-on practicing to support cognitive

- 45 learning. Cognitive-only training does not qualify as
- 46 "psychomotor skills."
- The requirements of this paragraph (b) shall be minimum
- 48 requirements. Any local school district shall be authorized to
- 49 offer CPR and AED instruction for longer periods of time than
- 50 required herein, and may enhance the curriculum and training
- 51 components.
- 52 (c) The State Department of Education shall establish a
- 53 procedure for monitoring adherence by school boards to the
- 54 requirements set forth in this section.
- All instruction in physical education, health education and
- 56 physical activity must be age and grade appropriate and based on
- 57 the most current state standards provided by the State Department
- 58 of Education. The health education curriculum must promote the
- 59 making of healthy choices in nutrition, exercise and behavior.
- 60 (2) * * * Each local school board shall, consistent with
- 61 regulations adopted by the State Board of Education, adopt a
- 62 school wellness plan which shall promote a healthy lifestyle for
- 63 Mississippi's school children and staff. * * * The school
- 64 wellness plan shall also promote increased physical activity,
- 65 healthy eating habits and abstinence from the use of tobacco and
- 66 illegal drugs through programs that incorporate healthy lifestyle
- 67 choices into core subject areas which may be developed in
- 68 partnership with the Institute for America's Health.

- 69 (3) Beginning with the 2012-2013 school year, the State
- 70 Board of Education, in consultation with the State Department of
- 71 Health, shall have the authority to establish a school health
- 72 pilot program to improve student health so that all students can
- 73 fully participate and be successful in school. The school health
- 74 pilot program shall be implemented in local school districts, as
- 75 provided in Section 37-13-134.1.
- 76 (4) The Legislature shall appropriate sufficient
- 77 state-source funds for the State Department of Education to employ
- 78 a physical activity coordinator to assist districts on current and
- 79 effective practices and on implementation of physical education
- 80 and physical activity programs.
- 81 (5) The physical activity coordinator employed under Section
- 82 37-13-133 must have the qualifications prescribed in any of the
- 83 following paragraphs, which are listed in the order of preference:
- 84 (a) A doctorate in physical education, exercise science
- 85 or a highly related field, and at least three (3) years of
- 86 experience in teaching physical education in Grades K-12 or in
- 87 physical activity promotion/fitness leadership; or
- 88 (b) A master's degree in physical education, exercise
- 89 science or a highly related field, and at least five (5) years of
- 90 experience in teaching physical education in Grades K-12 or in
- 91 physical activity promotion/fitness leadership; or
- 92 (c) A bachelor's degree in physical education, a
- 93 teacher's license, and at least seven (7) years of experience in

- 94 teaching physical education in Grades K-12 or in physical activity 95 promotion/fitness leadership.
- 96 (6) The Governor's Commission on Physical Fitness and Sports
- 97 created under Section 7-1-551 et seq., the Mississippi Council on
- 98 Obesity Prevention and Management created under Section 41-101-1
- 99 et seq., the Task Force on Heart Disease and Stroke Prevention
- 100 created under Section 41-103-1 et seq., the Mississippi Alliance
- 101 for Health, Physical Education, Recreation and Dance, and the
- 102 Mississippi Alliance for School Health shall provide
- 103 recommendations to the State Department of Education regarding the
- 104 employment of the physical activity coordinator. The department
- 105 shall consider the recommendations of those entities in employing
- 106 the physical activity coordinator.
- 107 (7) The physical activity coordinator shall present a state
- 108 physical activity plan each year to the Governor's Commission on
- 109 Physical Fitness and Sports, the Mississippi Council on Obesity
- 110 Prevention and Management, the Task Force on Heart Disease and
- 111 Stroke Prevention, the Mississippi Alliance for Health, Physical
- 112 Education, Recreation and Dance, and the Mississippi Alliance for
- 113 School Health.
- 114 (8) The physical activity coordinator shall monitor the
- 115 districts for adherence to current Mississippi school
- 116 accountability standards and for implementation of the physical
- 117 education curriculum on file with the State Department of
- 118 Education. The State Department of Education shall monitor and

- 122 (9) (a) The local school board of each school district
- 123 shall establish a local school health council for each school
- 124 which shall ensure that local community values are reflected in

- 128 (b) The local school health council's duties shall
- 129 include, but not be limited to, the following:
- 130 (i) Recommend age-appropriate curriculum and the

- 133 hours shall not be less than that required by this section;
- 134 (ii) Recommend appropriate practices that include
- 135 a coordinated approach to school health designed to prevent
- 136 obesity, cardiovascular disease, Type II diabetes and other health
- 137 risks, through coordination of:
- 138 1. Health education;
- 139 2. Physical education;
- 140 3. Nutritional services;
- 4. Parental/Community involvement;
- 142 5. Instruction to prevent the use of tobacco,

150	(iii) Provide guidance on the development and
151	implementation of the local school wellness plan.
152	(c) The local school board shall appoint members to the
153	local school health council. At a minimum, the school board shall
154	appoint one (1) person from each of the following groups:
155	(i) Parents who are not employed by the school
156	district;
157	(ii) The director of local school food services;
158	(iii) Public schoolteachers;
159	(iv) Public school administrators;
160	<pre>(v) District students;</pre>
161	(vi) Health care professionals;
162	(vii) The business community;
163	(viii) Law enforcement;
164	(ix) Senior citizens;
165	(x) The clergy;
166	(xi) Nonprofit health organizations; and
167	(xii) Faith-based organizations.

168	(10) Nothing in this section shall be construed to prohibit
169	or limit the sale or distribution of any food or beverage item
170	through fund-raisers conducted by students, teachers, school
171	groups, or parent groups when the items are intended for sale off
172	the school campus.

173 **SECTION 2.** This act shall take effect and be in force from 174 and after July 1, 2023.
