HOUSE BILL NO. 1604

1 AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE 2 PURPOSE OF DEFRAYING THE EXPENSES OF THE STATE BOARD OF 3 REGISTRATION FOR PROFESSIONAL ENGINEERS AND LAND SURVEYORS FOR 4 FISCAL YEAR 2024. 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 SECTION 1. The following sum, or so much thereof as may be 7 necessary, is hereby appropriated out of any money in the State 8 Treasury to the credit of the State Board of Registration for 9 Professional Engineers and Land Surveyors, for the purpose of 10 defraying the expenses of the board for the fiscal year beginning July 1, 2023, and ending June 30, 2024.....\$ 556,525.00. 11 12 SECTION 2. Of the funds approved for expenditure under the provisions of Section 1, the following positions are authorized: 13 14 AUTHORIZED HEADCOUNT: 5 15 Permanent: Time-Limited: 16 0 17 With the funds herein appropriated, it shall be the agency's responsibility to make certain that funds required for Personal 18 Services for Fiscal Year 2025 do not exceed Fiscal Year 2024 funds 19 H. 20 appropriated for that purpose unless programs or positions are 21 added to the agency's Fiscal Year 2024 budget by the Mississippi 22 Legislature. The Legislature shall determine the agency's personal services appropriation, which shall be published by the 23 24 State Personnel Board. Additionally, the State Personnel Board 25 shall determine and publish the projected annualized payroll costs 26 based on current employees. It shall be the responsibility of the 27 agency head to ensure that actual personnel expenditures for 28 Fiscal Year 2024 do not exceed the data provided by the 29 Legislative Budget Office. If the agency's Fiscal Year 2024 30 projected cost exceeds the annualized costs, no salary actions 31 shall be processed by the State Personnel Board with the exception 32 of new hires that are determined to be essential for the agency.

33 Any transfers or escalations shall be made in accordance with 34 the terms, conditions and procedures established by law or 35 allowable under the terms set forth within this act. The State 36 Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. 37 The 38 Department of Finance and Administration shall not provide written 39 approval to escalate any funds for salaries and/or positions 40 without proof of availability of new or additional funds above the appropriated level. 41

42 No general funds authorized to be expended herein shall be 43 used to replace federal funds and/or other special funds which are

None of the funds herein appropriated shall be used in violation of Internal Revenue Service's Publication 15-A relating to the reporting of income paid to contract employees, as interpreted by the Office of the State Auditor.

Funds have been appropriated herein for the purpose of funding Project SEC2 minimum salaries for all employees covered under the Colonel Guy Groff/Neville Kenning Variable Compensation Plan. It shall be the agency's responsibility to ensure that the funds are used to increase all employees' salaries up to the minimum level as determined by the State Personnel Board.

SECTION 3. It is the intention of the Legislature that the 56 57 State Board of Registration for Professional Engineers and Land 58 Surveyors shall maintain complete accounting and personnel records 59 related to the expenditure of all funds appropriated under this 60 act and that such records shall be in the same format and level of detail as maintained for Fiscal Year 2023. It is further the 61 62 intention of the Legislature that the agency's budget request for 63 Fiscal Year 2025 shall be submitted to the Joint Legislative 64 Budget Committee in a format and level of detail comparable to the format and level of detail provided during the Fiscal Year 2024 65 66 budget request process.

67 **SECTION 4.** It is the intention of the Legislature that 68 whenever two (2) or more bids are received by this agency for the

69 purchase of commodities or equipment, and whenever all things 70 stated in such received bids are equal with respect to price, 71 quality and service, the Mississippi Industries for the Blind 72 shall be given preference. A similar preference shall be given to 73 the Mississippi Industries for the Blind whenever purchases are 74 made without competitive bids.

SECTION 5. It is the intention of the Legislature that the funds herein appropriated shall be expended in compliance with Section 27-104-25, Mississippi Code of 1972, that no state agency shall incur obligations or indebtedness in excess of their appropriation and that the responsible officers, either personally or upon their official bonds, shall be held responsible for actions contrary to this provision.

82 The money herein appropriated shall be paid by SECTION 6. 83 the State Treasurer out of any money in the State Treasury to the 84 credit of the proper fund or funds as set forth in this act, upon 85 warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the 86 87 proper person, officer or officers, in the manner provided by law. 88 SECTION 7. This act shall take effect and be in force from and after July 1, 2023, and shall stand repealed June 30, 2023. 89
