HOUSE BILL NO. 1622

1 AN ACT MAKING AN APPROPRIATION TO DEFRAY THE EXPENSES OF THE  
2 DEPARTMENT OF HUMAN SERVICES FOR THE FISCAL YEAR 2024.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

4 **SECTION 1.** The following sum, or so much thereof as may be  
5 necessary, is appropriated out of any money in the State General  
6 Fund not otherwise appropriated, to the Department of Human  
7 Services for the fiscal year beginning July 1, 2023, and ending  
8 June 30, 2024.....\$ 74,476,245.00.

9 **SECTION 2.** The following sum, or so much thereof as may be  
10 necessary, is appropriated out of any money in any special fund in  
11 the State Treasury to the credit of the Department of Human  
12 Services which is comprised of special source funds collected by  
13 or otherwise available to the department for the support of the  
14 various divisions of the department, for the purpose of defraying  
15 the expenses of the department for the fiscal year beginning  
16 July 1, 2023, and ending June 30, 2024.....  
17 .....\$ 1,736,609,583.00.



18           **SECTION 3.** None of the funds appropriated by this act shall  
19 be expended for any purpose that is not actually required or  
20 necessary for performing any of the powers or duties of the  
21 Department of Human Services that are authorized by the  
22 Mississippi Constitution of 1890, state or federal law, or rules  
23 or regulations that implement state or federal law.

24           **SECTION 4.** With the funds appropriated in this act, the  
25 following positions are authorized:

26       AUTHORIZED HEADCOUNT:

27       Permanent:	Full Time.....	1,296

29       With the funds herein appropriated, it shall be the agency's  
30 responsibility to make certain that funds required for Personal  
31 Services for Fiscal Year 2025 do not exceed Fiscal Year 2024 funds  
32 appropriated for that purpose unless programs or positions are  
33 added to the agency's Fiscal Year 2024 budget by the Mississippi  
34 Legislature. The Legislature shall determine the agency's  
35 personal services appropriation, which shall be published by the  
36 State Personnel Board. Additionally, the State Personnel Board  
37 shall determine and publish the projected annualized payroll costs  
38 based on current employees. It shall be the responsibility of the  
39 agency head to ensure that actual personnel expenditures for  
40 Fiscal Year 2024 do not exceed the data provided by the  
41 Legislative Budget Office. If the agency's Fiscal Year 2024  
42 projected cost exceeds the annualized costs, no salary actions



43 shall be processed by the State Personnel Board with the exception  
44 of new hires that are determined to be essential for the agency.

45 Any transfers or escalations shall be made in accordance with  
46 the terms, conditions and procedures established by law or  
47 allowable under the terms set forth within this act. The State  
48 Personnel Board shall not escalate positions without written  
49 approval from the Department of Finance and Administration. The  
50 Department of Finance and Administration shall not provide written  
51 approval to escalate any funds for salaries and/or positions  
52 without proof of availability of new or additional funds above the  
53 appropriated level.

54 No general funds authorized to be expended herein shall be  
55 used to replace federal funds and/or other special funds which are  
56 being used for salaries authorized under the provisions of this  
57 act and which are withdrawn and no longer available.

58 None of the funds herein appropriated shall be used in  
59 violation of Internal Revenue Service's Publication 15-A relating  
60 to the reporting of income paid to contract employees, as  
61 interpreted by the Office of the State Auditor.

62 Funds have been appropriated herein for the purpose of  
63 funding Project SEC2 minimum salaries for all employees covered  
64 under the Colonel Guy Groff/Neville Kenning Variable Compensation  
65 Plan. It shall be the agency's responsibility to ensure that the  
66 funds are used to increase all employees' salaries up to the  
67 minimum level as determined by the State Personnel Board.



68           **SECTION 5.** It is the intention of the Legislature that the  
69 Department of Human Services shall maintain complete accounting  
70 and personnel records related to the expenditure of all funds  
71 appropriated under this act and that such records shall be in the  
72 same format and level of detail as maintained for Fiscal Year  
73 2023. It is further the intention of the Legislature that the  
74 agency's budget request for Fiscal Year 2025 shall be submitted to  
75 the Joint Legislative Budget Committee in a format and level of  
76 detail comparable to the format and level of detail provided  
77 during the Fiscal Year 2024 budget request process.

78           **SECTION 6.** Of the funds appropriated in Section 2 herein to  
79 the Department of Human Services, One Million Dollars  
80 (\$1,000,000.00) shall be transferred to the Department of Health,  
81 Child Care Licensure Program from the Child Care Development Fund  
82 or other appropriate special fund. These funds are to be  
83 transferred to the Board of Health no later than July 31, 2023.  
84 The Department of Health shall make a complete accounting to the  
85 Department of Human Services detailing the uses of these funds in  
86 accordance with federal and state regulations.

87           **SECTION 7.** It is the intention of the Legislature that  
88 whenever two (2) or more bids are received by this agency for the  
89 purchase of commodities or equipment, and whenever all things  
90 stated in such received bids are equal with respect to price,  
91 quality and service, the Mississippi Industries for the Blind  
92 shall be given preference. A similar preference shall be given to



93 the Mississippi Industries for the Blind whenever purchases are  
94 made without competitive bids.

95         **SECTION 8.** The Department of Human Services is authorized to  
96 expend available funds on technology or equipment upgrades or  
97 replacements when it will generate savings through efficiency or  
98 when the savings generated from such upgrades or replacements  
99 exceed expenditures thereof.

100         **SECTION 9.** It is the intention of the Legislature that none  
101 of the funds provided herein shall be used to pay certain  
102 utilities for state furnished housing for any employees. Such  
103 utilities shall include electricity, natural gas, butane, propane,  
104 cable and phone services. Where actual cost cannot be determined,  
105 the agency shall be required to provide meters to be in compliance  
106 with legislative intent. Such state furnished housing shall  
107 include single-family and multi-family residences but shall not  
108 include any dormitory residences. Allowances for such utilities  
109 shall be prohibited.

110         **SECTION 10.** In compliance with the "Mississippi Performance  
111 Budget and Strategic Planning Act of 1994," it is the intent of  
112 the Legislature that the funds provided herein shall be utilized  
113 in the most efficient and effective manner possible to achieve the  
114 intended mission of this agency. Based on the funding authorized,  
115 this agency shall make every effort to attain the targeted  
116 performance measures provided below:

217           **SECTION 11.** It is the intent of the Legislature that the  
218 Department of Human Services, Division of Child Support  
219 Enforcement, make a concentrated effort to increase collections of  
220 past due child support payments. On or before January 1, 2024,  
221 the Executive Director of the Department of Human Services shall  
222 submit a report to the Legislative Budget Office detailing  
223 year-to-date performance measures in the Child Support Enforcement  
224 Program compared with the prior year.

225           **SECTION 12.** It is the intention of the Legislature that the  
226 Department of Human Services shall have the authority to spend  
227 such additional funds as it shall receive from the federal  
228 government in incentives or the federal match on those incentives  
229 for the purpose of child support enforcement.

230           **SECTION 13.** Of the funds appropriated in Section 1, Two  
231 Hundred Fifty Thousand Dollars (\$250,000.00) shall be transferred  
232 to the Juvenile Facility Monitoring Unit at the Department of  
233 Public Safety no later than July 31, 2023.

234           **SECTION 14.** Of the funds appropriated herein, to the  
235 Department of Human Services One Million Dollars (\$1,000,000.00),  
236 is provided for the support of the Home Delivered Meals Program  
237 and any additional funds that may be appropriated to this program.

238           **SECTION 15.** Of the funds provided in Section 1, herein to  
239 the Department of Human Services, an amount not to exceed One  
240 Hundred Thousand Dollars (\$100,000.00) is provided to fund the  
241 Senior Olympics Program.



242           **SECTION 16.** It is the intention of the Legislature that the  
243 Governor's Office, Division of Medicaid and the Department of  
244 Human Services shall continue to work together to implement HB  
245 1090 of the 2017 Regular Session, known as the "Medicaid and Human  
246 Services Transparency and Fraud Prevention Act".

247           **SECTION 17.** As a condition of receiving and expending any  
248 funds appropriated under this act, the Department of Human  
249 Services:

250                   (a) Shall use a competitive procurement process for  
251 entering into all TANF subgrant agreements with non-state entities  
252 when the federal government does not direct to whom the funds must  
253 be subgranted;

254                   (b) Upon awarding of a grant to any subgrantee of the  
255 department, shall require the subgrantee to submit a monthly  
256 report to the department that contains, but is not limited to, all  
257 of the following:

258                           (i) A listing of all costs incurred by the  
259 subgrantee during the previous month;

260                           (ii) A listing of all clients served by the  
261 subgrantee, with an explanation of which services were provided to  
262 the clients;

263                           (iii) A listing of all lower-tier subgrantees, who  
264 must be approved by the department before the execution of any  
265 such agreement by the prime subgrantee; and



266 (iv) Any other data required by the department to  
267 provide sufficient evidence of budgetary compliance;

268 (c) Shall not advance funds to a subgrantee for more  
269 than sixty (60) days; and

270 (d) Shall reimburse a subgrantee for expenses only  
271 after the required documentation is provided and is approved by  
272 the department.

273 **SECTION 18.** It is the intent of the Legislature, that within  
274 the funds available, the Department of Human Services may provide  
275 any qualifying grants of CARES Act or American Rescue Act funding  
276 in an amount not to exceed One Million Five Hundred Thousand  
277 Dollars (\$1,500,000.00) to the three (3) regional food banks that  
278 serve Mississippi, including Feed the Gulf Coast, Mid-South Food  
279 Bank, and Mississippi Food Network.

280 **SECTION 19.** With the funds appropriated herein, the  
281 Department of Human Services is authorized to make payment to  
282 certain vendors for expenses incurred during 2021 as follows:

287 **SECTION 20.** The money herein appropriated shall be paid by  
288 the State Treasurer out of any money in the State Treasury to the  
289 credit of the proper fund or funds as set forth in this act, upon  
290 warrants issued by the State Fiscal Officer; and the State Fiscal



291 Officer shall issue his warrants upon requisitions signed by the  
292 proper person, officer or officers, in the manner provided by law.

293       **SECTION 21.** This act shall take effect and be in force from  
294 and after July 1, 2023, except for Section 19 which shall take  
295 effect and be in force from and after the passage of this act and  
296 through the fiscal year ending June 30, 2023, and shall stand  
297 repealed June 30, 2023.
