1 2	AN ACT MAKING AN APPROPRIATION TO DEFRAY THE EXPENSES OF THE DEPARTMENT OF CHILD PROTECTION SERVICES FOR THE FISCAL YEAR 2024 .
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
4	SECTION 1. The following sum, or so much thereof as may be
5	necessary, is appropriated out of any money in the State General
6	Fund not otherwise appropriated, to the Department of Child
7	Protection Services for the fiscal year beginning July 1, 2023,
8	and ending June 30, 2024\$ 131,237,561.00.
9	SECTION 2. The following sum, or so much thereof as may be
10	necessary, is appropriated out of any money in any special fund in
11	the State Treasury to the credit of the Department of Child
11 12	the State Treasury to the credit of the Department of Child Protection Services which is comprised of special source funds

18 **SECTION 3.** Of the funds appropriated under the provisions of

- 20 AUTHORIZED HEADCOUNT:
- 21 Permanent: 1,517
- 22 Time-Limited: 417
- 23 With the funds herein appropriated, it shall be the agency's
- 24 responsibility to make certain that funds required for Personal
- 25 Services for Fiscal Year 2025 do not exceed Fiscal Year 2024 funds
- 26 appropriated for that purpose unless programs or positions are
- 27 added to the agency's Fiscal Year 2024 budget by the Mississippi
- 28 Legislature. The Legislature shall determine the agency's
- 29 personal services appropriation, which the State Personnel Board
- 30 shall publish. The agency's personal services appropriation may
- 31 consist of restricted funds for approved vacancies for Fiscal Year
- 32 2024 that may not be utilized for active Fiscal Year 2023
- 33 Headcount. It shall be the agency's responsibility to ensure that
- 34 the funds provided for vacancies are used to increase headcount
- 35 and not for promotions, title changes, in-range salary adjustments

- 37 employees. It is the Legislature's intention that no employee
- 38 salary falls below the minimum salary established by the

- 40 Additionally, the State Personnel Board shall determine and
- 41 publish the projected annualized payroll costs based on current
- 42 employees. It shall be the responsibility of the agency head to

- 43 ensure that actual personnel expenditures for Fiscal Year 2024 do
- 44 not exceed the data provided by the Legislative Budget Office. If
- 45 the agency's Fiscal Year 2024 projected cost exceeds the
- 46 annualized costs, no salary actions shall be processed by the
- 47 State Personnel Board except for new hires determined to be

- Any transfers or escalations shall be made in accordance with
- 50 the terms, conditions, and procedures established by law or

- 66 **SECTION 4.** It is the intention of the Legislature that the
- 67 Department of Child Protection Services shall maintain complete

- 68 accounting and personnel records related to the expenditure of all
- 69 funds appropriated under this act and that such records shall be
- 70 in the same format and level of detail as maintained for Fiscal
- 71 Year 2023. It is further the intention of the Legislature that
- 72 the agency's budget request for Fiscal Year 2025 shall be
- 73 submitted to the Joint Legislative Budget Committee in a format
- 74 and level of detail comparable to the format and level of detail
- 75 provided during the Fiscal Year 2024 budget request process.
- 76 **SECTION 5.** It is the intention of the Legislature that
- 77 whenever two (2) or more bids are received by this agency for the
- 78 purchase of commodities or equipment, and whenever all things
- 79 stated in such received bids are equal with respect to price,
- 80 quality and service, the Mississippi Industries for the Blind
- 81 shall be given preference. A similar preference shall be given to
- 82 the Mississippi Industries for the Blind whenever purchases are
- 83 made without competitive bids.
- 84 **SECTION 6.** The Department of Child Protection Services is
- 85 authorized to expend available funds on technology or equipment
- 86 upgrades or replacements when it will generate savings through
- 87 efficiency or when the savings generated from such upgrades or
- 88 replacements exceed expenditures thereof.
- 89 **SECTION 7.** Of the funds appropriated in Section 1, herein to
- 90 the Department of Child Protection Services, it is the intention
- 91 of the Legislature that Ninety-three Thousand Six Hundred One
- 92 Dollars (\$93,601.00) shall be allocated to the Mississippi

- 93 Children's Trust Fund supported from General Fund court
- 94 assessments.
- 95 Of the funds appropriated by this act, pursuant
- to Section 97-3-54.9, Mississippi Code of 1972, Two Hundred Fifty 96
- 97 Thousand Dollars (\$250,000.00) is provided for maintaining a
- 98 24-hour hotline that is to be manned at all times, and for a
- coordinator to work with the Department of Public Safety, and to 99
- 100 contract with outside agencies or service providers to organize
- 101 for the provision of specialized services, including counseling
- services and other appropriate care to children who have been 102
- 103 victims of commercial and sexual exploitation or human
- 104 trafficking.
- 105 SECTION 9. Of the funds appropriated in Section 1 and

- 110 SECTION 10. The following sum, or so much thereof as may be
- 111 necessary, is reappropriated out of any money in the Capital
- 112 Expense Fund not otherwise appropriated for the Department of
- 113 Child Protection Services for the purpose of reauthorizing the
- 114 expenditure of Capital Expense Fund, as reappropriated in HB 1611,
- 2022 Regular Session, for information technology system 115
- 116 developments for the fiscal year beginning July 1, 2023, and

118	Notwithstanding the amount reappropriated under this section,
119	the amount that may be expended under the authority of this
120	section, shall not exceed the unexpended balance of the funds
121	remaining as of June 30, 2023, from the amount authorized for the
122	previous fiscal year. In addition, this reappropriation shall not
123	change the purpose for which the funds were originally authorized.
124	SECTION 11. Of the funds appropriated in Section 1, Eleven
125	Million Eighty-six Thousand Two Hundred Thirty-nine Dollars
126	(\$11,086,239.00) are appropriated to fund the Adoption Assistance
127	and Congregate Care Homes Maintenance Payments and One Million Two
128	Hundred Fifty-Four Thousand Nine Hundred Ninety-nine Dollars
129	(\$1,254,999.00) are provided for the Foster Home Maintenance
130	Payments. It is the intent of the Legislature that these funds be
131	expended for said purpose.
132	SECTION 12. Notwithstanding any other provision, the
133	Department of Child Protection Services shall have the authority
134	to escalate its headcount for any additional operational needs
135	related to Coronavirus State Fiscal Recovery Funds, upon approval
136	of the Department of Finance and Administration and the State
137	Personnel Board.
138	SECTION 13. Of the funds appropriated herein, the Department
139	of Child Protection Services is authorized to make payments for
140	expenses incurred during Fiscal Years 2020, 2021, and 2022 for an
141	amount not to exceed Sixty-five Thousand Four Hundred

Seventy-three Dollars and Seventy-nine Cents (\$65,473.79).

SECTION 14. The money herein appropriated shall be paid by
the State Treasurer out of any money in the State Treasury to the
credit of the proper fund or funds as set forth in this act, upon
warrants issued by the State Fiscal Officer; and the State Fiscal
Officer shall issue his warrants upon requisitions signed by the
proper person, officer or officers, in the manner provided by law
SECTION 15. This act shall take effect and be in force from
and after July 1, 2023.
