HOUSE BILL NO. 1636

1 2 3	AN ACT MAKING AN APPROPRIATION FOR THE SUPPORT AND MAINTENANCE OF THE DEPARTMENT OF MARINE RESOURCES FOR THE FISCAL YEAR 2024.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is appropriated out of any money in the State General
7	Fund not otherwise appropriated, for the support and maintenance
8	of the Department of Marine Resources for the fiscal year
9	beginning July 1, 2023, and ending June 30, 2024
10	\$ 2,704,500.00.
11	SECTION 2. The following sum, or so much thereof as may be
12	necessary, is appropriated out of any money in any special fund in
13	the State Treasury to the credit of the Department of Marine
14	Resources for the fiscal year beginning July 1, 2023, and ending
15	June 30, 2024\$ 117,667,565.00.
16	Of the funds appropriated in this section, Three Million
17	Fifty Thousand Dollars (\$3,050,000.00) is derived from the state
18	excise taxes upon gasoline, oil and other petroleum products.

19	SECTION	3. Of	the	funds	appropriated	under	the	provisions	ΟÍ

- 20 this act, the following positions are authorized:
- 21 AUTHORIZED HEADCOUNT:
- Permanent: 90
- 23 Time-Limited: 65
- With the funds herein appropriated, it shall be the agency's
- 25 responsibility to make certain that funds required for Personal
- 26 Services for Fiscal Year 2025 do not exceed Fiscal Year 2024 funds
- 27 appropriated for that purpose unless programs or positions are
- 28 added to the agency's Fiscal Year 2024 budget by the Mississippi
- 29 Legislature. The Legislature shall determine the agency's
- 30 personal services appropriation, which shall be published by the
- 31 State Personnel Board. Additionally, the State Personnel Board
- 32 shall determine and publish the projected annualized payroll costs
- 33 based on current employees. It shall be the responsibility of the
- 34 agency head to ensure that actual personnel expenditures for
- 35 Fiscal Year 2024 do not exceed the data provided by the
- 36 Legislative Budget Office. If the agency's Fiscal Year 2024
- 37 projected cost exceeds the annualized costs, no salary actions
- 38 shall be processed by the State Personnel Board with the exception
- 39 of new hires that are determined to be essential for the agency.
- 40 Any transfers or escalations shall be made in accordance with
- 41 the terms, conditions and procedures established by law or
- 42 allowable under the terms set forth within this act. The State
- 43 Personnel Board shall not escalate positions without written

- 44 approval from the Department of Finance and Administration. The
- 45 Department of Finance and Administration shall not provide written
- 46 approval to escalate any funds for salaries and/or positions
- 47 without proof of availability of new or additional funds above the
- 48 appropriated level.
- No general funds authorized to be expended herein shall be
- 50 used to replace federal funds and/or other special funds which are
- 51 being used for salaries authorized under the provisions of this
- 52 act and which are withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 54 violation of Internal Revenue Service's Publication 15-A relating
- 55 to the reporting of income paid to contract employees, as
- 56 interpreted by the Office of the State Auditor.
- 57 Funds have been appropriated herein for the purpose of
- 58 funding Project SEC2 minimum salaries for all employees covered
- 59 under the Colonel Guy Groff/Neville Kenning Variable Compensation
- 60 Plan. It shall be the agency's responsibility to ensure that the
- 61 funds are used to increase all employees' salaries up to the
- 62 minimum level as determined by the State Personnel Board.
- 63 **SECTION 4.** It is the intention of the Legislature that the
- 64 Department of Marine Resources shall maintain complete accounting
- 65 and personnel records related to the expenditure of all funds
- 66 appropriated under this act and that such records shall be in the
- 67 same format and level of detail as maintained for Fiscal Year
- 68 2023. It is further the intention of the Legislature that the

- 69 agency's budget request for Fiscal Year 2025 shall be submitted to
- 70 the Joint Legislative Budget Committee in a format and level of
- 71 detail comparable to the format and level of detail provided
- 72 during the Fiscal Year 2024 budget request process.
- 73 **SECTION 5.** Each Marine Conservation Officer and Supervisor
- 74 shall be furnished an allowance for uniforms not to exceed Six
- 75 Hundred Dollars (\$600.00) per annum.
- 76 **SECTION 6.** In addition to all other sums heretofore
- 77 appropriated, the following sum, or so much thereof as may be
- 78 necessary, is hereby appropriated out of any money in the State
- 79 Treasury to the credit of the Tidelands Fund No. 3345200000 to the
- 80 Department of Marine Resources for the purpose of defraying the
- 81 expenses of the tidelands projects for the fiscal year beginning
- 82 July 1, 2023, and ending June 30, 2024...... \$ 12,455,247.00.
- Of the funds appropriated within this section, One Million
- 84 Two Hundred Thousand Dollars (\$1,357,544) shall be designated for
- 85 bond repayment.
- 86 Department of Marine Resources Programs:
- Total Public Access Projects \$ 5,048,852.00
- Total Management Projects \$ 5,048,851.00
- 89 Prior Year Projects \$ 1,000,000.00
- 90 Each political subdivision receiving funds authorized in this
- 91 section shall be held responsible for complying with Section
- 92 29-15-9, Mississippi Code of 1972, and shall be subject to an
- 93 audit by the State Auditor and shall submit detailed reports

beginning June 30, and every six (6) months thereafter for the duration of the project to the Department of Marine Resources on how funds authorized in this section were expended.

It is the intention of the Legislature that any political subdivision seeking to qualify for tidelands funds for the subsequent fiscal year shall submit a proposal to the Department of Marine Resources no later than July 1, 2023. All proposals submitted will be reviewed and evaluated by the Department of Marine Resources in accordance to department plans and procedures. Multiphased projects, multiyear projects, proposed projects with high dollar value and projects that have a record of stacking funds shall be considered as low priority projects when evaluated.

It is the intention of the Legislature that if the amount of the Tidelands funds appropriated in this act exceed the actual amount of tidelands funds available, the available funds shall be allocated on a pro rata basis between projects listed in this section.

SECTION 7. It is the intention of the Legislature that the department shall place any special trust funds appropriated to the department in a special trust fund and the interest earned on the principal shall be credited to the special trust fund. Monies in the fund at the end of the fiscal year shall be retained in the special trust fund for use in the next succeeding fiscal year. The department may use the interest earned on the fund to pay reasonable costs for administering the fund and related projects.

- 119 **SECTION 8.** It is the intention of the Legislature that the
- 120 Department of Marine Resources has the authorization to move
- 121 tidelands funds between approved projects upon request from entity
- 122 and proper completion of Form TTF-6 documentation.
- 123 **SECTION 9.** It is the intention of the Legislature for the
- 124 Department of Marine Resources and the Department of Environmental
- 125 Quality to continue with any agency partnerships, including grant
- 126 agreements, that provide environmental projects to restore
- 127 Mississippi's natural resources in the wake of the Deepwater
- 128 Horizon Oil Spill.
- 129 **SECTION 10.** It is the intention of the Legislature that
- 130 whenever two (2) or more bids are received by this agency for the
- 131 purchase of commodities or equipment, and whenever all things
- 132 stated in such received bids are equal with respect to price,
- 133 quality and service, the Mississippi Industries for the Blind
- 134 shall be given preference. A similar preference shall be given to
- 135 the Mississippi Industries for the Blind whenever purchases are
- 136 made without competitive bids.
- 137 **SECTION 11.** Of the funds appropriated in Section 2, Forty-
- 138 Seven Million Three Hundred Fifty-Six Thousand Three Hundred
- 139 Nineteen Dollars (\$47,356,319.00) is provided for the funding of
- 140 the following Gulf of Mexico Energy Security Act (GOMESA) projects
- 141 for FY 2024:

260	SECTION 12. It is the intent of the Legislature that the
261	Department of Marine Resources shall have the authority to expend
262	funds in an amount not to exceed Seventeen Million Dollars
263	(\$17,000,000.00) from funds for the Gulf of Mexico Energy Security
264	Act (GOMESA) that may become available to the agency in fiscal
265	year 2024 in accordance with the rules and regulations of the
266	Department of Finance and Administration in a manner consistent
267	with the escalation of federal funds.

268 SECTION 13. It is the intention of the Legislature that none 269 of the funds provided herein shall be used to pay certain 270 utilities for state furnished housing for any employees. 271 utilities shall include electricity, natural gas, butane, propane, 272 cable and phone services. Where actual cost cannot be determined, 273 the agency shall be required to provide meters to be in compliance 274 with legislative intent. Such state furnished housing shall include single-family and multi-family residences but shall not 275 276 include any dormitory residences. Allowances for such utilities 277 shall be prohibited.

SECTION 14. It is the intention of the Legislature that the funds herein appropriated shall be expended in compliance with Section 27-104-25, Mississippi Code of 1972, that no state agency shall incur obligations or indebtedness in excess of their appropriation and that the responsible officers, either personally or upon their official bonds, shall be held responsible for actions contrary to this provision.

SECTION 15. With the funds appropriated herein, the

Department of Marine Resources is authorized to make payment for

expenses incurred during Fiscal Years 2020 and 2021 as follows:

SECTION 16. The money herein appropriated shall be paid by 294 295 the State Treasurer out of any money in the State Treasury to the 296 credit of the proper fund or funds as set forth in this act, upon 297 warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the 298 299 proper person, officer or officers, in the manner provided by law. 300 SECTION 17. This act shall take effect and be in force from 301 and after July 1, 2023, and shall stand repealed June 30, 2023.
