1 AN ACT MAKING AN APPROPRIATION TO THE MISSISSIPPI DEVELOPMENT 2 AUTHORITY TO PROVIDE FUNDS TO INNOVATE MISSISSIPPI FOR PROVIDING 3 ASSISTANCE UNDER THE RESEARCH AND DEVELOPMENT PROGRAM, THE PROOF 4 OF CONCEPT LOAN PROGRAM, THE MISSISSIPPI NEW TECHNOLOGY BUSINESS 5 PROGRAM-LEVEL 2 PROGRAM AND THE PROOF OF CONCEPT GRANT PROGRAM FOR 6 THE FISCAL YEAR 2024.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 8 SECTION 1. The following sum, or so much of it as may be 9 necessary, is appropriated out of any money in the State General 10 Fund not otherwise appropriated, to the Mississippi Development 11 Authority to provide funds to Innovate Mississippi for providing 12 assistance under the Research and Development Program, the Proof 13 of Concept Loan Program, the Mississippi New Technology Business Program-Level 2 Program and the Proof of Concept Grant Program 14 established under Sections 57-103-1, 57-103-3, 57-103-5 and 15 57-103-7, Mississippi Code of 1972, for the fiscal year beginning 16 July 1, 2023, and ending June 30, 2024.....\$ 2,000,000.00. 17 18 SECTION 2. The money appropriated by this act shall be paid 27 by the State Treasurer out of any money in the State General Fund not otherwise appropriated, upon warrants issued by the State 28 29 Fiscal Officer; and the State Fiscal Officer shall issue his or 30 her warrants upon requisitions signed by the proper person, 31 officer or officers in the manner provided by law.

32 SECTION 4. This act shall take effect and be in force from 33 and after July 1, 2023.
