The following sum, or so much of it as may be 9 necessary, is appropriated out of any money in the Coronavirus 10 State Fiscal Recovery Lost Revenue Fund not otherwise 11 appropriated, to the University of Mississippi Medical Center to 12 assist in paying the costs associated with repair and renovation 13 at and acquisition of equipment for the facility used for the adolescent psychiatric program, for the period beginning upon the 14 passage of this act and ending June 30, 2024.....\$ 6,000,000.00. 15 16 SECTION 2. (1) As used in this section and Section 3 of this act, the term "medical center" means the University of 17 18 Mississippi Medical Center. 19 The medical center shall not disburse any funds 20 appropriated under this act to any recipient without first: (a)

- 21 making an individualized determination that the expenditure sought
- 22 is, in the medical center's independent judgment, for necessary
- 23 expenditures eligible under Section 602 of the federal Social
- 24 Security Act as added by Section 9901 of the federal American
- 25 Rescue Plan Act of 2021 (ARPA) and its implementing guidelines,
- 26 quidance, rules, regulations and/or other criteria, as may be
- 27 amended or supplemented from time to time, by the United States
- 28 Department of the Treasury; and (b) determining that the recipient
- 29 has not received and will not receive reimbursement for the
- 30 expense in question from any source of funds, including insurance
- 31 proceeds, other than those funds provided under Section 602 of the
- 32 federal Social Security Act as added by Section 9901 of ARPA. In
- 33 addition, the medical center shall ensure that all funds
- 34 appropriated under this act are disbursed in compliance with the
- 35 Single Audit Act (31 USC Sections 7501-7507) and the related
- 36 provisions of the Uniform Guidance, 2 CFR Section 200.303
- 37 regarding internal controls, Sections 200.330 through 200.332
- 38 regarding sub-recipient monitoring and management, and subpart F
- 39 regarding audit requirements.
- 40 **SECTION 3.** (1) As a condition of receiving and expending
- 41 the funds appropriated to the medical center under this act, the
- 42 medical center shall certify to the Department of Finance and
- 43 Administration that each expenditure of the funds appropriated to
- 44 the medical center under this act complies with the guidelines,
- 45 quidance, rules, regulations and/or other criteria, as may be

- 46 amended from time to time, of the United States Department of the
- 47 Treasury regarding the use of monies from the Coronavirus State
- 48 Fiscal Recovery Fund established by ARPA.
- 49 (2) If the Office of Inspector General of the United States
- 50 Department of the Treasury, or the Office of Inspector General of
- 51 any other federal agency having oversight over the use of monies
- 52 from the Coronavirus State Fiscal Recovery Fund established by
- 53 ARPA (a) determines that the medical center or recipient has
- 54 expended or otherwise used any of the funds appropriated to the
- 55 medical center under this act for any purpose that is not in
- 56 compliance with the guidelines, guidance, rules, regulations
- 57 and/or other criteria, as may be amended from time to time, of the
- 58 United States Department of the Treasury regarding the use of
- 59 monies from the Coronavirus State Fiscal Recovery Fund established
- 60 by ARPA, and (b) the State of Mississippi is required to repay the
- 61 federal government for any of those funds that the Office of the
- 62 Inspector General determined were expended or otherwise used
- 63 improperly by the medical center or recipient, then the medical
- 64 center or recipient that expended or otherwise used those funds
- 65 improperly shall be required to pay the amount of those funds to
- 66 the State of Mississippi for repayment to the federal government.
- 67 **SECTION 4.** The money appropriated by this act shall be paid
- 68 by the State Treasurer out of any money in the Coronavirus State
- 69 Fiscal Recovery Lost Revenue Fund not otherwise appropriated, upon
- 70 warrants issued by the State Fiscal Officer; and the State Fiscal

- 71 Officer shall issue his or her warrants upon requisitions signed
- 72 by the proper person, officer or officers in the manner provided
- 73 by law.
- 74 **SECTION 5.** This act shall take effect and be in force from
- 75 and after its passage.
