HOUSE BILL NO. 1741

1 AN ACT MAKING AN APPROPRIATION TO THE GOVERNING AUTHORITIES 2 OF THE TOWN OF LEAKESVILLE TO ASSIST IN PAYING THE COSTS 3 ASSOCIATED WITH INFRASTRUCTURE IMPROVEMENTS IN THE TOWN, FOR THE FISCAL YEAR 2024. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. The following sum, or so much of it as may be 6 7 necessary, is appropriated out of any money in the State General Fund not otherwise appropriated, to the governing authorities of 8 9 the Town of Leakesville, Mississippi, to assist in paying the 10 costs associated with the infrastructure improvements described in Section 2 of this act, for the fiscal year beginning July 1, 2023, 11 12 and ending June 30, 2024.....\$ 592,600.00. 13 SECTION 2. The money appropriated by Section 1 of this act 14 shall be expended by the governing authorities of the town as 15 follows: (a) Not more than One Hundred Forty-six Thousand 16 17 Dollars (\$146,000.00) shall be used to assist in paying the costs associated with repairs, upgrades and improvements to River 18 Street, Jane Drive, Hardy Avenue and West Capital Avenue; 19 H. (b) Not more than Seventy-five Thousand Dollars
(\$75,000.00) shall be used to assist in paying the costs
associated with repairs, upgrades and improvements to Lee Drive,
Mississippi Street, North Davis Street, Marion Street and McLeod
Avenue;

(c) Not more than One Hundred Fifty Thousand Dollars
(\$150,000.00) shall be used to assist in paying the costs
associated with repairs, upgrades and improvements to Annex Road;
(d) Not more than Twenty Thousand Dollars (\$20,000.00)
shall be used to assist in paying the costs associated with
repairs, upgrades and improvements to Ferguson Avenue;

31 (e) Not more than Seven Thousand Five Hundred Dollars 32 (\$7,500.00) shall be used to assist in paying the costs associated 33 with repairs, upgrades and improvements to the Piggly Wiggly 34 service road;

35 (f) Not more than Sixty-seven Thousand Six Hundred 36 Dollars (\$67,600.00) shall be used to assist in paying the costs 37 associated with repairs, upgrades and improvements to Jasper 38 Avenue, Florida Avenue and 4th Street;

39 (g) Not more than Seven Thousand Five Hundred Dollars
40 (\$7,500.00) shall be used to assist in paying the costs associated
41 with repairs, upgrades and improvements to Westerfield Avenue;

42 (h) Not more than Sixty Thousand Dollars (\$60,000.00)43 shall be used to assist in paying the costs associated with

46 (i) Not more than Thirty-four Thousand Dollars
47 (\$34,000.00) shall be used to assist in paying the costs
48 associated with the purchase of equipment and machinery for road
49 repair and maintenance; and

50 (j) Not more than Twenty-five Thousand Dollars 51 (\$25,000.00) shall be used to assist in the paying costs 52 associated with repairs, upgrades, improvements and additions to 53 the Old Chickasawhay Bridge.

54 SECTION 3. The money appropriated by this act shall be paid 55 by the State Treasurer out of any money in the State General Fund 56 not otherwise appropriated, upon warrants issued by the State 57 Fiscal Officer; and the State Fiscal Officer shall issue his or 58 her warrants upon requisitions signed by the proper person, 59 officer or officers in the manner provided by law.

60 SECTION 4. This act shall take effect and be in force from 61 and after July 1, 2023.
