15	nominees from across the country who were honored at the 106th
16	annual National Automobile Dealers Association (NADA) Show in
17	Dallas on January 27, 2023, where the announcement of this year's
18	annual award was made by Edward Felsenthal, editor in chief and

- 20 Services and Ally Financial; and
- 21 WHEREAS, dealers are nominated by the executives of state and
- 22 metro dealer associations around the country, and a panel of
- 23 faculty members from the Tauber Institute for Global Operations at
- 24 the University of Michigan selects one finalist from each of the
- 25 four NADA regions and one National Dealer of the Year; nominees
- 26 will also be recognized on AllyDealerHeroes.com, which highlights
- 27 the philanthropic contributions and achievements of TIME Dealer of
- 28 the Year nominees; and
- 29 WHEREAS, Franks was chosen to represent the Mississippi
- 30 Automobile Dealers Association in the National Competition and was
- 31 one of only 48 auto dealers nominated for the  $54^{\rm th}$  annual award
- 32 from more than 16,000 auto dealers nationwide; and
- 33 WHEREAS, he began his journey as an auto dealer entrepreneur
- 34 at the age of 18 when he opened a used car lot in Kosciusko,
- 35 Mississippi and served in several management positions with
- 36 Gray-Daniels Automotive Group in Brandon before opening his first
- 37 new car dealership; and
- 38 WHEREAS, in 2008, Franks' hard work and previous management
- 39 experiences resulted in the opening of Franks Chevrolet, and he
- 40 also operates two pre-owned super centers in Kosciusko and
- 41 Carthage; and
- WHEREAS, he is an active member of the Mississippi Automobile
- 43 Dealers Association and has served in several leadership

- 44 positions, including chair in 2018, vice chair in 2017, and
- 45 secretary in 2016, and due to his leadership, this organization
- 46 started an annual leadership day at the Capitol; and
- 47 WHEREAS, in spite of his many professional obligations,
- 48 Franks still finds time to help others by serving as a volunteer
- 49 pilot for Pilots for Patients, and has logged over 125,000 flight
- 50 miles and more than 100 missions, flying children and adults to
- 51 and from treatment centers; and
- 52 WHEREAS, his philanthropic efforts also include an annual
- 53 donation of a car to the Make-A-Wish Mississippi Foundation for
- 54 the group's annual Cruisin' for a Wish fundraiser, where the
- 55 donated wrapped car travels to stops in the region and creates a
- 56 buzz while raising money for the charity; and
- 57 WHEREAS, it is most appropriate to honor the works of
- 58 exceptional businessmen, such as Stephen Franks, who provide
- 59 meaningful jobs for the citizens of this state, and also dedicates
- 60 their time and resources to improve the quality of life for those
- 61 less fortunate citizens of this state:
