- WHEREAS, once again, Baptist Memorial Hospital-Golden
- 5 Triangle received an A-rating for hospital safety from the
- 6 Leapfrog Group, making it the only hospital in Mississippi to
- 7 receive straight A's in patient safety for 10 consecutive years;
- 8 and
- 9 WHEREAS, caring for residents of the East Mississippi and
- 10 West Alabama area for more than 45 years, Baptist Memorial
- 11 Hospital-Golden Triangle is a 315-bed acute care hospital located
- 12 in Columbus, Mississippi, and it is the largest entity hospital in
- 13 the Baptist Memorial Health Care system; and
- 14 WHEREAS, Leapfrog Hospital Safety Grades, which is
- 15 peer-reviewed, fully transparent and free to the public, provides
- 16 consumer-friendly, patient-reported data and research to help
- 17 patients make informed decisions about one of the most critical
- 18 aspects of their hospital stay, which is patient safety, and

- 19 grades are assigned to nearly 3,000 general acute-care hospitals
- 20 across the nation twice each year, based on up to 30 performance
- 21 measures such as errors, injuries, accidents and infections, as
- 22 well as the systems hospitals have in place to prevent harm; and
- 23 WHEREAS, the Leapfrog Group has awarded Baptist Memorial
- 24 Hospital-Golden Triangle an "A" Safety Grade every biannual
- 25 grading cycle since 2012, and Spring 2022 marked the hospital's
- 26 tenth consecutive year to receive an "A" grade, and it is one of
- 27 only 22 hospitals in the United States to achieve straight "A"
- 28 grades in every grading cycle in the last 10 years, a truly
- 29 outstanding achievement; and
- 30 WHEREAS, with more than 100 physicians and surgeons
- 31 representing nearly every medical specialty, Baptist Memorial
- 32 Hospital-Golden Triangle provides a full range of comprehensive
- 33 medical services, and strives to provide high-quality health care
- 34 services and emphasize patient safety; and
- 35 WHEREAS, it is the policy of this Legislature to recognize
- 36 outstanding Mississippi hospitals, especially those such as
- 37 Baptist Memorial Hospital-Golden Triangle, whose dedication to the
- 38 safety of its patients brings honor to the field of healthcare and
- 39 to the State of Mississippi:
- 40 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
- 41 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
- 42 THEREIN, That we do hereby recognize and commend Baptist Memorial

- 43 Hospital-Golden Triangle upon receiving an "A" rating for 10
- 44 consecutive years.
