HOUSE CONCURRENT RESOLUTION NO. 52

1 2 3 4	A CONCURRENT RESOLUTION RECOGNIZING THE INTREPID LEADERSHIP, JUDICIOUS ADVOCACY AND SELFLESSLY ZEALOUS COMMITMENT OF THE HONORABLE SENATOR ANGELA TURNER-FORD PROVIDED DURING HER TERM AS CHAIRPERSON OF THE MISSISSIPPI LEGISLATIVE BLACK CAUCUS.
5	WHEREAS, since its informal inception in 1976, the
6	Mississippi Legislative Black Caucus, which evolved as an informal
7	organization in 1976, operating in a manner consistent with other
8	states' racial legislative caucuses, before formally establishing
9	in 1980 with Representative Robert G. Clark, Jr., serving as the
10	organization's first chairman, has continued to function as a
11	bastion of hope for the State of Mississippi's African-American
12	and underserved communities; and
13	WHEREAS, in shouldering the mantle of leadership to navigate
14	the path of democracy like the forerunners before her, Senator
15	Angela Turner-Ford, in her capacity as MLBC chairperson, since
16	having been elected to the post in 2019, has maintained the
17	tradition of remaining dedicated to the advancement or defeat, as
18	circumstances respectively necessitate, of legislation impacting
19	the state's African-American population, leading the charge of

- 20 advocacy for many of the social and economic issues impacting many
- 21 of the smaller and more rural communities throughout the state;
- 22 and
- 23 WHEREAS, serving with the same thoughtful analysis, civility
- 24 and even-keeled approach to legislating as her predecessor and
- 25 late father, the Honorable Senator Bennie Turner, Senator
- Turner-Ford has intuitively championed those issues of significant 26
- 27 importance which support public education, increase access to
- 28 healthcare, promote unfettered access to voting, advocate for
- 29 equitable spending of state funds and implementation of policies
- 30 that promote Mississippi's appeal to its next generation of
- 31 leaders; and
- 32 WHEREAS, born in Columbus, Mississippi, on July 2, 1971,
- Senator Turner-Ford attended Mississippi State and Howard 33
- 34 Universities before completing her collegiate matriculation at
- 35 Hampton University with a bachelor's degree in biology, in
- 36 addition to earning a certificate in medical technology from the
- University of Alabama at Birmingham, before ultimately making the 37
- 38 decision to pursue the path of legal jurisprudence by attending
- 39 the University of Mississippi School of Law, where she earned her
- 40 juris doctorate in 2000; and
- WHEREAS, upon the completion of her law degree and successful 41
- admission to the Mississippi Bar, Senator Turner-Ford joined the 42
- 43 Turner Law Firm as her father's protégé, and subsequently the
- torch bearer of his legacy as the successor of his law practice 44

- 45 and political voice for the electorate of Senate District 16 after
- 46 his passing in 2012, emanating a keen intellect and quiet
- 47 disposition, identical to that of her father; and
- 48 WHEREAS, Senator Turner-Ford initially heeded the call to
- 49 public service when appointed to serve as City Prosecutor for the
- 50 City of West Point in 2006, and subsequent thereto, as County
- 51 Prosecutor for Clay County, becoming the first African American to
- 52 be appointed by the board of supervisors to such positions, and
- 53 serving simultaneously in both capacities for the city and county
- 54 until being administered the oath of her elected office in the
- 55 Mississippi Senate in 2013; and
- 56 WHEREAS, a true guardian of the proletariat, Senator
- 57 Turner-Ford's presence in the Mississippi Senate has ushered in a
- 58 new era of reimagining the approach to diplomacy that transcends
- 59 the constructs of a volatile climate borne out of the difference
- 60 in political ideologies and cultural precepts; and
- 61 WHEREAS, as a result of this intuitive foresight to bridge
- 62 the disparity gaps which remain pervasive within Mississippi's
- 63 populace, Senator Turner-Ford, after being tapped by the Senate
- 64 leadership to serve as the body's Public Property Committee
- 65 chairperson, was elected by 52 of her peers to assess the
- 66 labyrinth of Mississippi's political landscape as chairperson of
- 67 the Mississippi Legislative Black Caucus; and

- 68 WHEREAS, with a courageous spirit, a calmly deft hand and
- 69 nurturing heart of compassion, Senator Turner-Ford has piloted the

- 70 helm of the MLBC with utmost deference to facilitate an inclusive
- 71 forum to hear and consider the concerns and recommendations of
- 72 each caucus member to better formulate a singular unified approach
- 73 to address the issues impacting the constituencies they were
- 74 elected to represent; and
- 75 WHEREAS, a firm believer in the power of effective
- 76 communication, Senator Turner-Ford has implemented a consistent
- 77 and efficient system listserv correspondence to ensure the
- 78 simultaneous conveyance of information to every member, providing
- 79 timely notice of strategic plans and agenda items, even in those
- 80 critical instances when time is of the essence and an urgent call
- 81 to action is incumbent upon the caucus to take an official
- 82 position; and
- 83 WHEREAS, Senator Turner-Ford's approach to effectively
- 84 chairing the MLBC has been premised in clearly defined and
- 85 consistently applied positions to effectively wield the most
- 86 influence to accomplish the organization's five-fold policy agenda
- 87 platform, which seeks to effectuate substantive change to improve
- 88 the areas of: health care; education; housing and community
- 89 investment; criminal justice reform; and unsuppressed voter access
- 90 through election reform; and
- 91 WHEREAS, a servant-leader by innate design, Senator
- 92 Turner-Ford, in assuming the responsibilities of office as
- 93 chairperson of the MLBC, has endeavored to cultivate a progressive
- 94 mentality of service and accountability within the MLBC by

96	proactively engaged in grassroot efforts which galvanize the
97	public's interest to make meaningful investments of time, talent
98	and resources in furtherance of fulfilling the caucus' mission;

100	WHEREAS, even in the face of a myriad of uncertainties
101	presented by a global pandemic unleashed by COVID-19, which
102	continues to stifle the quality of life through its residual
103	health and socio-economic implications, Senator Turner-Ford
104	remained undeterred in her efforts to ensure that the MLBC
105	remained at the discussion table, lending its perspective on the
106	plights of all minority communities of color throughout the state
107	who were and remain disproportionately affected by COVID-19 and
108	its various mutations, and advocating for the necessary financial
109	and tangible resources to mitigate the loss of lives and
110	livelihoods within those communities; and
111	WHEREAS, affording full disclosure in the vein of complete
112	transparency, Senator Turner-Ford made certain that every
113	correspondence submitted to the Speaker of the House, Lieutenant
114	Governor and Governor regarding its strategic initiatives to
115	revitalize the public, private and faith-based sectors of the
116	community, requests for CARES Act and ARPA funding, and
117	suggestions of collaborative party efforts to afford the state the
118	ability to emerge from the pandemic mentally, physically and
119	fiscally sound, was also provided to the members of the public

120	through press releases, news conferences, televised and radio
121	media outlets, as well as social media platforms; and
122	WHEREAS, a stalwart pillar of excellence within her community
123	and amongst her elected peers, Senator Turner-Ford's legislative
124	commitment as a dutifully engaged and well-versed member of the
125	Senate Committees on Accountability, Efficiency and Transparency,
126	Appropriations, Judiciary A, Judiciary B, Legislative
127	Reapportionment, Medicaid, Municipalities, Technology and Veterans
128	and Military Affairs, does not overshadow, but works in tandem
129	with her social, civic and professional affiliations as a member
130	of the Mississippi Bar Association, Delta Sigma Theta Sorority,
131	Inc., and Trinity African Methodist Episcopal Church, toward the
132	fulfillment of living a life of integrity, which as an individual
133	of moral and spiritual conviction, brings honor to the body of
134	Christ; and
135	WHEREAS, the service of Senator Turner-Ford would be without
136	honor but for the continued support, encouragement and love of her
137	family, who have endured the daunting struggles that accompany the
138	life of an elected official, and to whom much credit is due for
139	sacrificing countless hours without her in order to allow her to
140	fulfill her legislative obligations, including: husband, Robert
141	Ford, Sr.; and three children, Kennedy, Joshua and Jolen; and
142	WHEREAS, it is the policy of this Legislature to honor the
143	indelible legacy of remarkable service and display of intestinal
