HOUSE CONCURRENT RESOLUTION NO. 62

1	A CONCURRENT RESOLUTION COMMENDING THE ESTEEMED AND LAUDABLE
2	LEGISLATIVE CAREER AND PUBLIC SERVICE OF THE MOST HONORABLE AND
3	DISTINGUISHED GENTLEMAN FROM RANKIN, REPRESENTATIVE TOM
4	WEATHERSBY, UPON THE OCCASION OF HIS RETIREMENT FROM THE
5	MISSISSIPPI HOUSE OF REPRESENTATIVES.

- 6 WHEREAS, the honorable and distinguished Gentleman from
- 7 Rankin, Representative Tom Weathersby has announced his plans for
- 8 retirement from the Mississippi House of Representatives at the
- 9 conclusion of the 2023 Regular Session of the Mississippi
- 10 Legislature, after tirelessly working on behalf of the citizens of
- 11 Mississippi and House District 62, situated in Rankin County, for
- 12 32 consecutive years from the historical floor of the majestically
- 13 aesthetic, ornate and hallowed House Chamber; and
- 14 WHEREAS, before assuming his seat as the member of the
- 15 Mississippi House of Representatives from District 62,
- 16 Representative Weathersby led an exciting life as an exceptional
- 17 basketball player at Florence High School, who acquired the
- 18 nicknames "Shorty" and "Stump" due to his height, an whose
- 19 extraordinary skills afforded him the privileges of playing in the

- 20 Mississippi High School All Star Basketball Game during his senior
- 21 year and earning a basketball scholarship to Hinds Junior College,
- 22 where he played for two years before transferring to the
- 23 University of Southern Mississippi to complete his college
- 24 matriculation with a bachelor's degree in education; and
- 25 WHEREAS, an individual held in high esteem for maintaining a
- 26 reputable rapport with his peers, it was evident early in
- 27 Representative Weathersby's formative years that he was poised for
- 28 leadership after his selection as Mr. Florence High School and
- 29 President of his high school senior class, a characterization of
- 30 respect that followed him to Hinds, where he was also elected as
- 31 President of the Student Body and Mr. Hinds Junior College; and
- 32 WHEREAS, holding fast to the powerful impacts made by his
- 33 high school teachers upon his life, Representative Weathersby
- 34 deemed it befitting to return to his high school alma mater, as a
- 35 teacher and coach in 1967, in an effort to make similar strides to
- 36 positively influence the lives of the state's next generation of
- 37 ambitious leaders; and
- 38 WHEREAS, during his 13 year tenure in education,
- 39 Representative Weathersby coached the Florence High School "Lady
- 40 Eagles" Girls Basketball Team, earning the Little Dixie
- 41 Conference's "Coach of the Year" honor in 1969, capturing the 1970
- 42 state championship with the Lady Eagles in 1970, while
- 43 simultaneously working to obtain a master's degree from
- 44 Mississippi College, which positioned him to become principal of

45 the Florence Elementary School and thereafter appointed as 46 assistant principal at Florence High School; and 47 WHEREAS, in transitioning from the classroom and school administrator's roles to the business arena, Representative 48 49 Weathersby joined his brother Lynn at King Weathersby Appliance 50 Company in 1982, working alongside his brother for 10 years, before pursuing dual endeavors as an entrepreneurial owner and 51 52 operator of Atlas Pallet Company, in Florence from 1990 until 53 2008, when he sold the business; and 54 WHEREAS, an aspiring politician, he set his sights upon the 55 Mississippi Legislature, and upon a successful election bid in 56 1991, Tom Weathersby became the distinguished Gentleman from 57 Rankin upon being sworn into office on the first day of his first 58 legislative session in January 1992, and wasted no time requesting the legislation, amendments and reports that would help effectuate 59 60 into law the ideologies and policy changes that his constituents 61 had elected him to further, and which he personally supported important contributions to the state's most progressive 62 63 advancements, including: providing for a constitutional 64 initiative process in 1992, which allowed the citizens to propose 65 and approve changes to the Mississippi Constitution; creating the 66 Court of Appeals of Mississippi in 1993, which helped relieve the 67 burden on the Mississippi Supreme Court in hearing and deciding

appeals; and the creation of the Motor Vehicle Ad Valorem Tax

Reduction Fund in 1994, which reduced the high cost of car tags;

- 70 and Mississippi Tax Freedom Act of 2022, which provided the
- 71 largest tax cut in state history; and
- 72 WHEREAS, Representative Weathersby served during the terms of
- 73 15 of the highest-ranking officers in the executive and
- 74 legislative branches during his nearly five decades in the House,
- 75 including six governors, beginning with Ray Maybus, six lieutenant
- 76 governors, beginning with Eddie Briggs, and three House speakers,
- 77 beginning with Tim Ford; and
- 78 WHEREAS, Representative Weathersby's love and deeply felt
- 79 respect for the Legislature as a hallowed institution has led his
- 80 fight to preserve and nurture its integrity for all legislators
- 81 who equally hold a lion's share in the stake of advancing the
- 82 direction of the state's economic, educational and political
- 83 climate; and
- WHEREAS, during his long tenure as a member of the House,
- 85 Representative Weathersby has held a number of positions of
- 86 leadership, including: Vice Chairman of the Public Utilities
- 87 Committee from 1996 until 2000; Vice Chairman of the Public
- 88 Buildings, Grounds and Lands Committee (now Public Property) from
- 89 2000 until 2004; Chairman of the Public Property Committee from
- 90 2004 until 2008 and again from 2012 until 2024; Vice Chairman of
- 91 the Municipalities Committee from 2008 until 2012; Vice Chairman
- 92 of the Management Committee; and he also served as a member of the
- 93 Committees on Agriculture; Appropriations; Banking and Financial
- 94 Services; Conservation and Water Resources; Corrections; County

95	Affairs; Education; Energy; Insurance; Oil, Gas and Other
96	Minerals; Public Health and Welfare (now Public Health and Human
97	Services); Transportation; and Ways and Means; and
98	WHEREAS, not one to limit his community involvement to the
99	Legislature, Representative Weathersby has always been active in
100	his district and dedicated to improving the quality of life for
101	all citizens, as evidenced by his service as a deacon, a Mason,
102	member of Sigma Alpha Epsilon, Florence Lions Club, member of the
103	Rankin and Copiah Counties Chambers of Commerce, Mississippi
104	Cattlemen's Association, Kiwanis, ALEC and the NRA; and
105	WHEREAS, while Representative Weathersby is known and admired
106	for his always positive outlook, his easy-going temperament, his
107	insightful intellect and his passion for important issues, and he
108	has always been and remains a exceptional gentleman, grounded in
109	integrity, highly regarded for his understanding of the ultimate
110	purpose of legislation, which is to help people, and he
111	continually seeks to improve the lives of others through his hard
112	work, positive example and the undeniable truths of the Word of
113	God, which have manifested in numerous honors bestowed upon him,
114	such as Hinds Community College's Alumnus of the Year in 2009,
115	induction into the 2006 Class of the Hinds Community College
116	Sports Hall of Fame in 2006, and selection as one of Hinds
117	Community College's 100 Most Passionate People about Hinds in
118	2017; and

119	WHEREAS, Representative Weathersby's life is a true testament
120	to his faith and God being a rewarder of those who diligently seek
121	him, as he has endured and victoriously conquered numerous health
122	challenges, including two Stage 4 cancers, an emergency triple
123	bypass heart surgery, all the while enduring chemotherapy and
124	radiation treatments, which would deplete an average individual's
125	strength, but he has earned a true badge of honor as a real-life
126	Superman, as he continues to lead a purpose-driven life by feeding
127	35 cows in two different pastures located six miles apart every
128	day, manually keeps his home pool clean, bush hogs all pastures,
129	mows three yards, cuts wood for the fireplace and honoring the
130	requests of a sometimes demanding "honey-do" list, all the while
131	endeavoring his best to meet the needs of his District 62
132	constituents; and
133	WHEREAS, leaving the Capitol will not end Representative
134	Weathersby's passion for public service, and retiring from the
135	Legislature does not mean that he is retiring, period, as he plans
136	to maintain his active community involvement on the local level
137	just as he has at the State Capitol, and wants to continue to make
138	a difference wherever and in whatever capacity that he has; and
139	WHEREAS, the members of the House will cherish the bond and
140	common goals for the betterment of this great state shared with
141	Representative Weathersby over the past 32 years, and his
142	impeccable service, devotion and unparalleled commitment to the

144	will be greatly missed; and
145	WHEREAS, the service of Representative Weathersby would be
146	without honor but for the continued support, encouragement and
147	love of his family, who have endured the daunting struggles that
148	accompany the life of an elected official, and much credit is also
149	due to his loved ones who have sacrificed countless hours without
150	him in order to allow him to fulfill his legislative obligations,
151	including: his wife of 56 years, Beverly Cook Weathersby; sons,
152	Tommy, Clay and Bradley; and grandchildren, Cabe, Cook, Kelsey,
153	Grayson, Morgan, Braxton and Shelby; and
154	WHEREAS, it is the policy of this Legislature to honor the
155	indelible legacy of remarkable service of our colleague and
156	friend, Representative Tom Weathersby, who represented his
157	district, the House of Representatives and the people of this
158	state with honor and intrepid dignity:
159	NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
160	REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
161	THEREIN, That we do hereby commend the esteemed and laudable

163	distinguished and senior Gentleman from Rankin, Representative Tom
164	Weathersby, and express fondest respect and best wishes for
