HOUSE CONCURRENT RESOLUTION NO. 63

A CONCURRENT RESOLUTION COMMENDING THE ESTEEMED, LAUDABLE AND PIONEERING LEGISLATIVE CAREER AND PUBLIC SERVICE OF THE MOST HONORABLE AND DISTINGUISHED LADY FROM HINDS, REPRESENTATIVE ALYCE GRIFFIN CLARKE UPON THE SPECIAL OCCASION OF HER RETIREMENT FROM

5 THE MISSISSIPPI HOUSE OF REPRESENTATIVES.

6 WHEREAS, the lovely, honorable and distinguished Lady from

- 7 Hinds, Representative Alyce Griffin Clarke, a true champion of
- 8 District 69, who has not only worked tirelessly for her district -
- 9 District 69, Hinds County, and this great state as a whole, is
- 10 retiring after 38 years of invaluable service that has positively
- 11 changed the lives of Mississippians; and
- 12 WHEREAS, Representative Clarke, who is a political
- 13 trailblazer and pioneer in her own right as she is the first
- 14 African-American woman elected to the Mississippi Legislature,
- 15 serves as a living legend who continues to inspire young women and
- 16 men as she has left an admired ingrained mark in her public
- 17 service; and
- 18 WHEREAS, the roots of Representative Clarke's journey to
- 19 greatness began as a child in the small community of Deovelente,

- 20 Mississippi, in Humphreys County, where she was reared in love by
- 21 her parents, Mr. Henry Griffin and Mrs. Fannie Alice Merriweather
- 22 Griffin, who reared her with a staunch work ethic, which she has
- 23 applied throughout her wonderfully blessed life; and
- 24 WHEREAS, Representative Clarke, who is affectionally referred
- 25 to as "Myrt" by her family and close friends due to her middle
- 26 name being Myrtle, graduated from McNair High School in 1957, in
- 27 Belzoni, Mississippi, and notably, she went on to earn a
- 28 bachelor's degree in home economics in 1961 from her beloved
- 29 Alcorn State University (ASU), which she is known to show her
- 30 adoration for adorning purple and gold attire on a frequent basis;
- 31 and
- 32 WHEREAS, in addition to earning a degree from ASU,
- 33 Representative Clarke earned a master's degree from Tuskegee
- 34 Institute in home economics with an emphasis in nutrition in 1965,
- 35 and she has also had additional studies at Jackson State
- 36 University and Mississippi College, which speaks to her love of
- 37 education; and
- 38 WHEREAS, before assuming her role as an esteemed legislator,
- 39 Representative Clarke helped her community by serving as an
- 40 instructor for the Washington County Public School District (1962-
- 41 1970); served with Mississippi Action for Progress Head Start
- 42 (1970-1972); Director of Nutrition and WIC Services Jackson-
- 43 Hinds Comprehensive Health Center (1972-1987) and notably, in that

- WHEREAS, after Representative Clarke was elected to the
- 47 Legislature, she continued to make contributions as a valuable
- 48 team member with New York Life Insurance Company (1985-2000) and
- 49 Improving the Quality of Life Consulting Services (1995-2005); and
- 50 WHEREAS, although Representative Clarke made priceless
- 51 contributions to her community before being elected, upon her
- 52 election to the House of Representatives in March of 1985 in a
- 53 special election, she became the distinguished Lady from Hinds
- 54 upon being sworn into office and wasted no time requesting the
- 55 legislation, amendments and reports that would not only help her
- 56 constituents in District 69 but also help this great state as a
- 57 whole; and
- 58 WHEREAS, upon being elected, Representative Clarke faced
- 59 certain challenges upon her arrival to the House because she was
- 60 the only female African American in the Legislature, and one such
- 61 challenge was that her fellow female colleagues did not inform her
- 62 that they had a special restroom for their use; and
- 63 WHEREAS, undaunted by her exclusion from the special restroom
- 64 for her white female colleagues, Representative Clarke, who is
- 65 known for ensuring that all people are treated equally, made sure
- 66 that more restrooms for women were placed throughout the Capitol,
- 67 which is truly an enduring legacy that benefits women who work and
- 68 visit our beautiful Capitol; and

          WHEREAS, notably, as a mark of her steadfastness in state
     government, Representative Clarke, during her nearly four decades

     in the House, served under seven Governors, beginning with Bill

     Allain, seven Lieutenant Governors, beginning with Brad Dye and

     four House Speakers, beginning with Buddie Newman; and

          WHEREAS, Representative Clarke has introduced over 1,500

     bills and one of the highlights of her successful legislative
     career was a bill she introduced in 1986 entitled Born Free Act,

     and from this act, which stemmed from her work with women, infants

- 120 Catholic Charities; and
- 121 WHEREAS, Representative Clarke also authored a bill creating
- 122 Mississippi's International Baccalaureate Diploma program, and in
- 123 2003, after years of advocacy for a more comprehensive
- 124 rehabilitative approach for criminal defendants who committed
- 125 crimes while under the influence of alcohol/drugs, the Alyce
- 126 Griffin Clarke Drug Court Act, Senate Bill 2605, was passed; and
- 127 WHEREAS, in 2018, after 19 years of pursuing a lottery law,
- 128 the Alyce G. Clarke Mississippi Lottery Law, Senate Bill 2001,
- 129 from the 1st Extraordinary Session of 2018, was signed into law,
- 130 which authorized the first \$80 million in annual lottery proceeds
- 131 to go to infrastructure and anything beyond that amount goes to
- 132 education; and
- WHEREAS, additionally, in 2019, House Bill 1160 was signed
- 134 into law, and in this legislation, Mississippi's first pediatric
- 135 palliative care center was established and due to the work of
- 136 Representative Clarke and her love for children, the facility will
- 137 be named the Alyce G. Clarke Center for Medically Fragile
- 138 Children; and
- 139 WHEREAS, in addition to having legislation and a medical
- 140 facility named in her honor, Representative Clarke is depicted on
- 141 a mural entitled "Chain Breakers", on Jackson State University's
- 142 COFO Civil Rights Education Building, where she, along with five
- 143 other civil rights legends, one of which is Fannie Lou Hamer, are

- 145 for equality; and
- 146 WHEREAS, as one who is known for her trademark greeting of "I
- 147 am blessed and how are you," and who has governed and led by her
- 148 Christian values, Representative Clarke's genesis of the
- 149 instillment of her Christian values stem from Shiloh Missionary
- 150 Baptist Church, where she was baptized, and her values have
- 151 blossomed as a dedicated member of Cade Chapel Missionary Baptist
- 152 Church, where she served as an usher or gatekeeper for the House
- 153 of the Lord for 34 years; and
- WHEREAS, the service of Representative Clarke would be
- 155 without honor but for the continued support, encouragement and
- 156 love of her family, which included her husband of 32 years, Mr.
- 157 Lee William Clarke, who was her number one cheerleader until his
- 158 passing in 2004, and their successful son, DeMarquis Clarke, both
- 159 of whom sacrificed countless hours without her in order that she
- 160 could fulfill her legislative obligations; and
- 161 WHEREAS, it is the policy of this Legislature to honor the
- 162 indelible legacy of remarkable service of our colleague and
- 163 friend, Representative Alyce Griffin Clarke, who represented
- 164 District 69, Hinds County, this body and the people of this state
- 165 with honor and intrepid dignity for 38 years:
- NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
- 167 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
- 168 THEREIN, That we do hereby commend the most honorable,

169	distinguished Lady from Hinds, Representative Alyce Griffin
170	Clarke, for her esteemed and laudable legislative career and
171	public service, and express fondest respect and best wishes for
172	continued success in all her future endeavors.
