- 4 WHEREAS, it is written in Ecclesiastes 3:1 that "To
- 5 everything there is a season, and a time for every purpose under
- 6 the Heaven," and as such, on April 24, 2022, the immaculate author
- 7 and finisher of our soul's destiny summoned the mortal presence of
- 8 dearly beloved, Mr. Norman Goetzmann Stevens, Jr., of Mount Olive,
- 9 Mississippi, to eternal rest, rendering great sorrow and loss to
- 10 his family, friends and community; and
- 11 WHEREAS, born on June 11, 1931, in Picayune, Mississippi, to
- 12 Mr. Norman Goetzmann Stevens, Sr., and Mrs. Fern Anderson Stevens,
- 13 loving parents who laid a fine foundation for a remarkable life,
- 14 Mr. Goetzmann grew up in Picayune and spoke fondly of his days
- 15 there as a child, including riding with the engineer in the Crosby
- 16 steam engine as it carried logs between the mill and the mill
- 17 pond, untold hours at the YMCA, where he was when news of Pearl
- 18 Harbor came, and fishing on the Hobolochitto with his dad; and

- 19 WHEREAS, Mr. Goetzmann became a gifted athlete at Picayune
- 20 High School in multiple sports, leading the football team to a
- 21 state championship in 1948, and because of his outstanding
- 22 athleticism, he was a highly recruited quarterback, and like his
- 23 father before him, who was Louisiana State University's last four
- 24 sport letterman, he became a Bengal Tiger, one of the few
- 25 father-son combos in LSU football history, and while there, he
- 26 played the seasons of 1950 through 1953, and was named the MVP his
- 27 senior season; and
- 28 WHEREAS, while at LSU, Mr. Goetzmann met his beloved future
- 29 bride, Ms. Martha Sue "Mossy" Blain, a cheerleader who rode atop
- 30 the tiger cage into Tiger Stadium for each home game, and they
- 31 married December 20, 1952; and
- 32 WHEREAS, upon graduation, Mr. Goetzmann took a position with
- 33 a Picayune bank, but soon received a draft notice, and the United
- 34 States Air Force assigned him to Keesler Air Force Base, where the
- 35 base commander wanted him to coach and play for the base football
- 36 team, and while there, he was promoted to First Lieutenant and was
- 37 ultimately, as a 24-year-old, in command of over 600 men training
- 38 as radar operators; and
- 39 WHEREAS, after his time in the Air Force, Mr. Goetzmann
- 40 joined his father-in-law's company, Blain Construction Company of
- 41 Mount Olive, Mississippi, and helped build an outstanding company
- 42 that endured well into a third generation; and

highway construction and materials business and was a part of 44 building many of the major highways and interstates across 45 46 Mississippi and bordering states; and 47 WHEREAS, Mr. Goetzmann was well respected by his peers, known 48 for his honest dealings and forward-thinking practices, and served in leadership positions on many industry boards on a state and 49 50 national basis, as well as numerous local civic and philanthropic 51 boards; and 52 WHEREAS, in one of the defining moments of his life, as a young father of three children, Mr. Goetzmann suddenly lost his 53 54 beloved Martha Sue in 1965, but by the grace of God, he weathered 55 this heartache, and married the second love of his life, Ms. 56 Elizabeth "Beth" Wagner, on January 11, 1969, thereby becoming father to two more beloved children, and there has never been a 57 58 more complete melding of two families into one; and 59 WHEREAS, in a second defining moment, Beth was diagnosed with advanced ovarian cancer in August 2000, and Mr. Goetzmann 60 61 immediately retired from his work and devoted the next ten years 62 to walking side by side with her through a long and arduous
