HOUSE RESOLUTION NO. 48

1 A RESOLUTION RECOGNIZING AND COMMENDING THE MISSISSIPPI HORSE  
2 PARK FOR RECEIVING THE 2022 JUSTIN BOOTS BEST FOOTING AWARD FOR  
3 THE SOUTHEASTERN CIRCUIT.

4 WHEREAS, set atop the rolling hills, the Mississippi Horse  
5 Park is a beautiful 100 acre facility that is located just south  
6 of the Mississippi State University (MSU) main campus; and

7 WHEREAS, the park, which is a division of the MSU Extension  
8 Service, is part of a three part partnership with Mississippi  
9 State University, the City of Starkville and Oktibbeha County, and  
10 it is dedicated to supporting weekly labs and classes taught  
11 through the university, as well as providing unprecedented  
12 entertainment and service for exhibitors and spectators, hosting  
13 an average of 40 events each year, with over 40,000 people  
14 entering its gates each year; and

15 WHEREAS, last year, the Mississippi Horse Park was honored  
16 with the prestigious Justin Boots Best Footing Award for the  
17 Southeastern Circuit by the Women's Professional Rodeo Association  
18 (WPRA) for the 2022 Rotary Rodeo; and



19 WHEREAS, since the early 1990s, the WPRA and Justin Brands  
20 have honored rodeo committees in each of the 12 circuits with the  
21 Justin Best Footing Awards, which recognizes the hard work and  
22 time that rodeo committees put into making their ground as  
23 consistent and safe as possible for the animal athletes of rodeo;

25 WHEREAS, nine states in the Southeastern Circuit and over 70  
26 rodeos were considered for this award, and in December 2022, Ms.  
27 Bricklee Miller, Director of the Mississippi Horse Park, accepted  
28 this outstanding honor at the National Finals Rodeo in Las Vegas,  
29 Nevada; and

30 WHEREAS, this distinguished award is determined by votes from  
31 the WPRA membership and circuit directors, and represents the  
32 members' voices saying "thank you" to rodeo committees who have  
33 gone above and beyond to ensure safe ground conditions, allowing  
34 the horsepower in the WPRA to run at an elite level; and

35 WHEREAS, it is the policy of the House of Representatives to  
36 recognize outstanding Mississippi facilities, especially those  
37 such as the Mississippi Horse Park, whose service and dedication  
38 to providing safe ground conditions brings honor to the State of  
39 Mississippi:

40 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF  
41 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we do hereby  
42 recognize and commend the Mississippi Horse Park for receiving the  
43 Justin Boots Best Footing Award for the Southeastern Circuit by



44 the Women's Professional Rodeo Association for the 2022 Rotary  
45 Rodeo, and extend best wishes for continued success in all its  
46 future endeavors.
