- 3 WHEREAS, one of the greatest rock drummers of this
- 4 generation, Mr. Tommy Aldridge is renowned for his virtuosity,
- 5 groove, and for innovating such techniques as the use of double
- 6 kick drums and playing with his bare hands; and
- WHEREAS, born on August 15, 1950, in Jackson, Mississippi,
- 8 Mr. Aldridge was raised in Pearl, Mississippi, and graduated from
- 9 Pearl High School in 1968; and
- 10 WHEREAS, Mr. Aldridge taught himself to play drums in the
- 11 1960s, building a kit piece by piece with money he earned by
- 12 delivering newspapers and working other jobs, and he credits his
- 13 unique style to learning without the benefit of a mentor or
- 14 teacher; and
- WHEREAS, in the early 1970s, Mr. Aldridge began playing
- 16 original music with Alley Keith in the Florida Panhandle, and as
- 17 he was inspired by drummers such as Louis Bellson and Sam

18 Woodyard, he started using a double-bass drum setup, and became an

- 19 early pioneer of the hard rock double kick drum style of drumming;
- 20 and
- 21 WHEREAS, after playing for a short time with the southern
- 22 rock band David and the Giants, in 1972, Mr. Aldridge auditioned
- 23 for the band Black Oak Arkansas, and he made his recording debut
- 24 that year with the band's If an Angel Came to See You, Would You
- 25 Make Her Feel at Home? album, and he subsequently toured
- 26 extensively and recorded 10 albums with the band between 1972 and
- 27 1976, which surpassed a collective 1.5 million in sales; and
- 28 WHEREAS, from 1978 until 1981, Mr. Aldridge was with the Pat
- 29 Travers Band, recording five albums over that time, and upon
- 30 parting ways with Travers in 1981, he moved to London, England,
- 31 and began working with Gary Moore, recording the Dirty Fingers
- 32 album; and
- 33 WHEREAS, after working with Mr. Moore, and becoming friends
- 34 with American guitarist Randy Rhoads, who had been in England
- 35 recording with Ozzy Osbourne, Mr. Aldridge, who had toured with
- 36 Mr. Osbourne's previous band, Black Sabbath, extensively in the
- 37 1970s as part of Black Oak Arkansas, joined Mr. Osbourne's band
- 38 in 1981, prior to the North American leg of the "Blizzard Of Ozz"
- 39 tour; and
- 40 WHEREAS, Mr. Aldridge appeared on Mr. Osbourne's Bark at the
- 41 Moon album in 1983, which sold nearly 4.8 million copies, as well
- 42 as a pair of live albums, Speak of the Devil, which achieved

- 43 platinum status in the United States, and Tribute, before leaving
- 44 the band in 1984; and
- 45 WHEREAS, soon after, Mr. Aldridge, along with former Ozzy
- 46 Osbourne-bandmate, Rudy Sarzo, joined forces with two others to
- 47 form a project called M.A.R.S. and afterwards, Mr. Aldridge and
- 48 Mr. Sarzo both joined the band Whitesnake in 1987, as the band
- 49 prepared to tour in support of its multi-platinum selling
- 50 Whitesnake album; and
- 51 WHEREAS, Mr. Aldridge performed on the band's 1989 follow-up
- 52 album, Slip of the Tongue, which went platinum, and following his
- 53 time in Whitesnake, he played in the band Manic Eden, and during
- 54 the 1990s, Mr. Aldridge recorded and toured with various acts
- 55 including Motörhead, House of Lords, Yngwie Malmsteen, John Sykes
- 56 and Ted Nugent; and
- 57 WHEREAS, widely respected in the rock community, Mr. Aldridge
- 58 has been an in-demand drum clinician since the early 1980s, and
- 59 much of his work involves festivals and drum clinics, discussing
- 60 everything from the basic fundamentals of rock drumming, to the
- 61 double bass fills and solos that made him famous; and
- 62 WHEREAS, Mr. Aldridge's "Rock Drum Soloing and Double Bass
- 63 Workout" was his first instructional video, and he is currently
- 64 working on his second instructional video and a method book on
- 65 double bass drumming; and
- WHEREAS, from 2002 until 2007, Mr. Aldridge toured with
- 67 Whitesnake, and from 1997 through 2001, and again from 2007

- 68 through 2009, he toured with the John Sykes-fronted version of
- 69 Thin Lizzy; and
- 70 WHEREAS, on January 25, 2013, it was announced that Mr.
- 71 Aldridge had rejoined Whitesnake for the third time for the band's
- 72 upcoming "Year of the Snake" tour, and he has since recorded the
- 73 albums Flesh & Blood and The Purple Album with the group and
- 74 remains their drummer; and
- 75 WHEREAS, for more than four decades, Mr. Aldridge's fiery
- 76 drumming has defined hard-rock showmanship, and his signature
- 77 style is a rare combination of power, technique, and feel, and in
- 78 total, he has played on albums that have combined to sell nearly
- 79 10,000,000 copies; and
- 80 WHEREAS, it is the policy of the House of Representatives to
- 81 recognize extraordinary Mississippi musicians, especially those
- 82 such as Mr. Aldridge, whose incredible talent, hard-hitting style,
- 83 flair and showmanship, continues to be a major influence in the
- 84 music industry:
- 85 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
- 86 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we do hereby
- 87 recognize and commend Mr. Tommy Aldridge for his outstanding
- 88 musical artistry and accomplishments, and express sincere wishes
- 89 for continued success in all of his future endeavors.
- 90 BE IT FURTHER RESOLVED, That copies of this resolution be
- 91 furnished to Mr. Tommy Aldridge, and to the members of the Capitol
- 92 Press Corps.
