Christi Family Practice Residency Program, and then followed her

- 20 Medical Group and South Sunflower County Hospital in 2007,
- establishing a large practice in the underserved Mississippi 21
- 22 Delta, providing full spectrum care, including obstetrics, during

- 24 WHEREAS, Dr. Patterson served future physicians in the State
- of Mississippi as a passionate advocate for the Mississippi Rural 25
- 26 Physicians Scholarship Program and the Office of Mississippi
- 27 Physician Workforce, while also donning the intrepid and necessary
- 28 role as a teacher, educating countless medical students and
- 29 residents, hosting rural rotations, obstetrical blocks, lectures
- 30 and mentoring; and
- 31 WHEREAS, Dr. Patterson was recognized for her exemplary
- contributions to family medicine in July 2022, with her selection 32
- 33 for the John B. Howell Memorial Award as the Family Physician of
- 34 the Year by the Mississippi Academy of Family Physicians; and

- bask in the presence of the great Deity in the spirit realm, Dr. 36
