SENATE BILL NO. 2273

AN ACT TO AMEND SECTION 23-15-753, MISSISSIPPI CODE OF 1972,
TO INCREASE PUNISHMENT FOR THE CRIME OF VOTE FRAUD TO A FINE NOT
LESS THAN \$1,000.00 AND A TERM OF IMPRISONMENT IN THE PENITENTIARY
FOR NOT LESS THAN ONE YEAR; AND FOR RELATED PURPOSES.

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 23-15-753, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 23-15-753. (1) Any person who willfully, unlawfully and
- 9 feloniously procures, seeks to procure, or seeks to influence the
- 10 vote of any person voting by absentee ballot, by the payment of
- 11 money, the promise of payment of money, or by the delivery of any
- 12 other item of value or promise to give the voter any item of
- 13 value, or by promising or giving the voter any favor or reward in
- 14 an effort to influence his vote, or any person who aids, abets,
- 15 assists, encourages, helps, or causes any person voting an
- 16 absentee ballot to violate any provision of law pertaining to
- 17 absentee voting, or any person who sells his vote for money,
- 18 favor, or reward, has been paid or promised money, a reward, a

- 19 favor or favors, or any other item of value, or any person who
- 20 shall willfully swear falsely to any affidavit provided for in
- 21 Sections 23-15-621 through 23-15-735, shall be guilty of the
- 22 <u>felony</u> crime of "vote fraud" and, upon conviction, shall be * * *
- 23 fined not less than * * * One Thousand Dollars (\$1,000.00) nor
- 24 more than Five Thousand Dollars (\$5,000.00) * * * and shall be
- 25 sentenced to the State Penitentiary for not less than one (1) year
- 26 nor more than five (5) years.
- 27 (2) It shall be unlawful for any person who pays or
- 28 compensates another person for assisting voters in marking their
- 29 absentee ballots to base the pay or compensation on the number of
- 30 absentee voters assisted or the number of absentee ballots cast by
- 31 persons who have received the assistance. Any person who violates
- 32 this section, upon conviction, shall * * * be fined not less than
- 33 One Thousand Dollars (\$1,000.00) nor more than Five Thousand
- 34 Dollars (\$5,000.00) * * * and shall be imprisoned in the
- 35 Penitentiary not less than one (1) year nor more than five (5)
- 36 years, or both.
- 37 **SECTION 2.** This act shall take effect and be in force from
- 38 and after July 1, 2023.
