## SENATE BILL NO. 2434

AN ACT TO AMEND SECTION 51-35-333, MISSISSIPPI CODE OF 1972, TO DELETE THE PROVISION OF LAW AUTHORIZING THE BOARD OF DIRECTORS OF A DISTRICT FORMED UNDER THE URBAN FLOOD AND DRAINAGE CONTROL ACT TO LEVY SPECIAL ASSESSMENTS ON CERTAIN PROPERTY; AND FOR RELATED PURPOSES.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. Section 51-35-333, Mississippi Code of 1972, is 8 amended as follows:

9 51-35-333. (1) **\* \* \*** To provide funds for the payment of 10 the principal of, interest on, and other charges in connection with bonds issued under the provisions of this article, to provide 11 12 funds for the annual expenses of operations of the district, and to provide funds for carrying out any of the purposes of this 13 article, the district is empowered to levy annually a special tax 14 15 upon all the taxable property within such district on or before 16 the first Monday of September of each year and shall certify the levy to the boards of supervisors of the various counties in the 17 district. It shall be the duty of the boards of supervisors of 18 19 each county to make the levy on each tract of land or other

( \* \* \*2) 22 The taxes shall be collected by the tax collectors 23 of the respective counties in the district, who shall deposit them 24 in such depository as shall be selected by the board of directors of the district. The tax collector shall receive a sum not 25 greater than one-fifth of one percent (1/5 of 1%) of the amount 26 27 collected for his services in making such collection, and the fee 28 shall be paid into the county general fund. It shall be the duty 29 of the board of directors to levy a tax sufficient to pay the bonds and the interest thereon as such bonds and interest become 30 due, to pay for the annual expense of operation of the district, 31 32 and to provide funds for carrying out any of the purposes of this 33 article.

35 SECTION 2. This act shall take effect and be in force from 36 and after July 1, 2023.
