SENATE BILL NO. 2534

1 AN ACT TO AMEND SECTION 49-4-39, MISSISSIPPI CODE OF 1972, TO 2 REQUIRE A FRESHWATER FISHING GUIDE OR SERVICE THAT UTILIZES A BOAT 3 TO OBTAIN A FISHING GUIDE BOAT LICENSE AND DECAL; TO PROVIDE THE FEE FOR SUCH LICENSE; TO PROVIDE THAT FRESHWATER FISHING GUIDES 4 5 SHALL BE PROHIBITED FROM FISHING WHILE PROVIDING SERVICE; TO 6 PROVIDE THAT FRESHWATER FISHING GUIDES SHALL BE PROHIBITED FROM KEEPING ANY FISH CAUGHT BY THE PERSONS THEY ARE GUIDING; TO 7 PROVIDE THAT THE PRESENCE OF THE GUIDE DOES NOT COUNT TOWARD THE 8 9 BAG LIMIT FOR FISH; AND FOR RELATED PURPOSES.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

11 SECTION 1. Section 49-4-39, Mississippi Code of 1972, is

- 12 amended as follows:
- 13 49-4-39. (1) As used in this section:

14 (a) "Head boat" means a fishing boat that takes

15 recreational (sports) fishermen out for a fee per person.

16 (b) "Charter boat" means a fishing boat with a skipper,

17 guide, outfitter or captain that is rented for a fee for the

- 18 purpose of fishing.
- 19 (c) "Guide" means a person who advises or shows the way
- 20 to others for a fee.

21	(d) "Outfitter" means an establishment that sells
22	services for outdoor activities.
23	(e) "Skipper" means the captain of a ship or boat.
24	(f) "Captain" means a person who is at the helm,
25	controls or steering of a ship or boat.
26	(2) The commission may regulate hunting, fishing and
27	wildlife viewing, guide and outfitter services. The commission
28	shall have the following powers and duties:
29	(a) Prescribe the form and type of licenses;
30	(b) Prescribe an annual distinguishable decal for each
31	boat;
32	(* * * c) Except as otherwise provided in this section,
33	establish fees for the types of licenses; the fee for guide <u>and</u>
34	outfitter services annual licenses * * * to be less than Five
35	Hundred Dollars (\$500.00) for residents and not less than Two
36	Thousand Dollars (\$2,000.00) for nonresidents; * * *

38	(d) Require one-year proof of residency and a valid
39	sportsman's license for residents;
40	(e) Require a valid nonresident fishing license for
41	nonresidents;
42	(f) Require First Aid/CPR certification; and
43	(g) Exercise all powers to make regulations for
44	enforcement and safety of such services.

45	(3) A fishing guide, outfitter, skipper or captain that
46	utilizes a boat to provide fishing guide services shall obtain an
47	annual fishing guide boat license and decal for a fee of Two
48	Hundred Fifty Dollars (\$250.00). In order to obtain a fishing
49	guide boat license and decal, an applicant must register the boat
50	being utilized with the department and provide to the department a
51	copy of the driver's license of the guide, outfitter, skipper or
52	captain and proof of liability insurance and such other
53	information as the department may require by regulation.
54	(4) A fishing guide, outfitter, skipper, captain, boat mate
55	or crew is prohibited from keeping a recreational bag limit of
56	fish.
57	(5) The presence of a guide, outfitter, skipper, captain,
58	boat mate or crew does not count toward the boat's daily
59	possession limit for all game fish.
60	(6) A violation of this section or any regulation created by
61	the commission exercising its powers to regulate safety and
62	services is a Class II violation and is punishable as provided in
63	Section 9-7-143.
64	SECTION 2. This act shall take effect and be in force from
65	and after July 1, 2023.
