SENATE BILL NO. 2703

1 AN ACT TO AMEND SECTION 63-1-43, MISSISSIPPI CODE OF 1972, TO
2 REQUIRE THE DEPARTMENT OF PUBLIC SAFETY TO WAIVE THE FEE FOR ANY
3 DRIVER'S LICENSE, INTERMEDIATE LICENSE OR LEARNER'S PERMIT ISSUED
4 TO APPLICANTS WHO ARE IN THE CUSTODY OF THE DEPARTMENT OF CHILD
5 PROTECTION SERVICES; TO AMEND SECTION 45-1-21, MISSISSIPPI CODE OF
6 1972, TO CONFORM; AND FOR RELATED PURPOSES.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

8 **SECTION 1.** Section 63-1-43, Mississippi Code of 1972, is
9 amended as follows:

10 63-1-43. (1) The commissioner shall charge and collect the
11 following fees:

12 (a) Fees to which the card stock fee authorized in
13 Section 45-1-21 shall be added:

59 (c) In addition to the fees required in this section,
60 an applicant may contribute an additional One Dollar (\$1.00) which
61 shall be deposited into the Statewide Litter Prevention Fund. The
62 applicant shall be informed that he may contribute an additional
63 One Dollar (\$1.00) which shall be deposited into the Statewide
64 Litter Prevention Fund and shall be expended solely for the
65 purpose of funding litter prevention projects or litter education
66 programs, as recommended by the Statewide Litter Prevention
67 Program of Keep Mississippi Beautiful, Inc.

68 (d) Starting January 1, 2021, for any original or
69 renewal license for which the fee is greater than Ten Dollars
70 (\$10.00), if the applicant brings all required documentation but



71 does not receive his or her license within two and one-half
72 (2-1/2) hours of entering and remaining at the license station,
73 Ten Dollars (\$10.00) shall be deducted from the total amount owed
74 for the license.

75 (2) All originals and renewals of operators' licenses shall
76 be in compliance with Section 63-1-47.

77 (3) Notwithstanding any provision of law to the contrary in
78 this section, the commissioner shall waive the driver's license,
79 intermediate license, or learner's permit fee for any applicant in
80 the custody of the Department of Child Protection Services.

81 **SECTION 2.** Section 45-1-21, Mississippi Code of 1972, is
82 amended as follows:

83 45-1-21. (1) (a) The Mississippi Department of Public
84 Safety being required by law to keep various records and perform
85 various services and being authorized to furnish certain records
86 and services, the department, by direction of the Commissioner of
87 Public Safety, shall establish and collect for such services a
88 proper fee, commensurate with the service rendered and the cost of
89 the service for the furnishing of any record or abstract thereof
90 in the Department of Public Safety now or which may hereafter be
91 required by law to be kept by said department, any photograph or
92 photo copy or any report of any kind authorized by law, including
93 services for polygraph tests and reports thereof.

94 (b) No records shall be furnished by the Mississippi
95 Department of Public Safety which are classified as confidential



by law. All fees collected under this section shall be paid into the General Fund of the State Treasury in accordance with the provisions of Section 45-1-23(2).

(2) (a) (i) The Commissioner of Public Safety, by rule duly filed with the Secretary of State under the Administrative Procedures Act, may establish a card stock fee to be paid by an applicant when specifically authorized by statute for producing a license, permit or identification card bearing the likeness of the applicant. The card stock fee shall be the actual cost of producing the license, permit or identification card as set by contract rounded off to the next highest dollar.

(ii) The administrative rule filing shall include either:

1. A copy of the contract governing the actual cost of producing the license permit or identification card, from which nonpublic information may be redacted; or

2. An abstract of the pertinent parts of the contract verified to be correct by the person responsible for the administrative rule filing.

(b) Monies collected for the card stock fee shall be deposited into a special card stock fee account which the Department of Public Safety shall use to pay the actual cost of producing the licenses and identification cards. Any monies collected in excess of the actual costs of the card stock fee may be used by the department to defray the cost of future

123 year shall not lapse into the State General Fund and any interest
124 earned from the investment of monies in the fund shall be
125 deposited to the credit of the fund.

126 (3) The fee authorization provided in subsection (2) of this
127 section shall not apply to any applicant in the custody of the
128 Department of Child Protection Services.

129 **SECTION 3.** This act shall take effect and be in force from
130 and after July 1, 2023.
