1 AN ACT TO AMEND SECTION 19-11-27, MISSISSIPPI CODE OF 1972, 2 TO PERMIT COUNTY BOARDS OF SUPERVISORS TO EXPEND FEDERAL FUNDS 3 DURING THE LAST TERM OF OFFICE OF SUCH BOARD; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. Section 19-11-27, Mississippi Code of 1972, is 6 7 amended as follows: 19-11-27. No board of supervisors of any county shall expend 8 9 from, or contract an obligation against, the budget estimates for 10 road and bridge construction, maintenance and equipment, made and published by it during the last year of the term of office of such 11 12 board, between the first day of October and the first day of the following January, a sum exceeding one-fourth (1/4) of such item 13 14 of the budget made and published by it, except in cases of emergency. The clerk of any county is prohibited from issuing any 15 warrant contrary to the provisions of this section. No board of 16 17 supervisors nor any member thereof shall buy any machinery or equipment in the last six (6) months of their or his term unless 18 19 or until he has been elected at the general election of that year.
