## SENATE BILL NO. 2809

- AN ACT TO AMEND SECTION 37-173-1, 37-173-9 AND 37-173-21,
  MISSISSIPPI CODE OF 1972, TO EXPAND THE DYSLEXIA THERAPY
  SCHOLARSHIP FOR STUDENTS WITH DYSLEXIA PROGRAM BY MAKING CERTIFIED
  ACADEMIC LANGUAGE THERAPISTS (CALT) ELIGIBLE TO BE EMPLOYED BY
  SCHOOL DISTRICTS TO PROVIDE DYSLEXIA THERAPY SERVICES; TO AMEND
  SECTION 37-106-71, MISSISSIPPI CODE OF 1972, IN CONFORMITY TO THE
  PRECEDING PROVISIONS; AND FOR RELATED PURPOSES.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 37-173-1, Mississippi Code of 1972, is
- 10 amended as follows:
- 37-173-1. As used in this chapter, the following words and
- 12 phrases shall have the meanings ascribed in this section unless
- 13 the context clearly indicates otherwise:
- 14 (a) "Board" means the State Board of Education.
- 15 (b) "Department" means the State Department of
- 16 Education.
- 17 (c) "Dyslexia" means a specific learning disability
- 18 that is neurological in origin, characterized by difficulties with
- 19 accurate and fluent word recognition and poor spelling and
- 20 decoding abilities, which typically result from a deficit in the

- 22 relation to other cognitive abilities and the provision of
- 23 effective classroom instruction, and secondary consequences which
- 24 may include problems in reading comprehension and reduced reading
- 25 experience that can impede growth of vocabulary and background
- 26 knowledge.
- 27 (d) "Dyslexia therapy" means an appropriate specialized
- 28 dyslexia instructional program that is delivered by a Mississippi
- 29 Department of Education licensed dyslexia therapist or certified
- 30 academic language therapist, which is scientific, research-based,
- 31 Orton-Gillingham based, and is offered in a small group setting to
- 32 teach students the components of reading instruction which
- 33 include:
- 34 (i) Phonemic awareness to enable students to
- 35 detect, segment, blend and manipulate sounds in spoken language;
- 36 (ii) Graphophonemic knowledge (phonics) for
- 37 teaching the letter-sound plan of English;
- 38 (iii) The entire structure of the English language
- 39 that encompasses morphology, semantics, syntax and pragmatics;
- 40 (iv) Linquistic instruction directed toward
- 41 proficiency and fluency with the patterns of language so that
- 42 words and sentences are carriers of meaning; and
- 43 (v) Strategies that students use for decoding,
- 44 encoding, word recognition, fluency and comprehension.

45	These components shall be taught using instructional
46	approaches that include explicit, direct instruction which is
47	systematic, sequential and cumulative, following a logical plan of
48	presenting the alphabetic principle commensurate with the
49	students' needs, with no assumption of prior skills or language
50	knowledge; individualized to meet the specific learning needs of
51	each individual student in a small group setting; intensive,
52	highly concentrated instruction that maximizes student engagement
53	and uses specialized methods and materials; meaning-based
54	instruction directed toward purposeful reading and writing, with
55	an emphasis on comprehension and composition; and multisensory
56	instruction that incorporates the simultaneous use of two (2) or
57	more sensory pathways during teacher presentations and student
58	practice.

- 59 "Dyslexia therapist" means a professional who has 60 completed training in a department approved Orton-Gillingham based 61 dyslexia therapy training program attaining a AA license in 62 dyslexia therapy or a professional participating in a state 63 approved dyslexia therapy training program to attain a AA license 64 in dyslexia therapy.
- 65 "Mississippi Dyslexia Therapy Scholarship for Students with Dyslexia Program" means a scholarship to provide the 66 67 option to attend a public school other than the one to which assigned, or to provide a scholarship to a nonpublic school of 68 choice, for students in Grade 1 through Grade 12 diagnosed with 69

- 70 dyslexia in order to receive comprehensive multisensory dyslexia
- 71 therapy delivered by holders of an appropriate license in dyslexia
- 72 therapy issued by the department.
- 73 (g) "School" means any public or state accredited
- 74 nonpublic special purpose school that provides a specific learning
- 75 environment that provides comprehensive dyslexia therapy
- 76 instruction delivered by dyslexia therapists licensed by the
- 77 department providing highly qualified education and intervention
- 78 services to children diagnosed with the primary learning
- 79 disability of dyslexia.
- SECTION 2. Section 37-173-9, Mississippi Code of 1972, is
- 81 amended as follows:
- 37-173-9. (1) (a) The parent or legal guardian is not
- 83 required to accept the offer of enrolling in another public school
- 84 in lieu of requesting a Mississippi Dyslexia Therapy Scholarship
- 85 to a nonpublic school. However, if the parent or legal guardian
- 86 chooses the public school option, the student may continue
- 87 attending a public school chosen by the parent or legal guardian
- 88 until the student completes Grade 12.
- 89 (b) If the parent or legal guardian chooses a public
- 90 school within the district, the school district shall provide
- 91 transportation to the public school selected by the parent or
- 92 legal quardian. However, if the parent or legal quardian chooses
- 93 a public school in another district, the parent or legal guardian
- 94 is responsible to provide transportation to the school of choice.

- 95 These provisions do not prohibit a parent or legal guardian 96 of a student diagnosed with dyslexia, at any time, from choosing 97 the option of a Mississippi Dyslexia Therapy Scholarship which 98 would allow the student to attend another public school or 99 nonpublic special purpose school.
- 100 (2)If the parent or legal quardian chooses the nonpublic 101 school option and the student is accepted by the nonpublic school 102 pending the availability of a space for the student, the parent or 103 legal quardian of the student must notify the department thirty 104 (30) days before the first scholarship payment and before entering 105 the nonpublic school in order to be eligible for the scholarship 106 when a space becomes available for the student in the nonpublic 107 school.
- 108 The parent or legal guardian of a student may choose, as 109 an alternative, to enroll the student in and transport the student 110 to a public school in an adjacent school district which has 111 available space and has a program with dyslexia services that provide daily dyslexia therapy sessions delivered by a department 112 113 licensed dyslexia therapist or certified academic language 114 therapist, and that school district shall accept the student and 115 report the student for purposes of the district's funding under 116 the Mississippi Adequate Education Program.
- SECTION 3. Section 37-173-21, Mississippi Code of 1972, is amended as follows:

- 122 (a) Extend the school day or length of the scholastic

- 124 (b) Develop and establish a curriculum that is
- 125 consistent with the Mississippi Curriculum Framework in the
- 126 subject areas of mathematics, social studies, science, music, art
- 127 and physical education; and
- 128 (c) Select, purchase and use textbooks, literature and
- 129 other instructional materials that would improve educational
- 130 attainment by students in the school, subject to the approval of
- 131 the board.
- 132 (2) The qualified personnel to facilitate the educational
- 133 process of learning and instruction for children with dyslexia who
- 134 attend the schools shall consist of the following:
- 135 (a) An administrator or director with additional
- 136 training in the characteristics of dyslexia;
- 137 (b) A dyslexia therapist licensed by the department in
- 138 dyslexia therapy;
- 139 (c) Dyslexia therapists in training participating in a
- 140 department approved dyslexia therapy graduate internship program;

- SECTION 4. Section 37-106-71, Mississippi Code of 1972, is amended as follows:
- 37-106-71. (1) There is established the Mississippi
  148 Dyslexia Education Forgivable Loan Program for the purpose of
  149 identifying and recruiting qualified university and college
  150 students from the state for schooling in education with a focus on
  151 dyslexia therapy.
- 152 (2) The receipt of a forgivable loan under the program shall
  153 be solely limited to those students who are enrolled in or who
  154 have been accepted for enrollment into a master's degree program
  155 of study for dyslexia therapy at any public or private institution
  156 of higher learning within the State of Mississippi at the time an
  157 application for a forgivable loan is filed with the board.
  - (3) The annual amount of the forgivable loan award shall be equal to the total cost for tuition, materials and fees at the college or university in which the student is enrolled. Awards made to nonresidents of the state shall not include any amount assessed by the college or university for out-of-state tuition.
- 163 (4) Upon completion of the master's program and licensure
  164 requirements, a forgivable loan recipient who has not been
  165 previously licensed by the State Department of Education shall
  166 render service in an instructional or clinical capacity as a

- 167 licensed dyslexia therapist in a public school district in the
- 168 state or an eligible nonpublic school as defined by Section
- 169 37-173-1 and meets the criteria established in Section 37-173-17,
- 170 not to exceed five (5) recipients rendering instructional or
- 171 clinical services in a nonpublic school at any time.
- 172 (5) Repayment and conversion terms shall be the same as
- those outlined in Section 37-106-53.
- 174 (6) The board shall prepare and submit a report to the
- 175 Legislature by January 1, 2015, and annually thereafter, outlining
- 176 in detail the number of participants who have received forgivable
- 177 loans under the program, the record of service provided by those
- 178 recipients as they transition out of the degree program into the
- 179 public school districts of this state, and the projection for
- 180 expanding the program to include more participants annually as
- 181 determined by the need for such qualified professionals in the
- 182 public school setting. Additionally, the report shall include a
- 183 summary of allocations and expenditures for the administration of
- 184 the program and the total amount of funds issued to recipients of
- 185 forgivable loans from the inception of the program until such time
- 186 as the report has been prepared and submitted to the Legislature.
- 187 (7) The Mississippi Dyslexia Education Forgivable Loan
- 188 Program shall be administered in the same manner as the Critical
- 189 Needs Teacher Forgivable Loan Program established under Section
- 190 37-106-55 and shall be incorporated into the Critical Needs
- 191 Teacher Forgivable Loan Program for all purposes.

192	(8) Funding for the establishment and continued operation of
193	the Mississippi Dyslexia Education Forgivable Loan Program shall
194	be administered by the board through a special fund established
195	within the Critical Needs Teacher Forgivable Loan Program. The
196	board may accept and receive monetary gifts and donations from any
197	source, public or private, which such funds shall be deposited in
198	the special fund for the benefit of the Mississippi Dyslexia
199	Education Forgivable Loan Program with the Critical Needs Teacher
200	Forgivable Loan Program.

- 201 No more than twenty (20) students per cohort shall be 202 selected annually to be admitted into the program for receipt of 203 forgivable loans beginning with the 2013-2014 academic year. However, forgivable loans awarded under the program shall be 204 205 provided only to students who have been accepted into a Dyslexia 206 Therapy Master's Degree Cohort Program approved by the State Department of Education that provides instructional training as 207 208 required under Chapter 173, Title 37, Mississippi Code of 1972, 209 for dyslexia therapy in preparation of those cohort students for 210 AA licensure by the department.
- 211 As part of the Mississippi Dyslexia Education 212 Forgivable Loan Program, the State Department of Education is authorized and directed, subject to the availability of funds 213 specifically appropriated therefor by the Legislature, to provide 214 215 financial assistance for the recruitment, placement and employment of qualified licensed dyslexia therapy professionals identified 216

217	under Section 37-173-15(1)(b), Mississippi Code of 1972, in order
218	to provide dyslexia screening, evaluation and therapy services to
219	the students attending school in the school district. Said
220	funding may be used to purchase curriculum materials and supplies
221	for dyslexia therapy services. Said funding shall be provided to
222	public school districts upon application therefor regardless of
223	the financial need of the school district in an amount not to
224	exceed Fifty Thousand Dollars (\$50,000.00) annually, and subject
225	to specific appropriation therefor by the Legislature. In order
226	to qualify for such funds, the school district shall meet the
227	following criteria:

- 228 (a) Use licensed dyslexia therapists, certified

  229 <u>academic language therapist</u> or individuals participating in an

  230 approved training program resulting in State Department of

  231 Education licensure to provide dyslexia therapy to students

  232 diagnosed with dyslexia;
- 233 (b) Use daily Orton-Gillingham-based therapy;
- (c) Have school leadership trained in dyslexia; and
- 235 (d) Have a current School Program Verification and
- 236 Assurances form on file with the State Department of Education,
- 237 Office of Curriculum and Instruction. Procedures and standards
- 238 for the application for such funds shall be established by
- 239 regulations developed and issued by the State Board of Education.
- 240 **SECTION 5.** This act shall take effect and be in force from 241 and after July 1, 2023.
