- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** (1) **Short title.** This act shall be known and
- 6 may be cited as the Medical Freedom Act.
- 7 (2) **Scope.** This act relates to limitations on COVID-19
- 8 vaccine requirements.
- 9 (3) Findings and declarations. The Legislature finds and
- 10 declares that:
- 11 (a) Every resident in this state has the inalienable
- 12 right to bodily integrity and should be free from any threat or
- 13 compulsion that the individual must receive a vaccination;
- 14 (b) An individual who exercises the right not to
- 15 receive a COVID-19 vaccine shall not be denied any right or
- 16 privilege of citizenship; and
- 17 (c) Currently, this state allows for medical and
- 18 religious exemptions for immunizations and these rights should be

- 19 extended to all Mississippi residents who decline to receive a
- 20 COVID-19 vaccine.
- 21 (4) **Prohibitions.** The following prohibitions shall apply:
- 22 (a) The State of Mississippi or a political subdivision
- 23 of the state, or an agent thereof, shall not mandate that any
- 24 individual in this state receive a COVID-19 vaccination;
- 25 (b) A state agency or political subdivision shall not
- 26 enact or issue a rule, ordinance, order or any similar policy that
- 27 would result in an individual being required to submit to a
- 28 COVID-19 vaccination;
- 29 (c) A state agency or political subdivision, or an
- 30 agent thereof, shall not take any action which would result in an
- 31 individual being required to submit to a vaccination, including as
- 32 a condition of employment, access to education, the ability to
- 33 travel, entry to a public place or contracting with a state agency
- 34 or political subdivision;
- 35 (d) A vaccination offered by the state as part of a
- 36 mass vaccination effort may only be provided to individuals who
- 37 consent to receiving the vaccination, without coercion, after
- 38 receiving full information of all known ingredients, risks and
- 39 benefits prior to the vaccination;
- 40 (e) Employers shall not take any adverse employment
- 41 action against an individual who declines to receive a COVID-19
- 42 vaccination, including, but not limited to, termination,
- 43 suspension, involuntary reassignment, unpaid leave, demotion,

- 44 harassment or coercion. If an employer violates the provisions of
- 45 this paragraph, the aggrieved employee shall have the right to
- 46 apply for and receive unemployment benefits;
- 47 (f) An individual shall not be discriminated against,
- 48 denied entrance to or service from any establishment, denied the
- 49 ability to purchase goods or receive medical care or to
- 50 participate in any public organization for refusal to accept a
- 51 COVID-19 vaccination; and
- 52 (q) A citizen shall not be forced or coerced to sign a
- 53 COVID-19 vaccination declination waiver that is condemning,
- 54 self-incriminating or does not accurately express the citizen's
- 55 beliefs.
- 56 (5) **Notice.** If the state or a political subdivision, or an
- 57 agent thereof, recommends an individual receive a COVID-19
- 58 vaccination, the official or entity shall provide notice that the
- 59 recommendation is not mandatory in each oral or written statement
- 60 made.
- 61 **SECTION 2.** This act shall take effect and be in force from
- 62 and after its passage.
