1 AN ACT MAKING AN APPROPRIATION OF SPECIAL FUNDS TO DEFRAY THE 2 EXPENSES OF THE MISSISSIPPI DEPARTMENT OF EMPLOYMENT SECURITY FOR 3 FISCAL YEAR 2024. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4 5 SECTION 1. The following sum, or so much thereof as may be necessary, is appropriated out of any money in the State General 6 7 Fund not otherwise appropriated, for the purpose of defraying the expenses of the Mississippi Department of Employment Security for 8 9 the fiscal year beginning July 1, 2023, and ending June 30, 2024.....\$ 1,400,000.00. 10 11 SECTION 2. The following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the State 12 13 Treasury to the credit of the Mississippi Department of Employment 14 Security, or its successor, for the purpose of defraying the 15 expenses incurred by said department for the fiscal year beginning July 1, 2023, and ending June 30, 2024.....\$ 156,198,117.00. 16 17 SECTION 3. Of the funds appropriated under the provisions of 18 this act, the following positions are authorized:

22 With the funds herein appropriated, it shall be the agency's 23 responsibility to make certain that funds required for Personal 24 Services for Fiscal Year 2025 do not exceed Fiscal Year 2024 funds appropriated for that purpose unless programs or positions are 25 26 added to the agency's Fiscal Year 2024 budget by the Mississippi 27 Legislature. The Legislature shall determine the agency's personal services appropriation, which shall be published by the 28 29 State Personnel Board. Additionally, the State Personnel Board 30 shall determine and publish the projected annualized payroll costs 31 based on current employees. It shall be the responsibility of the 32 agency head to ensure that actual personnel expenditures for 33 Fiscal Year 2024 do not exceed the data provided by the Legislative Budget Office. If the agency's Fiscal Year 2024 34 35 projected cost exceeds the annualized costs, no salary actions shall be processed by the State Personnel Board with the exception 36 37 of new hires that are determined to be essential for the agency. 38 Any transfers or escalations shall be made in accordance with 39 the terms, conditions and procedures established by law or

allowable under the terms set forth within this act. The State
Personnel Board shall not escalate positions without written
approval from the Department of Finance and Administration. The
Department of Finance and Administration shall not provide written

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

51 None of the funds herein appropriated shall be used in 52 violation of Internal Revenue Service's Publication 15-A relating 53 to the reporting of income paid to contract employees, as 54 interpreted by the Office of the State Auditor.

55 Funds have been appropriated herein for the purpose of 56 funding Project SEC2 minimum salaries for all employees covered 57 under the Colonel Guy Groff/Neville Kenning Variable Compensation 58 Plan. It shall be the agency's responsibility to ensure that the 59 funds are used to increase all employees' salaries up to the 60 minimum level as determined by the State Personnel Board.

SECTION 4. Of the funds appropriated under the provisions of 61 62 Section 2 of this act, the following sum shall be derived from 63 money in the Unemployment Trust Fund, made available to this state 64 under Section 903 of the Social Security Act, as amended (42 USCA 65 Section 1103), to the Mississippi Department of Employment Security to be deposited in the Employment Security Administration 66 67 Fund and used by the Mississippi Department of Employment Security 68 for the following purposes:

It is the intention of the Legislature that 118 whenever two (2) or more bids are received by this agency for the purchase of commodities or equipment, and whenever all things 119 120 stated in such received bids are equal with respect to price, 121 quality and service, the Mississippi Industries for the Blind 122 shall be given preference. A similar preference shall be given to 123 the Mississippi Industries for the Blind whenever purchases are 124 made without competitive bids.

SECTION 6. Of the funds appropriated in Section 2 of this act, the Mississippi Department of Employment Security is authorized to expend up to Three Million Dollars (\$3,000,000.00) from the State Workforce Investment Funds for the State Workforce Investment Board, collected pursuant to Section 71-5-353, Mississippi Code of 1972.

SECTION 7. Of the funds appropriated in this act, a sum not to exceed Two Hundred Thousand Dollars (\$200,000.00) is made available for Pathways2Possibilities from the Mississippi Works Fund collected pursuant to Section 71-5-353, Mississippi Code of 135 1972.

SECTION 8. Of the funds appropriated under the provisions of Section 2 of this act, the Mississippi Department of Employment Security is authorized to expend up to Fifteen Million Dollars (\$15,000,000.00) from the Mississippi Works Fund collected pursuant to Section 71-5-353, Mississippi Code of 1972.

Of the funds appropriated in Section 1 of this 142 act, an amount not to exceed One Million Four Hundred Thousand 143 Dollars (\$1,400,000.00) is authorized for the Mississippi 144 Integrated Education and Workforce State Longitudinal Data System 145 (SLDS).

SECTION 10. It is the intention of the Legislature that the funds herein appropriated shall be expended in compliance with Section 27-104-25, Mississippi Code of 1972, that no state agency shall incur obligations or indebtedness in excess of their appropriation and that the responsible officers, either personally or upon their official bonds, shall be held responsible for actions contrary to this provision.

153 The money herein appropriated shall be paid by SECTION 11. 154 the State Treasurer out of any money in the State Treasury to the 155 credit of the proper fund or funds as set forth in this act, upon 156 warrants issued by the State Fiscal Officer; and the State Fiscal 157 Officer shall issue his warrants upon requisitions signed by the 158 proper person, officer or officers, in the manner provided by law. 159 SECTION 12. This act shall take effect and be in force from 160 and after July 1, 2023, and shall stand repealed from and after 161 June 30, 2023.
