1 AN ACT MAKING AN APPROPRIATION TO DEFRAY THE EXPENSES OF THE 2 MISSISSIPPI WORKERS' COMPENSATION COMMISSION FOR FISCAL YEAR 2024. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. The following sum, or so much thereof as may be 4 5 necessary, is hereby appropriated out of any money in the State 6 General Fund not otherwise appropriated, for the purpose of defraying the expenses incurred by the Mississippi Workers' 7 8 Compensation Commission for the fiscal year beginning July 1, 2023, and ending June 30, 2024.....\$ 5,602,900.00. 9 10 SECTION 2. The following sum, or so much thereof as may be 11 necessary, is hereby appropriated out of any money in the State Treasury to the credit of the Second Injury Fund (Fund Number 12 13 3352300000) for the purpose of making payments under the 14 provisions of Section 71-3-73, Mississippi Code of 1972, for the fiscal year beginning July 1, 2023, and ending June 30, 2024..... 15 \$ 16 50,000.00. 17 SECTION 3. With the funds appropriated in Section 1 of this 18 act, the following positions are authorized:

22 With the funds herein appropriated, it shall be the agency's 23 responsibility to make certain that funds required for Personal 24 Services for Fiscal Year 2025 do not exceed Fiscal Year 2024 funds appropriated for that purpose unless programs or positions are 25 26 added to the agency's Fiscal Year 2024 budget by the Mississippi 27 Legislature. The Legislature shall determine the agency's personal services appropriation, which shall be published by the 28 29 State Personnel Board. Additionally, the State Personnel Board 30 shall determine and publish the projected annualized payroll costs 31 based on current employees. It shall be the responsibility of the 32 agency head to ensure that actual personnel expenditures for 33 Fiscal Year 2024 do not exceed the data provided by the Legislative Budget Office. If the agency's Fiscal Year 2024 34 35 projected cost exceeds the annualized costs, no salary actions shall be processed by the State Personnel Board with the exception 36 37 of new hires that are determined to be essential for the agency. 38 Any transfers or escalations shall be made in accordance with 39 the terms, conditions and procedures established by law or

40 allowable under the terms set forth within this act. The State 41 Personnel Board shall not escalate positions without written 42 approval from the Department of Finance and Administration. The 43 Department of Finance and Administration shall not provide written

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

51 None of the funds herein appropriated shall be used in 52 violation of Internal Revenue Service's Publication 15-A relating 53 to the reporting of income paid to contract employees, as 54 interpreted by the Office of the State Auditor.

Funds have been appropriated herein for the purpose of funding Project SEC2 minimum salaries for all employees covered under the Colonel Guy Groff/Neville Kenning Variable Compensation Plan. It shall be the agency's responsibility to ensure that the funds are used to increase all employees' salaries up to the minimum level as determined by the State Personnel Board.

61 SECTION 4. It is the intention of the Legislature that with 62 the funds appropriated in Section 1 of this act, the Mississippi 63 Workers' Compensation Commission shall enter into a contract with 64 the industrial private sector for the purpose of implementing a 65 safety education and training program.

66 SECTION 5. In compliance with the "Mississippi Performance 67 Budget and Strategic Planning Act of 1994," it is the intent of 68 the Legislature that the funds provided herein shall be utilized

107 **SECTION 6.** It is the intention of the Legislature that whenever two (2) or more bids are received by this agency for the 108 109 purchase of commodities or equipment, and whenever all things 110 stated in such received bids are equal with respect to price, quality and service, the Mississippi Industries for the Blind 111 112 shall be given preference. A similar preference shall be given to 113 the Mississippi Industries for the Blind whenever purchases are 114 made without competitive bids.

115 **SECTION 7.** It is the intention of the Legislature that the 116 salary of the Workers' Compensation Commission members shall be 117 equal and the salary of the commission chairman shall exceed these 118 salaries as approved by the State Personnel Board.

It is the intention of the Legislature that the 120 funds herein appropriated shall be expended in compliance with 121 Section 27-104-25, Mississippi Code of 1972, that no state agency 122 shall incur obligations or indebtedness in excess of their 123 appropriation and that the responsible officers, either personally 124 or upon their official bonds, shall be held responsible for 125 actions contrary to this provision.

126 SECTION 9. The following sum, or so much thereof as may be 127 necessary, is reappropriated out of any money in the Capital 128 Expense Fund not otherwise appropriated for the Mississippi 129 Workers' Compensation Commission for the purpose of reauthorizing 130 the expenditure of Capital Expense Fund, as appropriated in SB 3026, 2022 Regular Session, for repairs and renovations for the 131 132 fiscal year beginning July 1, 2023, and ending June 30, 2024..... 133\$ 75,000.00.

Notwithstanding the amount reappropriated under this section, the amount that may be expended under the authority of this section as of June 30, 2023, shall not exceed the unexpended balance of the funds remaining from the amount authorized for the previous fiscal year.

139 SECTION 10. The money herein appropriated shall be paid by 140 the State Treasurer out of any money in the State Treasury to the 141 credit of the proper fund or funds as set forth in this act, upon 142 warrants issued by the State Fiscal Officer; and the State Fiscal

SECTION 11. This act shall take effect and be in force from and after July 1, 2023, and shall stand repealed from and after June 30, 2023.
