- 3 ASSOCIATION, BRIGADIER GENERAL SAM FORBERT, JR., OF MERIDIAN
- 4 MISSISSIPPI, COMMENDING HIS MILITARY SERVICE AND EXTENDING
- 5 CONDOLENCES TO HIS SURVIVING FAMILY.
- 6 WHEREAS, Mississippi has lost a military hero and
- 7 distinguished member of the "Greatest Generation". Brigadier
- 8 General Sam Forbert, Jr., 99, passed away on December 29, 2022;
- 9 and
- 10 WHEREAS, General Forbert, of Meridian, Mississippi, was born
- 11 February 13, 1923, in New Orleans, Louisiana. After high school
- 12 graduation, he attended Mississippi State University, studying
- 13 Aeronautical Engineering. He enlisted in the United States Air
- 14 Force at this time, where he completed his training and flew P-51s
- 15 in World War II. He was called to active duty with the
- 16 Mississippi Air Guard for the Korean War, where he was a pilot
- 17 with the 18th Fighter-Bomber Group; and

- 18 WHEREAS, he was named Wing Commander of the 186th Tactical
- 19 Reconnaissance Group on Key Field Air National Guard Base in
- 20 Meridian, Mississippi, from 1970-1978; and
- 21 WHEREAS, he was Past President of the Mississippi National
- 22 Guard Association and was appointed by Governor Haley Barbour to
- 23 serve on the Veteran Home Purchase Board from 2003-2008; and
- 24 WHEREAS, his love of flight and his knowledge of military
- 25 aircraft was present throughout his military career and was used
- 26 to teach flight as well as encourage many servicemen and women who
- 27 found Meridian their temporary home. He was an active presence at
- 28 Key Field and NAS; and
- 29 WHEREAS, after his retirement in the military, General
- 30 Forbert maintained his private business as an Insurance Agent for
- 31 Penn Mutual Life Insurance Company in Meridian, Mississippi. He
- 32 was a member of First Baptist Church Meridian and the Downtown
- 33 Rotary Club in Meridian. He enjoyed the outdoors and was an avid
- 34 hunter and fisherman; and
- 35 WHEREAS, he was preceded in death by his wife, Aline Adams
- 36 Forbert; his parents, Sam and Garnet Forbert; his
- 37 great-granddaughter, Allie Carruth and grandson-in-law, Joseph
- 38 Sanders. He is survived by his children, Steve Forbert (Diane),
- 39 Charles Forbert and Lisa Forbert; his grandchildren: Albree Florey
- 40 (Scotty), Leslie Carruth (Bill), Sam Forbert (Rachel), David
- 41 Forbert (Leah) and Katherine Forbert; his great-grandchildren:
