SENATE CONCURRENT RESOLUTION NO. 555

- A CONCURRENT RESOLUTION MOURNING THE PASSING AND COMMENDING THE LIFE AND CIVIC CONTRIBUTIONS OF BUSINESSMAN WIRT ADAMS YERGER,
- 3 JR., OF JACKSON, MISSISSIPPI, AND RECOGNIZING HIS LEADERSHIP IN
- 4 THE POLITICAL HISTORY OF OUR STATE.
- 5 WHEREAS, we extend the deep and heartfelt sympathy of the
- 6 Legislature on the passing of Wirt Adams Yerger, Jr., of Jackson,
- 7 Mississippi, on May 2, 2022; and
- 8 WHEREAS, a native of Jackson, Wirt was born on March 18,
- 9 1930, the son of the late Rivers Applewhite Yerger and Wirt Adams
- 10 Yerger. He was educated in the Jackson Public Schools and became
- 11 an Eagle Scout at age fifteen. Wirt received a Bachelor of
- 12 Business Administration Degree from the University of Mississippi,
- 13 where he was a member of Kappa Alpha fraternity; and
- 14 WHEREAS, from 1952 to 1954 he served as First Lieutenant in
- 15 the United States Air Force's Strategic Air Command. In 1956, he
- 16 married Mary Polk Montague of Hattiesburg; and
- 17 WHEREAS, in 1954 Wirt joined Ross & Yerger, Inc.,
- 18 Mississippi's first insurance agency, founded in 1860. During his
- 19 forty-eight years of leadership, the agency grew from three to

- 20 fifty-three employees. In February 2002, Ross & Yerger became
- 21 employee-owned, and Wirt continued to serve as Chairman Emeritus;
- 22 and
- 23 WHEREAS, he was the first insurance agent in Mississippi to
- 24 hold both the CPCU and CLU designations and was the first
- 25 Mississippian invited to be an Underwriting Name at Lloyd's of
- 26 London. He also served as President of the Mississippi
- 27 Association of Insurance Agents; and
- 28 WHEREAS, Wirt gave unselfishly and generously to his
- 29 community. He was a past President of Metropolitan Boys Club,
- 30 Metropolitan YMCA and Jackson Rotary Club; and
- 31 WHEREAS, he received the Jackson Junior Chamber of Commerce
- 32 Distinguished Service Award in 1956 and 1960. He founded both the
- 33 Metropolitan Crime Commission and Fondren Renaissance Foundation;
- 34 and
- 35 WHEREAS, he was a former Director of the Jackson Chamber of
- 36 Commerce, the Mississippi Insurance Council, and the Community
- 37 Foundation for Mississippi, establishing one of their first donor
- 38 advised funds; and
- 39 WHEREAS, he was a founding trustee of Jackson Preparatory
- 40 School and a member of First Presbyterian Church, where he served
- 41 as a Deacon; and
- WHEREAS, Wirt was the leader in establishing the Republican
- 43 Party in Mississippi, serving as State Chairman of the Mississippi

- 44 Republican Party from 1956 until 1966. He was also Chairman of
- 45 the Southern Association of Republican State Chairmen; and
- 46 WHEREAS, in May of 2009 he was honored as Mississippi
- 47 Republican Party Chairman Emeritus for his work in building a
- 48 two-party political system in Mississippi. He ended his speech
- 49 with these words, "The best advice I give to you is always choose
- 50 principles over pragmatism and power. Standing on principles is
- 51 not easy, you get tired and discouraged, but the satisfaction of
- 52 accomplishing all you can for a better nation is worth it all";
- 53 and
- 54 WHEREAS, Wirt's greatest reward was being a husband, father,
- 55 grandfather, great-grandfather and brother. He built special and
- 56 everlasting relationships with each member of his family
- 57 throughout their lives. Wirt unselfishly gave of his time,
- 58 talents, resources and love, not only to his family, but to many
- 59 friends in all walks of life; and
- 60 WHEREAS, he is survived by his wife Mary Montague Yerger of
- 61 Jackson, Mississippi; son Wirt Adams Yerger, III, (Linda Biggers
- 62 Yerger); daughter, Mary Yerger Dunbar (Thomas Tarver Dunbar); son,
- 63 Frank Montague Yerger (Jane Prater Yerger); granddaughters, Mary
- 64 Montague Dunbar and Sarah Jane Rivers Yerger; grandsons: Wirt
- 65 Adams Yerger, IV, (Jordan Jones Yerger), James David Yerger
- 66 (Natalie Sink Yerger), Richard Montague Yerger (Rachael Hardin
- 67 Yerger), John Taylor Yerger (Lauren Meyer Yerger), Thomas Yerger
- 68 Dunbar, Wirt Yerger Dunbar, Frank Montague Yerger, Jr., and Harlan

- 75 WHEREAS, we pay tribute and cherish fondly the memory of this
- 76 most public spirited citizen of Mississippi whose enormous civic
- 77 energy is a record of achievement and legacy of leadership in the
- 78 state he loved:
- 79 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 80 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 81 we do hereby mourn the passing and commend the life and civic
- 82 contributions of businessman Wirt Adams Yerger, Jr., of Jackson,
- 83 Mississippi, and recognize his leadership in the political history
- 84 of our state.
- 85 BE IT FURTHER RESOLVED, That this resolution be presented on
- 86 this day to the surviving family of Wirt Yerger, forwarded to the
- 87 Mississippi Association of Insurance Agents, the Jackson Chamber
- 88 of Commerce and the Jackson Rotary Club and be made available to
- 89 the Capitol Press Corps.
