## SENATE CONCURRENT RESOLUTION NO. 564

- A CONCURRENT RESOLUTION TO DESIGNATE MARCH 2023 AS "BRAIN INJURY AWARENESS MONTH IN MISSISSIPPI" TO PROMOTE AWARENESS OF THE EXTENT, CONSEQUENCES, CAUSES, TREATMENTS AND PREVENTION OF ACQUIRED BRAIN INJURIES.
- 5 WHEREAS, acquired brain injury is often overlooked and
- 6 underfunded, and affects thousands of Mississippians each year;
- 7 and
- 8 WHEREAS, a traumatic brain injury (TBI) is caused by a bump,
- 9 blow, or jolt to, or penetration of, the head that disrupts the
- 10 normal function of the brain; and
- 11 WHEREAS, more than 30,000 Mississippians are currently living
- 12 with the long-term effects of a brain injury; and
- 13 WHEREAS, falls are the leading cause of brain-related
- 14 injuries in Mississippi. Brain injuries can also be caused by
- 15 motor vehicle crashes, assaults, sports-related injuries,
- 16 occupational-related injuries, or opioid overdoses; and
- WHEREAS, Mississippi has more than 30,000 active military
- 18 personnel and has over 190,000 veterans residing in the state; and

- 19 WHEREAS, traumatic brain injury has been the signature injury 20 of wars in Iraq and Afghanistan, treatment is often complicated by
- 21 high rates of PTSD and suicide, presenting new challenges for
- 22 members of the military and their families in the state; and
- 23 WHEREAS, thirty percent of sports-related injuries happen
- 24 among youth five to 19 years of age, and because the signs of
- 25 brain injury are not always well recognized, youth may put
- 26 themselves at risk for another injury and potentially fatal
- 27 second-impact syndrome; and
- 28 WHEREAS, it is estimated that between 1.6-3.8 million mild
- 29 traumatic brain injuries, often called concussions, occur in the
- 30 United States per year during competitive sports and recreational
- 31 activities; and
- 32 WHEREAS, as many as 50% of mild traumatic brain injuries go
- 33 unreported or undetected; and
- 34 WHEREAS, an injury that happens in an instant can bring a
- 35 lifetime of physical, cognitive, and behavioral challenges; and
- 36 WHEREAS, early and adequate intervention, especially
- 37 cognitive rehabilitation, will greatly increase the quality of
- 38 life and enable individuals with brain injury to return to home,
- 39 school, work or their communities; and
- 40 WHEREAS, March has been designated as National Brain Injury
- 41 Awareness Month to promote awareness of the extent, consequences,
- 42 causes, treatments and prevention of acquired brain injuries; and
