11 Supreme Court Advisory Committee on Civil Rules from 2010-2022;

13 WHEREAS, Judge Primeaux was Chair for the Mississippi
14 Conference of Chancery Judges from 2018-2019; and

15 WHEREAS, Judge Primeaux was a member of the Mississippi
16 Commission on Guardianships and Conservatorships, which drafted
17 the legislation that became the Guard and Protect (GAP) Act; and



18 WHEREAS, Judge Primeaux authored the widely read *Better*
19 *Chancery Practice Blog* between 2010-2020; and

20 WHEREAS, Judge Primeaux has been married to Lisa M. Primeaux,
21 a retired register nurse, for 51 years, and they have three
22 children and two grandchildren; and

23 WHEREAS, Chancellor Primeaux served as a leader and mentor.
24 He consistently lectured on professional standards of the
25 practice, including ethics, integrity, civility, courtesy and
26 adherence to the Golden Rule. His practice honored both The
27 Mississippi Bar and this great state that he loved and served:
