- 4 WHEREAS, District 21 State Senator Barbara Blackmon has
- 5 announced that she will not be seeking reelection to the
- 6 Mississippi Senate. She has represented Senate District 21, which
- 7 includes portions of Attala, Holmes, Leake, Madison and Yazoo
- 8 Counties, since 2016. She previously served in the Mississippi
- 9 Senate from 1992 to 2004, and again from 2016 to 2023. In Barbara
- 10 Blackmon, the citizens of District 21 have had effective
- 11 representation from a dedicated public servant with extensive
- 12 experience in the practice of law; and
- 13 WHEREAS, Senator Blackmon is proud of her accomplishments in
- 14 the Legislature, and said she has always enjoyed working in the
- 15 Senate; and
- 16 WHEREAS, Senator Blackmon graduated from Jackson State
- 17 University, B.S. Business Administration; University of Alabama

- 18 M.B.A.; University of Mississippi, Juris Doctorate; and New York
- 19 University, L.L.M. (Taxation); and
- 20 WHEREAS, Senator Blackmon is an attorney and is a member of
- 21 The Mississippi State Bar, New York State Bar, Magnolia Bar
- 22 Association and Life Member of the NAACP; and
- 23 WHEREAS, as a State Senator, Senator Blackmon worked to
- 24 increase funding for all of Mississippi's state colleges and
- 25 universities. She supported the Mississippi Adequate Education
- 26 Program to provide equity to poorer school districts and was a
- 27 champion for senior citizens and children by being a strong and
- 28 effective voice for sound health care policies. Lieutenant
- 29 Governor Eddie Briggs recognized Barbara's vast business and legal
- 30 capacity and because of her significant business background,
- 31 Senator Blackmon was appointed to the Senate Finance Committee
- 32 where as a new Senator she was appointed Vice Chair where she
- 33 advocated for more economic development in the poorer areas of the
- 34 state as well as record construction investments at Mississippi's
- 35 universities and junior colleges. Lieutenant Governor Eddie
- 36 Briggs, also appointed Barbara to the Legislative Budget
- 37 Committee, and she was the first female ever appointed to the
- 38 committee from the State Senate. The committee sets the state's
- 39 budget prior to the Legislature convening. Barbara Blackmon was
- 40 the first African American in the Senate to be appointed to a
- 41 subcommittee chair on the Appropriations Committee where she
- 42 oversaw over \$350 Million in agency budgets; and

- WHEREAS, Senator Blackmon served as President of the National
- 44 Black Caucus of States Institute, a public policy think tank which
- 45 developed parallel to the National Black Caucus of State
- 46 Legislators from 2002-2010. She is a former Co-Chair of the
- 47 National Campaign for Jackson State University's \$50 Million
- 48 Campaign for scholarships, endowments and programs and served on
- 49 the Board of Directors for the Jackson State University
- 50 Foundation. She served on the Steering Committee for the B.B.
- 51 King Museum in Indianola, Mississippi. She has served on the
- 52 Board of Directors of the United Way of the Capitol Area, the Boys
- 53 and Girls Club of Central Mississippi, the Stewpot of Canton, the
- 54 American Red Cross Central Mississippi Chapter and as President of
- 55 the Foundation for Education and Economic Development among other
- 56 community and professional associations. Barbara and her husband,
- 57 Representative Edward Blackmon, Jr., received an award for Black
- 58 Philanthropy for having given \$1,000,000.00 to Tougaloo College,
- 59 \$750,000.00 to Jackson State University, and providing
- 60 scholarships and awards to 53 students; and
- 61 WHEREAS, at the beginning of the 2023 Regular Session,
- 62 Senator Blackmon served on the following committees: Housing,
- 63 Chair; Highways and Transportation, Vice-Chair; Finance;
- 64 Insurance; Judiciary, Division A; Local and Private; Medicaid; and
- 65 Public Health and Welfare; and
