- 451 Dollars (\$15,058,000.00) shall be used for the Educable Child
- 452 Program. It is the intention of the Legislature that the State
- 453 Board of Education shall allocate funding for the Educable Child
- 454 Program based upon a recalculated formula in a manner to include
- 455 only those billable days funded through appropriation of state
- 456 funds and not District funds. It is the intent of the Legislature
- 457 that the Educable Child funds shall be exempt from budget cuts
- 458 made to the Department of Education by the Legislature and/or the
- 459 Office of the Governor.
- SECTION 23. Of the funds appropriated in Section 1(a) and
- 461 Section 4(a), not less than Three Million Dollars (\$3,000,000.00)
- 462 shall be used for the Education Scholarship Account (ESA) Program.
- 463 It is the intent of the Legislature that the Education Scholarship

- Account (ESA) funds shall not be reduced by the State Department of Education and/or the Office of the Governor.
- 466 The public school districts of the state are SECTION 24. 467 authorized at their discretion to pay with local funds one hundred 468 percent (100%) of the cost of the health insurance premiums of the 469 State and School Employees Health Insurance Plan for all retired 470 members of the Public Employees' Retirement System who are 471 employed as school bus drivers by the school districts. It is the 472 intention of the Legislature that no state funds shall be used for 473 this purpose.
- 474 SECTION 25. - SECTION 26. Of the funds appropriated in Section 1, not less
 than Six Million Four Hundred Fourteen Thousand Eight Hundred
 Ninety-eight Dollars (\$6,414,898.00) shall be used for the
 Compulsory School Attendance Office and School Attendance
 Officers.
- 487 **SECTION 27.** Of the funds appropriated in this act, it is the intention of the Legislature that Three Million Sixty Thousand

- 489 Dollars (\$3,060,000.00) shall be used for the Mary
- 490 Kirkpatrick-Mary Sprayberry Public School Nurse Program. The
- 491 amount of Three Million Sixty Thousand Dollars (\$3,060,000.00) is

- 522 Assistance Fund as outlined in Section 37-17-6, Mississippi Code
- 523 of 1972, during the period beginning July 1, 2023, and ending
- 524 June 30, 2024. The school districts receiving these loans shall
- 525 repay the Mississippi Department of Education the amount of the
- 526 loan on or before June 30, 2024.
- 527 **SECTION 32.** Of the funds appropriated in Section 1(a), Seven
- 528 Hundred Thousand Dollars (\$700,000.00) shall be transferred to the
- 529 Board of Health no later than December 31, 2023.
- 530 **SECTION 33.** Any school district receiving funds through Save
- 531 the Children may provide a ten percent (10%) match from local
- 532 funds for implementation of the program.
- 533 **SECTION 34.** Of the funds appropriated in Section 1(a), Two
- 534 Million Dollars (\$2,000,000.00) is provided for the Mississippi
- 535 Community Oriented Policing Services in Schools (MCOPS) grant
- 536 program. A portion of these funds not to exceed one percent (1%)
- 537 may be used for training and administrative costs related to
- 538 oversight and auditing of the program.

539	SECTION 35. Of the funds appropriated in Section 1(a) and
540	Section 2(a), Twenty-four Million Dollars (\$24,000,000.00) is
541	provided for an Early Childhood Education Initiative program. The
542	funding shall be provided to early learning collaboratives in
543	Fiscal Year 2024 as follows: no less than Two Thousand Five
544	Hundred Dollars (\$2,500.00) per student in a full-day program and
545	no less than One Thousand Two Hundred Fifty Dollars (\$1,250.00)
546	per student in a half-day program. Funds must be matched as
547	provided by Section 37-21-51, Mississippi Code of 1972.
548	SECTION 36. Of the funds appropriated in Section 1(a) and
549	Section 4(a), Fifteen Million Ninety-four Thousand Five Hundred
550	Dollars (\$15,094,500.00) shall be used for the Literacy Initiative
551	and Assessment and monitoring and evaluating the adoption and
552	implementation of high-quality instructional materials that have
553	been reviewed through the approved state process and distributed
554	through regional textbook depository as outlined in Section
555	37-43-23, Mississippi Code of 1972.
556	SECTION 37. Of the funds appropriated herein, funding is
557	provided for the ACT test, which is the college readiness portion
558	of the state accountability model.
559	SECTION 38. Of the funds appropriated in Section 1(a), Two
560	Million Seven Hundred Twenty-one Thousand Eighty-three Dollars
561	(\$2,721,083.00) shall be used for the Mississippi School of the
562	Arts and Three Million Nine Hundred Ninety Thousand Eighty-eight
