

House Amendments to Senate Bill No. 2309

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

10 **SECTION 1.** Section 1, Chapter 393, Laws of 2014, as amended
11 by Section 1, Chapter 443, Laws of 2022 is amended as follows:
12 Section 1. (1) The Department of Finance and
13 Administration, acting on behalf of the Mississippi Department of
14 Archives and History, is authorized to donate to the * * * United
15 States Department of the Interior, National Park Service,
16 Vicksburg National Military Park all the rights, title and
17 interest in certain real property under the possession and control
18 of the Department of Archives and History, located in the Second
19 Judicial District of Hinds County, Mississippi, subject to the
20 requirements and conditions prescribed in subsection (3) of this
21 section. Upon completing a field survey, the Department of
22 Finance and Administration, acting on behalf of the Mississippi
23 Department of Archives and History, is authorized to develop a
24 legal description and file necessary deeds to exclude a
25 two-hundred-foot buffer to extend southerly from the existing
26 south right-of-way line of the railroad property, thereby forming

27 the north line of the National Park Service property at the
28 Champion Hill Battlefield property described below, and to
29 describe an access corridor to be retained by the Mississippi
30 Department of Archives and History. The purpose of this boundary
31 line is to identify ownership and to assist in carrying out future
32 park operations and maintenance. The property is more
