

**House Amendments to Senate Bill No. 3025**

**TO THE SECRETARY OF THE SENATE:**

**THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:**

**AMENDMENT NO. 1**

**Amend by striking all after the enacting clause and inserting in lieu thereof the following:**

4           **SECTION 1.** The following sum, or so much thereof as may be  
5 necessary, is hereby appropriated out of any money in the State  
6 General Fund not otherwise appropriated, for the support and  
7 maintenance of the Department of Mental Health for the fiscal year  
8 beginning July 1, 2023, and ending June 30, 2024.....  
9 .....\$     222,160,008.00.

10           **SECTION 2.** The following sum, or so much thereof as may be  
11 necessary, is hereby authorized for expenditure out of any special  
12 source funds which are collected by or otherwise become available  
13 for the support and maintenance of the Department of Mental Health  
14 for the fiscal year beginning July 1, 2023, and ending  
15 June 30, 2024.....\$     422,651,516.00.

16           **SECTION 3.** Of the funds appropriated under the provisions of  
17 Section 2 of this act, Eighteen Million Nine Hundred Fifty-one  
18 Thousand Eight Hundred Eighty-six Dollars (\$18,951,886.00) shall  
19 be derived from the Health Care Expendable Fund created in Section  
20 43-13-407, Mississippi Code of 1972, for the support and

21 maintenance of the Department of Mental Health. The funds  
22 provided for in this section shall be allocated as follows:

33 **SECTION 4.** Of the funds appropriated under the provisions of  
34 Sections 1 and 2 of this act, the following positions are  
35 authorized:

36 AUTHORIZED HEADCOUNT:

37 Permanent: 6,299

38 Time-Limited: 457

39 With the funds herein appropriated, it shall be the agency's  
40 responsibility to make certain that funds required for Personal  
41 Services for Fiscal Year 2025 do not exceed Fiscal Year 2024 funds  
42 appropriated for that purpose unless programs or positions are  
43 added to the agency's Fiscal Year 2024 budget by the Mississippi  
44 Legislature. The Legislature shall determine the agency's  
45 personal services appropriation, which shall be published by the  
46 State Personnel Board. Additionally, the State Personnel Board

47 shall determine and publish the projected annualized payroll costs  
48 based on current employees. It shall be the responsibility of the  
49 agency head to ensure that actual personnel expenditures for  
50 Fiscal Year 2024 do not exceed the data provided by the  
51 Legislative Budget Office. If the agency's Fiscal Year 2024  
52 projected cost exceeds the annualized costs, no salary actions  
53 shall be processed by the State Personnel Board with the exception  
54 of new hires that are determined to be essential for the agency.

55 Any transfers or escalations shall be made in accordance with  
56 the terms, conditions and procedures established by law or  
57 allowable under the terms set forth within this act. The State  
58 Personnel Board shall not escalate positions without written  
59 approval from the Department of Finance and Administration. The  
60 Department of Finance and Administration shall not provide written  
61 approval to escalate any funds for salaries and/or positions  
62 without proof of availability of new or additional funds above the  
63 appropriated level.

64 No general funds authorized to be expended herein shall be  
65 used to replace federal funds and/or other special funds which are  
66 being used for salaries authorized under the provisions of this  
67 act and which are withdrawn and no longer available.

68 None of the funds herein appropriated shall be used in  
69 violation of Internal Revenue Service's Publication 15-A relating  
70 to the reporting of income paid to contract employees, as  
71 interpreted by the Office of the State Auditor.

72 Funds have been appropriated herein for the purpose of  
73 funding Project SEC2 minimum salaries for all employees covered  
74 under the Colonel Guy Groff/Neville Kenning Variable Compensation  
75 Plan. It shall be the agency's responsibility to ensure that the  
76 funds are used to increase all employees' salaries up to the  
77 minimum level as determined by the State Personnel Board.

78 The Department of Mental Health (DMH) is authorized to grant  
79 temporary COVID-19 adjustments to the compensation for employees  
80 in the following occupational title: Nurse Licensed Practical I,  
81 II and III; Nurse I, II, III and IV; Nurse Manager; Nurse  
82 Administrator; Nurse Chief; and for those employees who function  
83 as a nurse and are already classified in their new nurse titles as  
84 part of Project SEC2. Authority is provided for an increase of up  
85 to seventy-five percent (75%) temporary COVID adjustment pay for  
86 Fiscal Year 2024.

87 **SECTION 5.** In compliance with the "Mississippi Performance  
88 Budget and Strategic Planning Act of 1994," it is the intent of  
89 the Legislature that the funds provided herein shall be utilized  
90 in the most efficient and effective manner possible to achieve the  
91 intended mission of this agency. Based on the funding authorized,  
92 this agency shall make every effort to attain the targeted  
93 performance measures provided below:

188 A reporting of the degree to which the performance targets  
189 set above have been or are being achieved shall be provided in the  
190 agency's budget request submitted to the Joint Legislative Budget  
191 Committee for Fiscal Year 2025.

192         **SECTION 6.** The Department of Mental Health and its  
193 facilities shall have the authority, within funding and spending  
194 authority appropriated under the provisions of this act to  
195 transfer funds to the Division of Medicaid in payment of Medicaid  
196 match and designate that the funds thus transferred shall be  
197 applied to Medicaid match obligations arising in the subsequent  
198 fiscal year.

199         **SECTION 7.** Any person within the Department of Mental Health  
200 who must work on a statutory holiday or any holiday proclaimed by  
201 the Governor may, at the discretion of the Director of the



202 Institution and the Executive Director of the Department of Mental  
203 Health and within available personnel funds, be paid "call-back  
204 pay" in lieu of "compensatory time credit."

205         **SECTION 8.** Of the funds appropriated to the "Service  
206 Budget," funds are included for the support of community mental  
207 health services for Fiscal Year 2024.

208         Provided, however, that none of the funds appropriated for  
209 the support of community mental health services shall be made  
210 available to any Regional Mental Health/Intellectual Disability  
211 Center which does not receive from each of its participating  
212 counties a dollar amount equivalent to what the proceeds of a  
213 three-fourths (3/4) mill tax on all taxable property in the county  
214 in Fiscal Year 1982 would have been or the amount of funds  
215 contributed to the center by the county in Fiscal Year 1984,  
216 whichever shall be greater. By means of performance contracts,  
217 the Department of Mental Health shall disburse the funds  
218 appropriated in this section for services for the mentally ill,  
219 intellectually disabled and alcohol/drug abusers. The State Board  
220 of Mental Health and the Department of Mental Health shall be  
221 responsible for selecting the types of services which shall be  
222 provided with the funds appropriated in this section, for  
223 developing and monitoring performance contracts and for holding  
224 contractors accountable for utilization of funds.

225         **SECTION 9.** Ellisville State School is authorized to draw up  
226 to Four Hundred Fifty Thousand Dollars (\$450,000.00) from interest  
227 earned on funds invested in Ellisville State School Client's Trust

228 Fund for the purpose of supplementing the cost related to  
229 supplies, property, and equipment in direct care.

230       **SECTION 10.** The Department of Mental Health and its  
231 facilities shall have the express legal authority, within funding  
232 and spending authority appropriated under the provisions of this  
233 act to purchase land for use by residential facilities operated by  
234 the department, either directly or by means of transferring funds  
235 to the Bureau of Building, Grounds and Real Property Management,  
236 and to transfer such funds to the Bureau of Building, Grounds, and  
237 Real Property Management for the purposes of constructing and  
238 equipping group homes for persons with mental illness,  
239 intellectual disability, and/or substance abuse; constructing and  
240 equipping such other buildings as may be required for treatment of  
241 persons with mental illness, intellectual disability, and/or  
242 substance abuse; repair and renovate existing buildings; and to  
243 construct, repair and/or renovate employee housing. Any  
244 intermediate care facilities for individuals with intellectual  
245 disabilities (ICF/IID) constructed with funds authorized in this  
246 section shall be authorized to participate in Medicaid funding  
247 available for such services.

248       **SECTION 11.** It is the intention of the Legislature that the  
249 Department of Mental Health shall maintain complete accounting and  
250 personnel records related to the expenditure of all funds  
251 appropriated under this act and that such records shall be in the  
252 same format and level of detail as maintained for Fiscal Year  
253 2023. It is further the intention of the Legislature that the

254 agency's budget request for Fiscal Year 2025 shall be submitted to  
255 the Joint Legislative Budget Committee in a format and level of  
256 detail comparable to the format and level of detail provided  
257 during the Fiscal Year 2024 budget request process.

258       **SECTION 12.** It is the intention of the Legislature that none  
259 of the funds provided herein shall be used to pay certain  
260 utilities for state-furnished housing for any employees. Such  
261 utilities shall include electricity, natural gas, butane, propane,  
262 cable and phone services. Where actual cost cannot be determined,  
263 the agency shall be required to provide meters to be in compliance  
264 with legislative intent. Such state-furnished housing shall  
265 include single-family and multifamily residences but shall not  
266 include any dormitory residences. Allowances for such utilities  
267 shall be prohibited.

268       **SECTION 13.** It is the intention of the Legislature that the  
269 Executive Director of the Department of Mental Health shall have  
270 authority to transfer cash from one special fund treasury fund to  
271 another special fund treasury fund under the control of the  
272 Department of Mental Health. The purpose of this authority is to  
273 more efficiently use available cash reserves. It is further the  
274 intention of the Legislature that the Executive Director of the  
275 Department of Mental Health shall submit written justification for  
276 the transfer to the Legislative Budget Office and the Department  
277 of Finance and Administration. None of the funds transferred with  
278 this section may be transferred to the Central Office for Personal  
279 Services.

280           **SECTION 14.** Of the funds appropriated under the provisions  
281 of this act, Twenty-three Million Three Hundred Twenty-nine  
282 Thousand Dollars (\$23,329,000.00) is provided to the Department of  
283 Mental Health to expand those community-based services that will  
284 improve the State of Mississippi's compliance with the Olmstead  
285 decision of the United States Supreme Court. Further, it is the  
286 intention of the Legislature that the Department of Mental Health  
287 shall have the authority to transfer such sums from this source as  
288 are necessary to implement or improve those community services  
289 that are more appropriately addressed by the Mississippi  
290 Department of Education and/or the Mississippi Department of  
291 Rehabilitation Services to those agencies for that purpose.  
292 Further, it is the intention of the Legislature that any sums  
293 received from this source that are not expended during the fiscal  
294 year ending June 30, 2023, by the Mississippi Department of Mental  
295 Health shall be reappropriated for the same purpose during the  
296 fiscal year ending June 30, 2024. Further, it is the intention of  
297 the Legislature that the Department of Mental Health shall account  
298 for the expenditure of these funds in sufficient detail to clearly  
299 show the purposes for which such funds were expended. The  
300 Executive Director of the Department of Mental Health shall report  
301 any such reappropriation to the Legislative Budget Office no later  
302 than fifteen (15) days after the effective date of the  
303 reappropriation.

304           **SECTION 15.** Of the funds appropriated in this act, the  
305 Department of Mental Health, with approval by the board, may

306 contract with a Community Mental Health Center, or suitable  
307 entities, for the purpose of operating the Crisis Intervention  
308 Center at Grenada.

309 Of the funds appropriated in this act, the Department of  
310 Mental Health, with approval by the board, may contract with a  
311 community health center to allow Region 14 to be served at the  
312 Crisis Stabilization Unit at Gulfport.

313 The Department of Mental Health, with approval by the board,  
314 may also contract with suitable entities for the purpose of  
315 operating the crisis intervention centers in Batesville,  
316 Brookhaven, Cleveland, Corinth, Laurel and Newton. The department  
317 shall provide quarterly progress reports on the operation of the  
318 crisis intervention centers to the Chairmen of the Senate and  
319 House Public Health and Appropriations Committees.

320 **SECTION 16.** It is the intention of the Legislature that  
321 whenever two (2) or more bids are received by this agency for the  
322 purchase of commodities or equipment, and whenever all things  
323 stated in such received bids are equal with respect to price,  
324 quality and service, the Mississippi Industries for the Blind  
325 shall be given preference. A similar preference shall be given to  
326 the Mississippi Industries for the Blind whenever purchases are  
327 made without competitive bids.

328 **SECTION 17.** The Department of Finance and Administration  
329 (DFA) shall transfer funds back to the Department of Mental  
330 Health, upon the request of the Department of Mental Health, where  
331 the funds received by DFA from the Department of Mental Health

332 were special funds (neither general funds or bond funds) and where  
333 those funds are not required for the payment of costs already  
334 incurred on a building or repair project. For the purposes of  
335 this section, the term "special funds" includes any state source  
336 special funds, including, but not limited to, funds from the  
337 Health Care Expendable Fund. The duty of DFA to transfer funds  
338 back to the Department of Mental Health under this section applies  
339 to any funds described in this section that were transferred to  
340 DFA, regardless of the year that the transfer was made by the  
341 Department of Mental Health.

342         **SECTION 18.** It is the intention of the Legislature that the  
343 Department of Mental Health may provide, upon the availability of  
344 funds, Five Hundred Thousand Dollars (\$500,000.00) to the Hope  
345 Village for Children Program.

346         **SECTION 19.** None of the funds provided in Section 1, 2, or 3  
347 of this act shall be used to pay Medicaid match for the thirteen  
348 (13) Community Mental Health Centers.

349         **SECTION 20.** Of the funds appropriated under the provisions  
350 of this act, an amount not to exceed Two Hundred Fifty Thousand  
351 Dollars (\$250,000.00) is provided for community-based mental  
352 health services for juveniles in detention.

353         **SECTION 21.** Of the funds appropriated in Section 1, it is  
354 the intention of the Legislature that Three Million Nine Hundred  
355 Ten Thousand Seven Hundred Two Dollars (\$3,910,702.00) shall be  
356 allocated to the Crisis Intervention Mental Health Fund supported  
357 by General Fund court assessments.

358           **SECTION 22.** Of the funds appropriated in this act, the  
359 Department of Mental Health shall fund ten (10) Programs of  
360 Assertive Community Treatment (PACT) Teams and provide supportive  
361 employment for individuals with intellectual and developmental  
362 disabilities.

363           **SECTION 23.** Notwithstanding any other provision, the  
364 Department of Mental Health shall have the authority to escalate  
365 its headcount for any additional operational needs related to  
366 Coronavirus State Fiscal Recovery Funds upon approval of the  
367 Department of Finance and Administration and the State Personnel  
368 Board.

369           **SECTION 24.** Of the funds appropriated in Sections 1 and 2 of  
370 this act, it is the intention of the Legislature that continued  
371 funding at or above the Fiscal Year 2023 appropriated amount shall  
372 be allocated to the ID/DD Home and Community Based Waiver slots.

373           **SECTION 25.** It is the intention of the Legislature that the  
374 Department of Mental Health shall provide a report on the pilot  
375 program created to provide mental health services to former  
376 inmates of the Department of Corrections who are no longer  
377 incarcerated within a correctional institution of the Department  
378 of Corrections. This report shall be provided on December 15th of  
379 the current fiscal year to the Chairmen of the Senate and House  
380 Public Health and Appropriations Committees.

381           **SECTION 26.** With the funds appropriated herein, the  
382 Department of Mental Health is authorized to make payment for  
383 expenses incurred during Fiscal Year 2021 as follows:

386       **SECTION 27.** The money herein appropriated shall be paid by  
387 the State Treasurer out of any money in the State Treasury to the  
388 credit of the proper fund or funds as set forth in this act, upon  
389 warrants issued by the State Fiscal Officer; and the State Fiscal  
390 Officer shall issue his warrants upon requisitions signed by the  
391 proper person, officer or officers in the manner provided by law.

392       **SECTION 28.** This act shall take effect and be in force from  
393 and after July 1, 2023, and shall stand repealed from and after  
394 June 29, 2023.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**

1       AN ACT MAKING AN APPROPRIATION TO DEFRAY THE EXPENSES OF THE  
2 DEPARTMENT OF MENTAL HEALTH FOR FISCAL YEAR 2024.
