- 1 **AMEND** after line 97 by adding the following language:
- 2 **SECTION 3.** The Mississippi Department of Public Safety
- 3 Headquarters' Office, to be constructed and located in Pearl,
- 4 Rankin County, Mississippi, shall be named the "David R. Huggins
- 5 Headquarters of the Mississippi Department of Public Safety." The
- 6 Department of Finance and Administration shall prepare or have
- 7 prepared a distinctive plaque, to be approved by the Mississippi
- 8 Department of Public Safety, to be placed in a prominent place
- 9 within the building, that states the background, accomplishments
- 10 and service to the state by Commissioner David R. Huggins. The
- 11 Department of Finance and Administration, in conjunction with the
- 12 Mississippi Department of Public Safety, shall erect or cause to
- 13 be erected proper lettering or signage on the outdoor facade of



- 14 the building displaying the official name of the building as the
- 15 "David R. Huggins Headquarters of the Mississippi Department of
- 16 Public Safety." Any and all funds necessary to accomplish this
- 17 act will be appropriated by the Legislature for such purpose.
- 18 **SECTION 4.** The Mississippi State Crime Laboratory of the
- 19 Mississippi Department of Public Safety located in Pearl, Rankin
- 20 County, Mississippi, shall be named the "Tom Weathersby State
- 21 Crime Laboratory." The Department of Finance and Administration
- 22 shall prepare or have prepared a distinctive plaque, to be
- 23 approved by the Mississippi Department of Public Safety and the
- 24 Mississippi House of Representatives, to be placed in a prominent
- 25 place within the building, that states the background,
- 26 accomplishments and service to the state by the Honorable Tom
- 27 Weathersby. The Department of Finance and Administration, in
- 28 conjunction with the Mississippi Department of Public Safety,
- 29 shall erect or cause to be erected proper lettering or signage on
- 30 the outdoor facade of the building displaying the official name of
