39 SECTION 5. It is the intention of the Legislature that 40 whenever two (2) or more bids are received by this agency for the purchase of commodities or equipment, and whenever all things 41 42 stated in such received bids are equal with respect to price, 43 quality and service, the Mississippi Industries for the Blind 44 shall be given preference. A similar preference shall be given to the Mississippi Industries for the Blind whenever purchases are 45 46 made without competitive bids.

47 SECTION 6. It is the intention of the Legislature that the 48 Tennessee-Tombiqbee Waterway Development Authority shall maintain 49 complete accounting and personnel records related to the 50 expenditure of all funds appropriated under this act and that such 51 records shall be in the same format and level of detail as 52 maintained for Fiscal Year 2023. It is further the intention of 53 the Legislature that the agency's budget request for Fiscal Year 54 2025 shall be submitted to the Joint Legislative Budget Committee 55 in a format and level of detail comparable to the format and level 56 of detail provided during the Fiscal Year 2024 budget request 57 process.

58 SECTION 7. It is the intention of the Legislature that the 59 funds herein appropriated shall be expended in compliance with 60 Section 27-104-25, Mississippi Code of 1972, that no state agency 61 shall incur obligations or indebtedness in excess of their 62 appropriation and that the responsible officers, either personally

or upon their official bonds, shall be held responsible foractions contrary to this provision.

The money herein appropriated shall be paid by 65 SECTION 8. the State Treasurer out of any money in the State Treasury to the 66 67 credit of the proper fund or funds as set forth in this act, upon 68 warrants issued by the State Fiscal Officer; and the State Fiscal 69 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 70 71 SECTION 9. This act shall take effect and be in force from and after July 1, 2023, and shall stand repealed from and after 72 73 June 29, 2023.
