Senate Amendments to House Bill No. 1628

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5 SECTION 1. The following sum, or so much thereof as may be 6 necessary, is appropriated out of any money in the State General 7 Fund not otherwise appropriated, for the support and maintenance 8 of the State Forestry Commission for the fiscal year beginning 9 July 1, 2023, and ending June 30, 2024.....\$ 15,460,487.00. SECTION 2. The following sum, or so much thereof as may be 10 11 necessary, is appropriated out of any money in the special fund in 12 the State Treasury to the credit of the State Forestry Commission which is comprised of special source funds collected by or 13 14 otherwise available to the commission, for the support and 15 maintenance of the commission for the fiscal year beginning 16 July 1, 2023, and ending June 30, 2024.....\$ 11,776,802.00. 17 Of the funds specified in this section, Two Hundred Fifty Thousand Dollars (\$250,000.00) shall be deposited in a fund 18 19 created in the State Treasury called the "Forest Improvement 20 Revolving Fund." Money in this fund shall be used by the State 21 Forestry Commission to assist in the reforestation and growth H. B. 1628 PAGE 1

- 22 improvement of the forests, woodlands, and publicly owned lands of
- 23 the state, including sixteenth section lands, Camp Shelby,
- 24 Columbia Training School and colleges and universities.
- 25 Landowners who contract with the commission for such work shall
- 26 pay to the commission its actual cost for conducting such work.
- 27 Money received for this work by the commission shall be paid into
- 28 the State Treasury, and the State Treasurer shall deposit such
- 29 money in the "Forest Improvement Revolving Fund."
- 30 **SECTION 3.** Of the funds appropriated under the provisions of
- 31 this act, the following positions are authorized:
- 32 AUTHORIZED HEADCOUNT:
- 33 Permanent: 343
- 34 Time-Limited: 7
- With the funds herein appropriated, it shall be the agency's
- 36 responsibility to make certain that funds required for Personal
- 37 Services for Fiscal Year 2025 do not exceed Fiscal Year 2024 funds
- 38 appropriated for that purpose unless programs or positions are
- 39 added to the agency's Fiscal Year 2024 budget by the Mississippi
- 40 Legislature. The Legislature shall determine the agency's
- 41 personal services appropriation, which shall be published by the
- 42 State Personnel Board. Additionally, the State Personnel Board
- 43 shall determine and publish the projected annualized payroll costs
- 44 based on current employees. It shall be the responsibility of the
- 45 agency head to ensure that actual personnel expenditures for
- 46 Fiscal Year 2024 do not exceed the data provided by the
- 47 Legislative Budget Office. If the agency's Fiscal Year 2024

- 48 projected cost exceeds the annualized costs, no salary actions
- 49 shall be processed by the State Personnel Board with the exception
- of new hires that are determined to be essential for the agency.
- 51 Any transfers or escalations shall be made in accordance with
- 52 the terms, conditions and procedures established by law or
- 53 allowable under the terms set forth within this act. The State
- 54 Personnel Board shall not escalate positions without written
- 55 approval from the Department of Finance and Administration. The
- 56 Department of Finance and Administration shall not provide written
- 57 approval to escalate any funds for salaries and/or positions
- 58 without proof of availability of new or additional funds above the
- 59 appropriated level.
- No general funds authorized to be expended herein shall be
- 61 used to replace federal funds and/or other special funds which are
- 62 being used for salaries authorized under the provisions of this
- 63 act and which are withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 65 violation of Internal Revenue Service's Publication 15-A relating
- 66 to the reporting of income paid to contract employees, as
- 67 interpreted by the Office of the State Auditor.
- 68 Funds have been appropriated herein for the purpose of
- 69 funding Project SEC2 minimum salaries for all employees covered
- 70 under the Colonel Guy Groff/Neville Kenning Variable Compensation
- 71 Plan. It shall be the agency's responsibility to ensure that the
- 72 funds are used to increase all employees' salaries up to the
- 73 minimum level as determined by the State Personnel Board.

74	SECTION 4. It is the intention of the Legislature that the
75	State Forestry Commission shall maintain complete accounting and
76	personnel records related to the expenditure of all funds
77	appropriated under this act and that such records shall be in the
78	same format and level of detail as maintained for Fiscal Year
79	2023. It is further the intention of the Legislature that the
30	agency's budget request for Fiscal Year 2025 shall be submitted to
31	the Joint Legislative Budget Committee in a format and level of
32	detail comparable to the format and level of detail provided
3	during the Fiscal Year 2024 budget request process.
34	SECTION 5. In compliance with the "Mississippi Performance
35	Budget and Strategic Planning Act of 1994," it is the intent of
36	the Legislature that the funds provided herein shall be utilized
37	in the most efficient and effective manner possible to achieve the
38	intended mission of this agency. Based on the funding authorized,
39	this agency shall make every effort to attain the targeted

108 A reporting of the degree to which the performance targets 109 set above have been or are being achieved shall be provided in the 110 agency's budget request submitted to the Joint Legislative Budget Committee for Fiscal Year 2025.

SECTION 6. There is created in the State Treasury a fund designated as the Volunteer Fire Department Equipment Conversion Revolving Fund to be used by the State Forestry Commission to assist in the conversion of vehicles acquired by the State Forestry Commission through the Federal Excess Personal Property Program or by volunteer fire departments through other means to adapt them for use in the suppression of wildland fires. assistance shall be in the form of fabrication of water tanks or other accessories necessary for the operation of fire suppression units, installation of piping and valves, painting or other similar or associated component work necessary to place fire suppression equipment into service. It is not for general vehicle

maintenance or repair.

125 The Volunteer Fire Department Equipment Conversion Revolving Fund shall be funded by monies received from charges for work and 126 127 services performed for volunteer fire departments by the State 128 Forestry Commission. Monies collected from such charges shall be 129 deposited into the Volunteer Fire Department Equipment Conversion 130 Revolving Fund. The State Treasurer shall make disbursements 131 therefrom for payment of materials, supplies and labor upon requisition of the Forestry Commission and upon the issuance of 132 133 warrants therefor by the Department of Finance and Administration.

The amount of monies deposited into the Volunteer Fire

Department Equipment Conversion Fund through this work shall not exceed Fifty Thousand Dollars (\$50,000.00). Funds in excess of Fifty Thousand Dollars (\$50,000.00) shall be placed in the State Forestry Commission's regular appropriated special funds. Monies in this revolving fund are to be considered special funds and shall be carried forward from one fiscal year to the next.

SECTION 7. There is created in the State Treasury a fund

designated as the Camden State Forest Revolving Fund to be used by
the State Forestry Commission to direct forest management
activities on the Camden State Forest in Madison County,
Mississippi. The forest management activities will include, but
not be limited to, maintenance of property, timber sale activities
and regeneration work.

The Camden State Forest Revolving Fund shall be funded by monies received from timber sales, leases, and any other source.

Monies collected from these income sources shall be deposited into

- 151 the Camden State Forest Revolving Fund. The State Treasurer shall
- 152 make disbursements therefrom for payments of materials, supplies
- 153 and labor upon requisition of the State Forestry Commission and
- 154 upon the issuance of warrants therefor by the Department of
- 155 Finance and Administration.
- 156 It is the intention of the Legislature that any revolving
- 157 funds in excess of the budgeted amount needed for the necessary
- 158 operation and maintenance of all properties under the direct
- 159 supervision and management of the State Forestry Commission shall
- 160 remain in the Camden State Forest Revolving Fund for use in future
- 161 years.
- 162 Of the funds appropriated in Section 2, it is the
- 163 intention of the Legislature that Two Hundred Thousand Dollars
- 164 (\$200,000.00) shall be transferred to the Department of
- 165 Agriculture and Commerce for the Beaver Control or Eradication
- 166 Program during the Fiscal Year 2024.
- 167 SECTION 9. Any funds in the Salary, Wages and Fringe
- Benefits major object of expenditure may be used to purchase 168
- 169 accumulated compensatory time within the funds available.
- 170 SECTION 10. It is the intention of the Legislature that
- 171 whenever two (2) or more bids are received by this agency for the
- 172 purchase of commodities or equipment, and whenever all things
- stated in such received bids are equal with respect to price, 173
- 174 quality and service, the Mississippi Industries for the Blind
- shall be given preference. A similar preference shall be given to 175

- the Mississippi Industries for the Blind whenever purchases are made without competitive bids.
- 178 **SECTION 11.** It is the intention of the Legislature that the 179 funds herein appropriated shall be expended in compliance with
- 180 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 181 shall incur obligations or indebtedness in excess of their
- 182 appropriation and that the responsible officers, either personally
- 183 or upon their official bonds, shall be held responsible for
- 184 actions contrary to this provision.
- 185 **SECTION 12.** The money herein appropriated shall be paid by 186 the State Treasurer out of any money in the State Treasury to the
- 187 credit of the proper fund or funds as set forth in this act, upon
- 188 warrants issued by the State Fiscal Officer; and the State Fiscal
- 189 Officer shall issue his warrants upon requisitions signed by the
- 190 proper person, officer or officers, in the manner provided by law.
- 191 **SECTION 13.** This act shall take effect and be in force from
- 192 and after July 1, 2023, and shall stand repealed June 29, 2023.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:
