Senate Amendments to House Bill No. 1630

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is authorized and approved for expenditure out of any
7	funds which are received by or otherwise become available to the
8	Pat Harrison Waterway District, for the purpose of defraying the
9	expenses of the district for the fiscal year beginning
LO	July 1, 2023, and ending June 30, 2024\$ 7,662,825.00.
L1	SECTION 2. Of the funds approved for expenditure under the
L2	provisions of Section 1, the following positions are authorized:

L 6	With the funds herein appropriated, it shall be the agency's
L 7	responsibility to make certain that funds required for Personal

- 22 personal services appropriation, which shall be published by the
- 23 State Personnel Board. Additionally, the State Personnel Board
- 24 shall determine and publish the projected annualized payroll costs
- 25 based on current employees. It shall be the responsibility of the
- 26 agency head to ensure that actual personnel expenditures for
- 27 Fiscal Year 2024 do not exceed the data provided by the
- 28 Legislative Budget Office. If the agency's Fiscal Year 2024
- 29 projected cost exceeds the annualized costs, no salary actions
- 30 shall be processed by the State Personnel Board with the exception
- 31 of new hires that are determined to be essential for the agency.
- 32 Any transfers or escalations shall be made in accordance with
- 33 the terms, conditions and procedures established by law or
- 34 allowable under the terms set forth within this act. The State
- 35 Personnel Board shall not escalate positions without written
- 36 approval from the Department of Finance and Administration. The
- 37 Department of Finance and Administration shall not provide written
- 38 approval to escalate any funds for salaries and/or positions
- 39 without proof of availability of new or additional funds above the
- 40 appropriated level.
- 41 No general funds authorized to be expended herein shall be
- 42 used to replace federal funds and/or other special funds which are
- 43 being used for salaries authorized under the provisions of this
- 44 act and which are withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 46 violation of Internal Revenue Service's Publication 15-A relating

- 47 to the reporting of income paid to contract employees, as
- 48 interpreted by the Office of the State Auditor.
- Funds have been appropriated herein for the purpose of
- 50 funding Project SEC2 minimum salaries for all employees covered
- 51 under the Colonel Guy Groff/Neville Kenning Variable Compensation
- 52 Plan. It shall be the agency's responsibility to ensure that the
- 53 funds are used to increase all employees' salaries up to the
- 54 minimum level as determined by the State Personnel Board.
- 55 **SECTION 3.** It is the intention of the Legislature that the
- 56 Pat Harrison Waterway District shall maintain complete accounting
- 57 and personnel records related to the expenditure of all funds
- 58 appropriated under this act and that such records shall be in the
- 59 same format and level of detail as maintained for Fiscal Year
- 60 2023. It is further the intention of the Legislature that the
- 61 agency's budget request for Fiscal Year 2025 shall be submitted to
- 62 the Joint Legislative Budget Committee in a format and level of
- 63 detail comparable to the format and level of detail provided
- 64 during the Fiscal Year 2024 budget request process.
- 65 **SECTION 4.** It is the intention of the Legislature that
- 66 whenever two (2) or more bids are received by this agency for the
- 67 purchase of commodities or equipment, and whenever all things
- 68 stated in such received bids are equal with respect to price,
- 69 quality and service, the Mississippi Industries for the Blind
- 70 shall be given preference. A similar preference shall be given to
- 71 the Mississippi Industries for the Blind whenever purchases are
- 72 made without competitive bids.

- 73 **SECTION 5.** The funds herein approved for expenditure, except
- 74 and less an amount approved by the State Fiscal Officer which
- 75 shall be sufficient to cover disbursements for current operations,
- 76 shall be deposited at interest with any official depository of the
- 77 state at a rate of interest numerically not less than one percent
- 78 (1%) below the bank discount rate on United States Treasury bills
- 79 of comparable maturity as determined by the State Treasurer.
- 80 **SECTION 6.** It is the intention of the Legislature that the
- 81 funds herein appropriated shall be expended in compliance with
- 82 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 83 shall incur obligations or indebtedness in excess of their
- 84 appropriation and that the responsible officers, either personally
- 85 or upon their official bonds, shall be held responsible for
- 86 actions contrary to this provision.
- 87 **SECTION 7.** The money herein approved for expenditure shall
- 88 be disbursed upon bank checks signed by the proper person, officer
- 89 or officers, in the manner provided by law.
- 90 **SECTION 8.** This act shall take effect and be in force from
- 91 and after July 1, 2023, and shall stand repealed June 29, 2023.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:
