## Adopted COMMITTEE AMENDMENT NO 1 PROPOSED TO

## House Bill No. 677

## **BY: Committee**

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 11 **SECTION 1.** Section 35-3-21, Mississippi Code of 1972, is
- 12 amended as follows:
- 13 35-3-21. In order to maintain offices and pay personnel for
- 14 the purpose of assisting all residents of the State of Mississippi
- 15 who served in the military or naval forces of the United States
- 16 during any war, their relatives, beneficiaries or dependents, to
- 17 receive from the United States any and all compensation,
- 18 hospitalization, insurance or other aid or benefits to which they
- 19 may be entitled under existing or hereafter enacted laws of the
- 20 United States, the boards of supervisors in the various counties



- 21 in the state are hereby authorized and empowered, in their
- 22 discretion, to expend out of the general county fund, or special
- 23 veterans' fund herein authorized to be set up, or from both of
- 24 such funds, such monies necessary to defray the office operating
- 25 expenses and salary of the county veteran service officers.
- Two (2) or more counties may, upon resolution duly adopted by
- 27 the board of supervisors of each of such counties, agree to
- 28 establish one (1) veteran service office for all of such counties.
- 29 When two (2) or more counties enter into such an agreement, each
- 30 county shall pay such amount mutually agreed upon and duly adopted
- 31 by resolution of the respective boards of supervisors.
- 32 County veteran service officers shall be (a) honorably
- 33 discharged or honorably released veterans; (b) the surviving
- 34 spouse or child of any such \* \* \* veteran, living or deceased; or
- 35 (c) any person employed as a county veteran service officer in any
- 36 county of this state on March 30, 1990. From and after July 1,
- 37 1990, county veteran service officers shall be certified by the
- 38 Mississippi State Veterans Affairs Board which, among any other
- 39 criteria it may establish, shall require such officers to (a)
- 40 attend one (1) of the annual training programs provided for such
- 41 officers by the Mississippi State Veterans Affairs Board, (b)
- 42 successfully complete a written examination each year on the
- 43 duties and responsibilities of and assistance available to such
- 44 officers and veterans, (c) have certification and be accredited
- 45 according to 38 CFR Section 14.629 administered by the Mississippi

- 46 State Veterans Affairs Board, and (d) follow the rules and
- 47 regulations promulgated by the Mississippi State Veterans Affairs
- 48 Board. County veteran service officers who annually receive and
- 49 complete such instruction in a manner satisfactory to the Veterans
- 50 Affairs Board and in accordance with this section shall be
- 51 certified by the board. No county veteran service officer shall
- 52 be entitled to receive any compensation for his services, to which
- 53 he is otherwise entitled by law, unless he is annually certified
- 54 by the board. Persons who cannot meet the accreditation standards
- of hours worked for county veteran service officers may be
- 56 certified by the Mississippi State Veterans Affairs Board as
- 57 Veterans Resource Advisors and be entitled to receive any
- 58 compensation for his services as authorized by law.
- 59 County veteran service officers may be employed, in the
- 60 discretion of the boards of supervisors, either full time or part
- 61 time.
- 62 County veteran service officers shall be authorized and
- 63 empowered to act for a veteran under a written power of attorney
- 64 authorized by the veteran for the purpose of assisting with
- 65 claims, benefits, and appeals in an administrative hearing before
- 66 the United States Department of Veterans Affairs and any of its
- 67 boards or departments, and shall be immune from legal action only
- 68 for such actions except in cases of abuse, fraud or breach of
- 69 fiduciary duty.



- 70 The boards of supervisors of the various counties are 71 authorized and directed to provide necessary office space and 72 communications connectivity for county veteran service officers.
- 73 The boards of supervisors of the various counties are further 74 authorized and empowered to pay all necessary and actual expenses 75 of county veteran service officers who attend a school of 76 instruction within the State of Mississippi for such county 77 veteran service officers.
- 78 It shall also be the duty of the boards of supervisors to aid 79 the United States to defeat all unjust claims for aid or benefit 80 therefrom.
- Such expenditures may be made by the several counties acting 81 82 alone, or in cooperation with other counties, and in cooperation with any federal or state agency carrying out such purposes. 83
  - In the event that the general revenues of the county levied under and within the limits of existing taxing statutes are not sufficient to pay the expenses authorized herein, the board of supervisors may, in its discretion, levy an additional tax not to exceed one (1) mill on all taxable property in the county to defray such expenses or any part thereof. Any tax levy made under authority of this chapter shall not be considered in refunding homestead exemption losses under Title 27, Chapter 33, Mississippi Code of 1972.
- 93 SECTION 2. This act shall take effect and be in force from and after July 1, 2023. 94

## Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO AMEND SECTION 35-3-21, MISSISSIPPI CODE OF 1972, TO AUTHORIZE COUNTY VETERAN SERVICE OFFICERS TO ACT FOR A VETERAN FOR 3 CERTAIN SERVICES UNDER A WRITTEN POWER OF ATTORNEY AUTHORIZED BY THE VETERAN FOR THE PURPOSE OF ASSISTING WITH CLAIMS, BENEFITS, 5 AND APPEALS IN AN ADMINISTRATIVE HEARING BEFORE THE UNITED STATES DEPARTMENT OF VETERANS AFFAIRS; TO PROVIDE COUNTY VETERAN SERVICE 7 OFFICERS WITH LEGAL IMMUNITY FOR SUCH ACTIONS EXCEPT IN CASES OF 8 ABUSE, FRAUD OR BREACH OF FIDUCIARY DUTY; TO REVISE CERTAIN 9 QUALIFICATIONS FOR COUNTY VETERAN SERVICE OFFICERS; AND FOR 10 RELATED PURPOSES.
