COMMITTEE AMENDMENT NO 1 PROPOSED TO**

**Amend by striking all after the enacting clause and inserting
in lieu thereof the following:**

7 **SECTION 1.** The following sum, or so much thereof as may be
8 necessary, is reappropriated out of any money in the State
9 Treasury to the credit of Fund No. 3393100000 to the Department of
10 Finance and Administration, acting through the Bureau of Building,
11 Grounds and Real Property Management, for the purpose of
12 reauthorizing the expenditure of funds previously appropriated for
13 construction and/or repair and renovation projects at various
14 state agencies and institutions, as authorized in HB No. 1603,
15 2022 Regular Session, for the fiscal year beginning July 1, 2023,
16 and ending June 30, 2024.....\$ 90,392,052.00.

296 **SECTION 16.** The Bureau of Building, Grounds and Real
297 Property Management of the Office of General Services is expressly
298 authorized and empowered to receive, budget and expend any state,
299 local or other source funds designated for supplemental funding of
300 construction and/or repair and renovation projects.

301 **SECTION 17.** The money herein appropriated shall be paid by
302 the State Treasurer out of any money in the State Treasury to the
303 credit of the proper fund or funds as set forth in this act, upon
304 warrants issued by the State Fiscal Officer; and the State Fiscal
305 Officer shall issue his warrants upon requisitions signed by the
306 proper person, officer or officers, in the manner provided by law.

307 **SECTION 18.** This act shall take effect and be in force from
308 and after July 1, 2023, and shall stand repealed June 29, 2023.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE

5 STATE AGENCIES AND INSTITUTIONS, FOR FISCAL YEAR 2024.
