HOUSE BILL NO. 365

AN ACT TO AMEND SECTION 3-3-7, MISSISSIPPI CODE OF 1972, TO DESIGNATE THE MONTH OF MARCH EACH YEAR AS "MISSISSIPPI MUSICIANS MONTH"; AND FOR RELATED PURPOSES.

WHEREAS, Mississippi has become recognized nationally as the

5 "Birthplace of America's Music", and the State of Mississippi has

6 had a global impact on music, both as an art form, and within the

7 music industry; and

8 WHEREAS, Mississippi's music, as well as many of its musical

9 performers, composers and songwriters, are known worldwide, and

10 there is no mainstream commercial musical genre that has not been

11 influenced by Mississippi, particularly in the genres of Blues,

12 Rock & Roll, Country, Rhythm & Blues, Gospel and Jazz; and

13 WHEREAS, Mississippi has produced more Grammy Award winners

14 per capita than any other state, and there are numerous

15 Mississippi musical performers, composers, and songwriters that

16 have had a global impact, including: Robert Johnson, Jimmie

17 Rodgers, B.B. King, Muddy Waters, Elvis Presley, Charley Pride,

18 Leontyne Price, Marty Stuart, Faith Hill, Craig Wiseman and many

- 19 others, and because of their musical work and contributions, many
- 20 Mississippi musicians' names have become household names
- 21 throughout the nation and the world; and
- 22 WHEREAS, by designating the month of March each year as
- 23 Mississippi Musicians' Month, everyone will have an annual
- 24 opportunity to recognize and celebrate Mississippi's numerous
- 25 outstanding past and present musical artists; NOW, THEREFORE,
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. Section 3-3-7, Mississippi Code of 1972, is
- 28 amended as follows:
- 29 3-3-7. (1) Except as otherwise provided in subsection (2)
- 30 of this section, the following are declared to be legal holidays,
- 31 viz: the first day of January (New Year's Day); the third Monday
- 32 of January (Robert E. Lee's birthday and Dr. Martin Luther King,
- 33 Jr.'s birthday); the third Monday of February (Washington's
- 34 birthday); the last Monday of April (Confederate Memorial Day);
- 35 the last Monday of May (National Memorial Day and Jefferson Davis'
- 36 birthday); the fourth day of July (Independence Day); the first
- 37 Monday of September (Labor Day); the eleventh day of November
- 38 (Armistice or Veterans' Day); the day fixed by proclamation by the
- 39 Governor of Mississippi as a day of Thanksqiving, which shall be
- 40 fixed to correspond to the date proclaimed by the President of the
- 41 United States (Thanksgiving Day); and the twenty-fifth day of
- 42 December (Christmas Day). In the event any holiday hereinbefore

- 43 declared legal shall fall on Sunday, then the next following day
- 44 shall be a legal holiday.
- In lieu of any one (1) legal holiday provided for in 45
- subsection (1) of this section, with the exception of the third 46
- 47 Monday in January (Robert E. Lee's and Martin Luther King, Jr.'s
- 48 birthday) and the eleventh day of November (Armistice or Veterans'
- Day), the governing authorities of any municipality or county may 49
- 50 declare, by order spread upon its minutes, Mardi Gras Day or any
- 51 one (1) other day during the year, to be a legal holiday.
- 52 August 16 is declared to be Elvis Aaron Presley Day in
- 53 recognition and appreciation of Elvis Aaron Presley's many
- 54 contributions, international recognition and the rich legacy left
- 55 to us by Elvis Aaron Presley. This day shall be a day of
- 56 recognition and observation and shall not be recognized as a legal
- 57 holiday.
- 58 May 8 is declared to be Hernando de Soto Day in
- 59 recognition, observation and commemoration of Hernando de Soto,
- 60 who led the first and most imposing expedition ever made by
- 61 Europeans into the wilds of North America and the State of
- 62 Mississippi, and in further recognition of the Spanish explorer's
- 63 187-day journey from the Tombigbee River basin on our state's
- 64 eastern boundary, westward to the place of discovery of the
- Mississippi River on May 8, 1541. This day shall be a day of 65
- 66 commemoration, recognition and observation of Hernando de Soto and

- 69 (5) Armistice Day (Veterans' Day) shall be observed by
- 70 appropriate exercises in all the public schools in the State of
- 71 Mississippi. The superintendent of schools of each public school
- 72 district is authorized to provide for the appearance of uniformed
- 73 military personnel, uniformed veterans or the families of fallen
- 74 military personnel/veterans at such public school exercises in
- 75 honor of Armistice (Veterans') Day. The superintendent of schools
- 76 is also authorized to permit the school band and its director(s)
- 77 at any public school in the district to perform at Armistice
- 78 (Veterans') Day exercises in the school district upon the request
- 79 of public officials or veterans associations without loss of any
- 80 program credit by participating students and without loss of leave
- 81 by participating school personnel.
- 82 (6) The month of March is declared to be "Mississippi
- 83 Musicians Month" to recognize and celebrate the state's rich
- 84 musical heritage and to encourage the world to join Mississippi in
- 85 honoring our musicians and their contributions.
- 86 **SECTION 2.** This act shall take effect and be in force from
- 87 and after its passage.
